## **Note 1. Plan Description**

The AccuTemp/Challenge Tool & Manufacturing 401(k) Retirement Plan is a defined contribution plan covering employees of AccuTemp Products, Inc. and Challenge Tool & Manufacturing, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information. Prior to January 1, 2024, the Plan was known as the AccuTemp Products, Inc. 401(k) Plan. The Plan was amended on January 1, 2024 to add Challenge Tool & Manufacturing, Inc. as a participating employer.

### Merger

Effective January 1, 2024, the Challenge Tool & Manufacturing, Inc. 401(k) Retirement Plan was merged into the Plan. The transferred net assets have been recognized in the accounts of the Plan as of January 1, 2024, at their balances as previously carried in the accounts of the Challenge Tool & Manufacturing, Inc. 401(k) Retirement Plan. The changes in net assets, subsequent to the merger on January 1, 2024, of the Challenge Tool & Manufacturing, Inc. 401(k) Retirement Plan, are included in the accompanying statement of changes in net assets available for benefits. A summary of the transferred net assets are as follows:

### Eligibility

Each employee, except those under the age of 18, becomes eligible to participate in the Plan on the first day of the next month after meeting the 90 days of service requirement.

### Contributions

Participants may elect to contribute between 1% and 100% of eligible compensation up to the statutory dollar limit established by the Internal Revenue Code. Participants may elect to make pre-tax or Roth deferral contributions, or both. The Company match contribution is discretionary. For the year ended 2024, the discretionary match was 50% up to 6% of the participant's compensation. The discretionary contribution in 2024 was \$190,800.

### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's match and profit sharing contributions and an allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants have the option of investing in a variety of mutual funds and a guaranteed investment contract offered through Empower Trust Company, LLC. All amounts in participant accounts are participant-directed; however, if a participant does not choose an investment allocation, the Plan provides for a default investment option.

Notes Receivable from Participants

The Plan allows participants to borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have one loan outstanding at a time. The duration of any loan shall be no more than five years unless such loan is for the purchase of a participant's primary residence, in which case the repayment period may not exceed ten years. Repayments are made through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with prevailing rates as determined by the Plan Administrator at time of origination (5.25% through 10.50% at December 31, 2024). Loans outstanding at December 31, 2024, mature through September 2029.

Vesting

Participants are immediately vested in their elective contributions and income or loss thereon. Vesting in the Company's contributions is based on years of service. A participant becomes partially vested after one year of service. Vesting percentages increase each year thereafter with 100% vesting after four years of service. Participants employed by AccuTemp Products, Inc. prior to January 1, 2023 are fully vested in all Company contributions.

Benefit Payments

Normal retirement age under the Plan is 65 years, with no option for early retirement. Participants who are still active may also receive lump sum benefit payments upon attaining age 59 1/2 or for hardships. Minimum distributions are required once the participant reaches age 72. On termination of service, retirement, or death a participant has the following options regarding his or her value of their vested interest: a) receive a lump-sum payment, b) receive payments in equal installments, c) rollover the balance into another qualified plan, or d) remain in the Plan as an inactive participant.

Forfeitures

If a participant terminates employment before being fully vested, a portion of the Company contributions will be forfeited. Forfeitures are used to pay Plan expenses or reduce Company contributions. At December 31, 2024 and 2023, forfeitures of approximately \$14,000 and \$1,500, respectively were available to pay Plan expenses. During the Plan year ended December 31, 2024, approximately \$8,700 forfeitures were used.

Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**Note 2. Significant Accounting Policies**

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Payment of benefits to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The plan administrator has evaluated events and transactions for possible recognition or disclosure through August 25, 2025, the date the financial statements were available to be issued.

**Note 3. Information Certified by Empower Trust Company, LLC**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Empower Trust Company, LLC, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments as shown in the accompanying statements of net assets available for benefits.
- b. Net investment earnings as shown in the accompanying statement of changes in net assets available for benefits, including interest income and dividends and net realized and unrealized appreciation in fair value of investments.
- c. Schedule of Assets (Held at End of Year).

**Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

**Note 4. Fair Value Measurements (Continued)**

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values ("NAV") of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 5. Investment Contract with Insurance Company**

The Plan holds a traditional investment contract and the Key Guaranteed Portfolio, with Empower Trust Company, LLC. The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: 1) temporary absence; 2) change in position or other occurrence qualifying as a temporary break in service under the Plan; 3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; 4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business; 5) removal from the Plan of one or more groups or classifications of participants; 6) partial or complete Plan termination; or 7) Plan disqualification. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

## **Note 6. Transactions with Parties-In-Interest**

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for accounting and other services are rendered by parties-in-interest and are paid by the Company. The Plan invests in pooled separate accounts and a guaranteed investment account affiliated with Empower Trust Company, LLC. Investment related expenses are included in net appreciation in investments.

## **Note 7. Income Tax Status**

The Plan obtained its latest determination letter on June 30, 2020, stating that the Plan is a qualified plan under Section 401 of the Internal Revenue Code. The Plan has been amended since receiving the letter. The Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan sponsor and plan administrator are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 8. Risks and Uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
