Note 1. Description the Plan

The following description of the Automated Precision, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of the Company who have three months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Participants may contribute a percentage of eligible compensation on a pre-tax or after-tax basis or a combination thereof, up to the Internal Revenue Code (IRC) maximum allowable limit for 2024 of \$23,000 if under age 50 and \$30,500 if age 50 or over. Under the Roth 401(k) contribution option, a participant can make after-tax contributions; distributions from a participant's Roth 401(k) contributions and earnings thereon at retirement are generally tax-free. Participant contributions may be subject to additional limitations imposed by the IRC as detailed in the Plan.

The Employer makes a safe-harbor matching contribution of 100% of the participants' contributions up to 3% and an additional 50% of the participants' contributions between 3% and 5% on a pre-tax basis under the Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Employer may make non-elective contributions as determined each year by the Company. Non-elective contributions are allocated to participants' accounts based upon the nature of each eligible participant's compensation to the total compensation of all eligible participants. There were no non-elective contributions made during the 2024 plan year.

Participant Accounts. Each participant's account is credited with the participant's contribution, the Company's matching contribution and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested in their contributions plus actual earnings thereon. Participants are 100% vested in the Company's contribution portion of their accounts. Participants become fully vested in any non-elective contributions after 2 years of service, as defined in the Plan agreement.

Notes Receivable from Participants. Loans from participants accounts are not permitted by the Plan.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, payments over a period certain, or purchase of an annuity. For termination of service for other reasons, distribution of funds shall be made on the occurrence of an event that would result in the distribution had the terminated participant remained in the employ of the Company, or the participant may receive the value of the vested interest in his or her account as a lump-

sum distribution.

Hardship distributions to employees are permitted from the participant's vested account balance if certain conditions are met. After withdrawal, participants may not make savings or other contributions to the Plan for at least six months after receipt of the hardship distribution.

Forfeitures. Forfeitures are used to pay administrative expenses and to reduce future employer contributions. In 2024, there were no forfeitures.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting. The accompanying financial statements have been prepared on an accrual basis of accounting and present the net assets available for benefits and changes in those net assets.

Use of Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid.

Administrative Expenses. Certain administrative expenses of the Plan are paid by the Sponsor. Other administrative fees and expenses of the Plan are paid by the participants.

Date of Management's Review of Subsequent Events. The Plan evaluated its December 31, 2024 financial statements for subsequent events through August 6, 2025, the date these financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

Note 3. Information Prepared and Certified by the Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and

Note 4. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 and Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds are held by the Plan are considered to be actively traded. The fair value of the money market funds are valued at their net asset value and must transact at that price.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers into or out of levels 1, 2 or 3.

Note 5. Party-in-interest Transactions

Certain Plan investments are Vanguard mutual funds that are managed by Ascensus Trust Company, the trustee of the Plan. These transactions related to such investments qualify as party-in-interest transactions.

Note 6. Tax Status

The Company adopted the Non-standardized Pre-approved Profit Sharing Plan with CODA of Ascensus, Inc. in compliance with legislative and regulatory changes. The Internal Revenue Service has determined and informed Ascensus, Inc., by a letter dated June 30, 2020, that the Non-standardized Pre-approved Profit Sharing Plan with CODA are designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
