We have performed audits of the financial statements of Utilities International, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Utilities International, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **NOTES TO FINANCIAL STATEMENTS**

### **1. Description of the Plan**

The following brief description of Utilities International, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the published summary Plan booklet for a more complete description of the Plan.

#### **General:**

The Plan became effective on January 1, 1995. The Plan is a defined-contribution plan covering all employees of Utilities International, Inc. (the Company). The Company (the Plan Administrator) controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan participation:**

Any employee of the Company, who is at least 21 years old, shall become eligible to participate in the Plan after one month of employment. Non-resident aliens and residents of Puerto Rico are not eligible to participate in the Plan. Entry dates for employees are on the first day of each month.

#### **Employee contributions:**

Employees can contribute funds to the Plan equal to 100% of compensation as defined by the Plan. Contributions are limited in accordance with Internal Revenue Service regulations.

#### **Employer contributions:**

The Plan permits discretionary matching contribution by the Company. The employer discretionary matching contributions are made in an amount equal to \$1.00 for every \$1.00 contributed by the participant, up to \$1,500 contributed by the participant. The Company then matches an amount equal to \$0.50 for every \$1.00 contributed by the participant, up to the next \$1,500 contributed by the participant. The maximum employer discretionary contribution per participant per year is \$3,000. Effective January 1, 2024, the Plan was amended updating the employer discretionary matching contributions in an amount equal to \$1.00 for every \$1.00 contributed by the participant, up to \$5,000 contributed by the participant. The maximum employer discretionary contribution per participant per year is \$5,000.

**1. Description of the Plan (continued)**

**Participant accounts:**

The Plan maintains a separate account for each participant. Participants self-direct their contributions and their share of the Company's contribution among the investment options offered by the Plan. Employees can manage their individual accounts online. Earnings and net appreciation or depreciation of the Plan assets are allocated to each participant's account based on actual earnings of participant-directed investments.

**Vesting:**

Participants are 100% vested in their employee deferral contributions at all times.

Vesting in the Company's discretionary matching contributions and earnings thereon is based on participants' years of credited service. The vested portion is determined in accordance with the following schedule:

Years of service	Vested portion
Less than 1	0%
At least 1 but less than 2	20%
At least 2 but less than 3	40%
At least 3 but less than 4	60%
At least 4 but less than 5	80%
5 or more	100%

**Participant loans:**

Participants may borrow from their fund account up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from 1 to 5 years or up to 15 years for the purpose of purchasing a primary residence. The loans are secured by the balances in the participants' accounts and bear interest at Prime plus 2.00% at the time of issuance. Principal and interest are paid ratably through payroll deductions.

### **1. Description of the Plan (continued)**

#### **Payment of benefits:**

A participant becomes entitled to benefits under the Plan upon reaching normal retirement age (as defined by the Plan), death, permanent disability or resignation from the Company. Upon death, disability or retirement at age 65, a participant's account balance becomes fully vested. Upon resignation, participants are entitled to receive the vested portion of their account balance. A participant whose vested account balance exceeds \$5,000 may elect to postpone distribution of his account until his statutorily required beginning date.

The Plan also allows in-service withdrawals from all vested account balances upon attaining age 59 1/2. Additionally, the Plan allows in-service withdrawals due to financial hardship.

#### **Forfeitures:**

Upon termination of employment, any amounts not vested are forfeited. Forfeitures and earnings thereon may be used to reduce future Company discretionary matching contributions or to pay administrative expenses of the Plan. Forfeiture account balances totaled \$63,021 and \$39,846 at December 31, 2024 and 2023, respectively.

### **2. Summary of significant accounting policies**

#### **Basis of accounting:**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

#### **Investment valuation and income recognition:**

The Plan's investments are stated at fair value except for the fully benefit-responsive group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**2. Summary of significant accounting policies (continued)**

**Contributions:**

Participants' contributions are recognized by the Plan when withheld from the participants' paychecks by the Company.

**Payment of benefits:**

Benefits are recorded when paid.

**Notes receivable from participants:**

As described in Note 1, the Plan allows participants to borrow against their vested account balance and the loans are secured by the participants' account balances. Participant loans are valued at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are repaid ratably through regular payroll deductions and loan defaults are treated as distributions.

**Administrative expenses:**

All administrative costs, charges and expenses are paid by the Plan to the extent not paid by the Company.

**Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits as of the end of the Plan year and the reported amounts of changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates.

**Subsequent events:**

The Plan Administrator has reviewed and evaluated subsequent events through August 15, 2025, the date the financial statements were available to be issued.

**3. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**4. Investments (information prepared and certified by Empower Annuity Insurance Company of America (the Insurance Company))**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in these financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified to as complete and accurate by the Insurance Company.

Interest on notes receivable from participants was \$9,535 for the year ended December 31, 2024, as certified by the Insurance Company. The interest rate on notes receivable from participants ranged from 5.25% to 10.50% as of December 31, 2024 and 2023.

Furthermore, although the Plan Administrator believes that the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Investment contract with the Insurance Company**

The Plan has a fully benefit-responsive group annuity contract with the Insurance Company, which is called the Great West general account. The Insurance Company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the Insurance Company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy and (6) early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

**6. Investment contract with the Insurance Company (continued)**

The Insurance Company may not terminate the contract at any amount less than the contract value. The Insurance Company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the Insurance Company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year. The actual average yield earned by the Plan for the group annuity contract is derived by averaging the Plan's quarterly interest rates.

**7. Party-in-interest transactions**

Certain Plan investments are shares of an insurance company general account managed by an affiliated company of the Insurance Company. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Insurance Company for investment management and recordkeeping services amounted to \$65,482 for the year ended December 31, 2024. The Plan also contracts with an investment advisor. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for these investment services totaled \$54,098 for the year ended December 31, 2024.

**8. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**9. Tax status**

The Plan, a mass-submitter prototype plan, obtained its latest determination letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the requirements of the Code.
