**SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We performed audits of the accompanying financial statements of the IntelliGenesis 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the IntelliGenesis 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document or the Summary Plan Description for more complete information.

**GENERAL**

The Plan is a defined contribution plan covering all employees of IntelliGenesis LLC (Company) who are at least 21 years old. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan sponsor's board of directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Participants may contribute up to the maximum amount of pretax and/or after-tax annual compensation, as defined by the Plan, not to exceed limitations set by the Internal Revenue Code (IRC). Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes a matching contribution of 100% of a participant's deferrals up to 6% of the contributing participant's eligible compensation. The Plan is designed to qualify as a safe harbor 401(k) plan. As such, the Company also makes a safe harbor matching contribution of 100% of a participant's deferrals up to 4% of the contributing participant's eligible compensation. The Company may make an additional non-elective discretionary contribution to the Plan. There were no non-elective discretionary contributions for the years ended December 31, 2024 and 2023.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any Company contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**VESTING**

Participants are immediately vested in their safe harbor matching contributions, elected deferral contributions and rollover contributions, plus actual earnings thereon. Participants are vested in the Company's matching contributions plus actual earnings based on a vesting schedule, beginning at 50% for one year of service and increasing by 50% increments until a participant is fully vested at two years.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, participants may direct all contributions to various investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

**PAYMENT OF BENEFITS**

Upon retirement, death, disability, or termination of employment, a participant or beneficiary may elect to receive the value of the participant's account in a lump sum. Hardship distributions are permitted if certain conditions are met. In-service withdrawals are also permitted for participants who turn 59½ years old. If the total value of an inactive participant's vested account balance is \$1,000 or less, the participant's entire vested benefit will be distributed in a lump sum. If the total value of an inactive participant's account is \$1,001 to \$5,000, the Plan Administrator may require the balance to be rolled over to an individual retirement plan designated by the Plan Administrator.

**FORFEITED ACCOUNTS**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,962 and \$55,470, respectively. These accounts will be used to reduce future Company contributions in accordance with the Plan document. During the year ended December 31, 2024, Company contributions were reduced by approximately \$55,000 from forfeited non-vested accounts.

**PLAN TERMINATION**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

**ADMINISTRATIVE EXPENSES**

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in the net appreciation in investments.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

**ACCOUNTING STANDARDS CODIFICATION**

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

**BASIS OF ACCOUNTING**

The accompanying financial statements are presented on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**INVESTMENT VALUATION**

Investments are reported at fair value except for fully benefit responsive investment contracts, which are reported at contract value. See Note 3 for a discussion of fair value measurements.

**RISK AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through August 8, 2025, the date the financial statements were available to be issued.

**NOTE 3 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions under the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy, which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Codification are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation

techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INVESTMENT CONTRACTS WITH INSURANCE COMPANIES**

The Plan has investments in the Empower Select Guaranteed Fund, which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by the Trustee, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan’s ability to transact at contract value. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: (a) an uncured breach of the Plan’s investment guidelines, (b) a material amendment to the contract without the issuer’s consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. The Plan paid approximately \$130,000 to parties in interest for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

**NOTE 7** TAX STATUS

The Plan adopted a volume submitter plan, which obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with Section 401 of the IRC. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.
