## **1. Description of Plan**

The following description of the Irving 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### **General**

The Plan is a defined contribution plan, sponsored and administered by Irving Forest Products, Inc. and certain participating employers under common control, as listed in the Plan’s provisions (collectively, the Employer or the Plan Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### **Participation**

Eligible employees may become participants in the Plan if they are US residents, at least 21 years of age, have completed three months of services and worked 250 hours during these three months.

Once eligible, an employee must complete 1,000 hours of service during the Plan year and be employed at year-end to receive an allocation of any profit-sharing contribution for the year. Participants direct the investment of all contributions into various investment options offered by the Plan.

### **Employee contributions**

Eligible employees may elect to contribute up to 100% of their pre-tax compensation, as defined in the Plan document, as allowable under Section 401(k), 402(g) and 414(v) of the Internal Revenue Code (“IRC”). The Plan participant has the option to decline to participate in the Plan or change their employee salary deferral rate by providing the Plan with written consent.

Effective March 1, 2010, all Fort Edward Union employees hired after April 1, 2008, and all employees whose date of hire is on or after January 1, 2012, who satisfy the Plan’s eligibility requirements, are automatically enrolled in the Plan at an employee salary deferral rate of 5%.

Effective January 1, 2013, the employer matching contribution for Fort Edward Union participants hired before April 1, 2008 will decrease to 50% of the first 2% of the participants' compensation contributed to the Plan for a maximum match of 1%. Effective March 31, 2015, no employer matching contribution will be provided to Fort Edward Union participants hired before April 1, 2008; however, Fort Edward Union participants may continue to contribute to the Plan on a voluntary basis.

At the Employer's discretion, additional profit-sharing contributions can be made to eligible participants. Employer profit-sharing contributions are allocated to participants in accordance with the ratio of each employee's total eligible compensation to the total eligible compensation of all participants, as defined in the Plan document.

### Vesting

Participants are immediately vested in their contributions.

Non-union participants and Fort Edward Union participants hired after April 1, 2008 are vested immediately in their employer matching contributions. Fort Edward union participants hired before April 1, 2008, became vested in their employer matching contributions based on a graded vesting schedule over a period of four years.

Participants become vested in the Plan's profit-sharing contributions based on a graded vesting schedule over a period of four years.

### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or 10 years for the purchase of a primary residence. The loans are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The loans outstanding at December 31, 2024 bear interest at rates from 4.25% to 9.50% (2023 – 4.25% to 9.50%) and mature between one and five years. Principal and interest are paid rateably through payroll deductions.

### **Distributions**

No amounts may be distributed to participants from their accounts prior to the termination of employment, death, disability or attainment of age 59½ unless the participant has incurred a hardship, as defined by the Plan documents.

Upon distribution, a participant may roll over their vested account balance to another eligible government 547(b), 401(k), 403(b) or 401(a) plan or an Internal Revenue Agency.

### **Administrative expenses**

The Employer pays substantially all administrative expenses associated with the Plan, with the exception of certain investment management fees, which are paid by the Plan and may be charged directly to the mutual funds held by the Plan. Certain redemption and loan distribution and administration fees are paid directly by the Plan participants.

### **Forfeitures**

Upon termination of employment, employer contributions not vested will be forfeited by the member under the terms of the Plan. Amounts forfeited and all earnings of the Plan that are reasonably attributable to the forfeited amounts will be returned to the Employer as a credit against subsequent contributions. As per the terms of the Plan, forfeitures attributable to non-elective contributions will be used to reduce any non-elective contributions. Any forfeiture attributable to matching contributions will be used to reduce any matching contributions. Forfeitures available as at December 31, 2024 totalled \$187 (2023 - \$2,500).

## 2. *Summary of significant accounting policies*

### a) Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting and in accordance with generally accepted accounting principles in the United States of America (“US GAAP”).

### b) Use of estimates

The preparation of financial statements in conformity with US GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. The most significant estimates relate to the determination of fair value of investments.

### c) Investment valuation

Investments in mutual funds, are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Investments in the Collective Investment Fund and the Stable Value Fund use net asset value per share as a practical expedient for fair value. Accordingly, the Plan does not report these investments in the fair value hierarchy.

Investments held in mutual funds invest in stocks, bonds and other securities. The Putnam Stable Value Fund and the GW&K Small Cap Core Equity Collective Investment Fund invest in investment contracts offered by insurance companies and other approved financial institutions, as well as other short-term investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Distributions are recorded on the effective date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of its investments, which consists of the realized and unrealized gains and losses.

### d) Payment of benefits

Benefits are recorded when paid.

### e) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Deemed distributions due to default on participant loans totalled \$11,772 for the year ended December 31, 2024 (2023 – \$nil).

### f) Evaluation of subsequent events

For purposes of the preparation of these financial statements in conformity with US GAAP, management has considered transactions or events occurring through August 25, 2025, which represents the date that the financial statements were available to be issued.

## 3. *Information certified by the Plan's Trustee*

The Plan's fair value investments, interest and distributions, appreciation in fair value and purchases and sales of investments were certified by Empower Trust Company, LLC, the trustee of the Plan, as at December 31, 2024 and December 31, 2023 and for the year ended December 31, 2024. Therefore, in accordance with the request of the Plan's Administrator and as allowed under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure, this information was not subjected to US generally accepted auditing procedures by the Plan's independent auditor. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Mutual funds:* Valued at quoted market prices held by the Plan at year-end.

*Collective Investment Fund and Stable Value Fund:* Net asset value per share is used as a practical expedient for fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## ***4. Fair value measurements and disclosures (continued)***

As the investments in the Collective Investment Fund and the Stable Value Fund use net asset value per share as a practical expedient for fair value, they are excluded from the levelling table above.

There were no differences between the net assets available for benefits or the changes in net assets available for benefits in the financial statements and those in Form 5500 for December 31, 2024 and 2023.

## ***5. Plan termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## ***6. Income tax status***

The Plan has adopted an Empower Trust Company, LLC prototype plan, which has received a favorable opinion letter dated November 14, 2022 from the Internal Revenue Service (“IRS”) stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and thus, the Plan is exempt from federal income taxes.

US GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2017.

## ***7. Related party and party-in-interest transactions***

Certain distributions are in the form of loans to the Plan’s participants. These loans are considered to be party-in-interest transactions. Loans to Plan participants totalled \$285,404 (2023 – \$243,976) and ranged from one to five years. Interest rates on these loans ranged from 4.25% to 9.50%. Interest income for the year totalled \$19,515.

The sponsor and affiliates provide administration services to the Plan. These services are not charged to the Plan.

**8. *Risks and uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
