## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator of  
The Commonwealth School, Inc. DC Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of The Commonwealth School, Inc. DC Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Commonwealth School, Inc. **1. DESCRIPTION OF PLAN**

The following description of The Commonwealth School, Inc. DC Plan (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

**General –**

The Plan is a defined contribution plan covering substantially all employees of The Commonwealth School (the Employer) upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions –**

Upon hire, all eligible participants may contribute, on a voluntary basis, pre-tax salary deferrals up to 100% of their eligible compensation, as defined in the Plan document, subject to the maximum amount allowed by the Internal Revenue Code (IRC). Participants are required to make mandatory salary-reduction contributions to the Plan equal to 5% of their eligible compensation after attainment of age twenty-six and completion of one year of service, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the Plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes matching contributions equal to 8% of eligible compensation to participants with at least one year of service who are under age twenty-six provided the participant's elective deferrals equal or exceed 5% of the participant's compensation. The Employer makes a nonelective contribution equal to 8% of compensation for participants equal to or exceeding age twenty-six who are subject to mandatory salary-reduction contributions. For the years ended December 31, 2024 and 2023, Employer contributions totaled \$359,234 and \$310,936, respectively.

**Participant Accounts –**

Each participant's account is credited with the participant's contributions, the Employer's matching and nonelective contributions and Plan earnings thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting –**

Participants are vested immediately in all contributions plus actual earnings thereon.

**Plan Loans –**

Participants with retirement assets with Teachers Insurance and Annuity Association (TIAA) may borrow against their account balance accumulated from voluntary and rollover contributions in an aggregate amount up to the lesser of \$50,000 or 50% of their vested balances, subject to plan limitations, directly from TIAA. The minimum loan amount is \$1,000. Loans must bear a reasonable rate of interest. An amount equal to 110% of the loan must be transferred to the TIAA Traditional Annuity in the participants account to serve as collateral for such loans. TIAA uses funds from its general accounts to make loans directly to participants. A promissory note is executed by the participant. Loans must be repaid over a period not to exceed five years unless the loan is to be used for the purchase of a primary residence in which case the note may be repaid within a period of no more than ten years. In the event a loan is defaulted on, the outstanding balance and any accrued interest will be deducted from the participant TIAA Traditional Annuity account.

There were no outstanding plan loans as of December 31, 2024 and 2023.

**Notes Receivable from Participants –**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are required to be repaid within five years unless the loan is to be used for the purchase of a primary residence in which case the note may be repaid within a period of no more than ten years. Participants may only have two outstanding loans at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits –**

Upon termination of service due to death, disability or retirement, a participant may elect to receive a distribution amount equal to the value of the participant's vested interest in their account as a lump sum payment, partial payments or annuity contract, subject to certain limitations as defined in the plan document. A participant may withdraw from their rollover account at any time. A participant may also request an in-service withdrawal of all or any portion of their elective deferral account balance upon attainment of age 59 ½.

Hardship withdrawals are available from the participant's accounts, in order to meet a participant's immediate and heavy financial need, as defined in the Plan document.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting –**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Use of Estimates –**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition –**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants –**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants, if applicable, are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits –**

Benefits are recorded when paid.

**Administrative Expenses –**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Date of Management's Review –**

The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed insurance contracts (non-benefit responsive):*

The TIAA Traditional Annuity is valued at fair value by TIAA which equals the accumulated cash contributions, interest credited, and transfers, if any, less any withdrawals and transfers, if any. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange, therefore transactions in similar investment instruments are not observable. Since participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

*Variable annuity contracts:*

Valued at the net asset value of units of a variable annuity. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

*Pooled separate accounts:*

Valued at the net asset value of units of a pooled separate account. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

**4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive investment contract with TIAA. Participants individually contract with TIAA to establish an account within the TIAA Traditional Annuity. The TIAA Traditional Annuity is offered through a variety of contracts including retirement annuities (“RA”), retirement choice (“RC”), retirement choice plus (“RCP”), supplemental retirement annuities (“SRA”), and group supplemental retirement annuities (“GSRA”) as determined by the contract between TIAA and the participant. Employer contributions must be made to an RA contract. Participant contributions may be made to an RA, RC, RCP, SRA, or GSRA contract as determined by the participant.

RCP, SRA and GSRA are traditional investment contracts that meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure attribute for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported by TIAA, represents contributions made under the contract, less participant withdrawals and administrative expenses, plus earnings. RA contracts are considered non-benefit responsive due to certain illiquidity features and are valued at fair value measured using a discounted cash flow methodology.

**4. GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (Continued)**

The TIAA Traditional Annuity contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3% for SRA and GSRA contracts and not less than 1% for the RCP contract.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Employer may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**5. INFORMATION PREPARED AND CERTIFIED BY PLAN'S CUSTODIANS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and College Retirement Equities Fund (CREF) (the custodians of the Plan).

**6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**7. TAX STATUS**

The Plan has adopted a volume submitter profit sharing plan and relies on the volume submitter plan sponsor's favorable opinion letter from the Internal Revenue Service (IRS) dated August 7, 2017, in which the IRS stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**7. TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

**9. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by TIAA and CREF, the custodians of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.
