INDEPENDENT AUDITOR'S REPORT

To Trustees of FBD Partnership, L.P.

Opinion

We have audited the accompanying financial statements of FBD Partnership, L.P. sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


Auditor's Responsibilities for the Audit of the Financial Statements

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about FBD Partnership, L.P. Wellness First Health Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan

The Wellness First Health Plan provides medical, dental, life, and disability benefits covering eligible employees of the FBD Partnership, L.P. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan provides benefits (medical, hospital, surgical, major medical, prescription, dental, life, AD&D, short-term disability, long-term disability, vision, flexible spending account) that cover permanent, full-time employees that fall within the eligibility classifications of the partnership and choose to participate following the employee waiting period. An employee becomes eligible on the first day of the month following a waiting period of 30 consecutive days of employment. The plan also provides continuation coverage as required by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) for qualified beneficiaries who would otherwise have lost coverage under the plan.

The plan provided benefits through a funding arrangement that included a trust, which was funded by the plan sponsor and/or the participating employees, and with insurance to protect the plan against unpredictable excess claims. Effective at December 31, 2013, the board of directors of FBD Holdings, Inc. elected to terminate the trust. The employer will continue funding the Plan out of its general assets and with other insurance assistance. Under the plan agreement, the partnership contributes in cash to the plan in a manner and at such time determined by a committee, which is a plan fiduciary. Employees contribute to the plan in order to participate. The contribution is based on the coverage elected by the participants (i.e. single, family, etc.) and their participant class. Former members covered under COBRA make contributions to the plan for continuation of health coverage.

Medical benefits are provided on a partially self-insured basis. The plan has purchased insurance contracts to protect the plan against excessive or unpredictable claims. The insurance contracts include specific loss provisions that cover claims in excess of \$100,000 for each individual covered under the medical plan. The insurance contracts also include aggregate loss provisions that cover the combined claims for all participants of the plan when the qualified claims for the plan year exceed a stated amount. The stated amount under the aggregate loss provisions was approximately \$2,717,048 at December 31, 2024.

Although it has not expressed the intent to do so, the partnership has the right to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. Funds contributed to the plan are irrevocably restricted for the use and provision of benefits to company employees.

The foregoing description of the plan provides only general information. Employees should refer to the Summary Plan Description and Plan Document for a more complete description of the plan's provisions.

Note 2 - Summary of Significant Accounting Policies

When applicable, quoted market prices are used to value investments. Certificates of Deposit are valued based on original cost plus accrual interest. Certificates of Deposit with a maturity of three months or less are treated as cash.

The obligation for claims incurred before the financial statement date, but not reported to the plan as of the end of year, is estimated on an overall basis based on prior loss experience, and review of claims paid subsequent to the plan year end. The obligation is determined based on the present value of the ultimate cost to settle the claims. Deficits in net assets are funded subsequent to year end through payments of claims subsequent to plan year end.

Note 3 - Tax Status

The Plan has not pursued tax exempt status. However, taxable income of the Plan is defined in such a way that yields no significant tax liability for the current year.

Note 4 - Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 6 - Fair Value Measurements

The fair value of financial instruments classified as assets or liabilities, including cash, prepaid expenses, insurance contributions receivable, refunds receivable, and benefit obligations approximate carrying value, principally because of the short maturity of those items.

Note 7 - Related Party Transactions

The plan sponsor paid \$120,389 in third party administrative fees and \$424,475 in reinsurance premiums on behalf of the Plan during the year ending December 31, 2024. The plan sponsor also paid \$13,500 in auditing fees on behalf of the Plan during the year ending December 31, 2024.

Note 8 - Subsequent Events

The Plan evaluated its December 31, 2024, financial statements for subsequent events through the date of the audit report, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
