Note 1 – Plan Description

The following description of the Alpha Metallurgical Resources 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Alpha Metallurgical Resources, LLC (the “Plan Sponsor”). Employees who are covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations are not eligible to participate in the Plan. Certain nonresident aliens who have received no earned income from sources within the United States and certain leased and temporary employees as defined by the Plan are also not eligible to participate in the Plan. Eligible employees can begin participating in the Plan after completing one hour of service. The Plan began on July 25, 2016, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended effective January 1, 2019, in connection with the merger of Contura Energy, Inc.; ANR, Inc.; and Alpha Natural Resources Holdings, Inc., to include ANR, Inc.; Alpha Natural Resources Holdings, Inc.; and related entities as participating employers in the Plan.

Contributions and Catch Up Contributions

Eligible participants can contribute an amount up to 70% of eligible pay as defined by the Plan on a pre-tax basis, not to exceed the maximum contribution limit set by the Internal Revenue Service (IRS) of \$23,000 for 2024. Effective December 11, 2023, participants may also contribute on a Roth basis up to a total contribution of the aforementioned limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for 2024. Participants can also contribute an amount up to 16% of eligible compensation as defined by the Plan on an after-tax basis. Contributions are subject to certain statutory limitations. The Plan accepts direct rollovers from other qualified retirement plans as approved by the plan administrator.

The Plan includes automatic enrollment provisions whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant.

The Plan Sponsor also may, at its discretion, make an annual profit sharing contribution. Participants with at least 1,000 hours of service and employed on the last day of the Plan year are eligible to receive the profit sharing contribution. During 2024, the Plan Sponsor did not make any discretionary profit sharing contributions.

The Plan Sponsor also may, at its discretion, make additional qualified non-elective contributions (“QNEC”) to the Plan. During 2024, the Plan Sponsor did not make any QNEC contributions.

The Plan also provides for employer matching contributions at 100% of the first 3% and 50% of the next 2% of eligible compensation on any elective contributions by participants. Effective January 1, 2023, the Plan was amended to provide a true-up of employer matching contributions that ensures participants receive the full employer matching contribution based on each participant’s annual contributions to the Plan. Effective May 1, 2024, the Plan was amended to remove

safe harbor employer matching contributions and to permit a discretionary employer contribution with a flexible uniform allocation method for each plan year.

Participant accounts

Each participant's account is credited with the Plan Sponsor's matching and discretionary contributions, if any, the participant's contributions, and investment earnings and losses. Accounts are charged with withdrawals and an allocation of Plan administrative expenses. The matching contribution, if any, is allocated based upon participants' eligible contributions to the Plan. The discretionary profit sharing contribution, if any, is allocated to each participant in the ratio of each participant's eligible annual compensation to the total eligible annual compensation earned by all participants. Investment earnings are allocated based on the investments held by each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant, at all times, has a fully vested (100%) interest in their own contributions including salary deferrals, catch up contributions, and rollovers. In addition, participants have a fully vested interest in any employer matching contributions, safe harbor matching contributions and qualified non-elective contributions made by the Plan Sponsor. The vesting schedule for profit sharing contributions is as follows:

A participant shall be 100% vested in any employer contributions upon disability, death, or reaching normal retirement age while an employee of the Plan Sponsor.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum amount equal to the lesser of (i) \$50,000, reduced by the highest outstanding loan balance during the previous twelve months or (ii) 50% of their vested account balance. Terms range from 1 to 5 years, unless the loan was taken for the purchase of a primary residence for which longer terms are available. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. For the year ended December 31, 2024, the interest rates for notes outstanding with the Plan were between 4.25% and 9.5%. Principal and interest are paid ratably through payroll deductions.

Investment Options

A participant may direct their employee contributions and their allocation of Plan Sponsor contributions in any of several investment options.

Benefit Payments

Distributions can be made due to retirement, death, disability, or termination of employment and are subject to the applicable provisions of the Plan document. Normal retirement age is 65 years. In service distributions due to hardship or attainment of age 59½ are permitted. Other in-service withdrawals are permitted for all or a portion of a participant's rollover and after-tax contribution account balances.

Administrative Expenses

The Plan's administrative expenses, which include primarily custodial, investment management, and professional fees for services provided by parties in interest, are paid by either the Plan or the Plan Sponsor, as provided in the Plan document.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted prices which represent the Net Asset Value (NAV) of shares held by the Plan at the valuation date. Common trust funds are valued using the NAV provided by the Administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments consists of the realized gains or losses and the unrealized appreciation or depreciation of those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when distributed to participants.

Forfeitures

Forfeitures represent the non-vested portion of terminated participants' allocation of the Plan Sponsor's contributions. Forfeited non-vested amounts at December 31, 2024 and 2023 were \$145,566 and \$208,800, respectively. These amounts are used to reduce future contributions of the Plan Sponsor and to offset the administrative expenses of the Plan. Any remaining forfeitures will be allocated to Plan participants. During the year ended December 31, 2024, forfeitures of \$0 were used to reduce employer contributions and \$95,914 were used for Plan expenses.

Note 3 – Financial Information and Trustee (Unaudited)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information was certified as complete and accurate by the Plan's Trustee, Fidelity Management Trust Company. That information is as follows:

- Investment assets
- Investment transactions
- Investment income
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year)
- Notes receivable from participants

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental Schedule of Assets (Held at End of Year).

Note 4 – Related Party and Parties in Interest Transactions

Certain expenses were paid by the Company to the Trustee of the Plan, Fidelity Management Trust Company, for investment management services. Therefore, these transactions qualify as party in interest transactions. Administrative expenses paid to the trustee were \$181,239 for the year ended December 31, 2024. Notes receivable from participants qualify as party in interest transactions.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the distribution of account balances will be distributed by the Trustee.

Note 6 – Income Tax Status

The Plan is based on non-standardized pre-approved profit sharing plan documents that received a favorable determination letter from the IRS. The most recent pre-approved plan document received a favorable determination letter dated June 30, 2020. Although the Plan has been amended since receiving this determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the

Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.

Note 8 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 –Inputs to the valuation methodology are observable, quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 –Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 –Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to

transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 of the valuation hierarchy.

Common/Collective Trusts

These investments are valued using the Net Asset Value (“NAV”) provided by the Administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The funds consist of individual security positions that are mostly securities easily traded on recognized market exchanges. These securities are priced and traded daily, and therefore these funds are valued daily. Due to the significant observable inputs, the common/collective trusts are included in Level 2 of the fair value hierarchy.

The methods described above may produce a fair value determination that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
