We have performed audits of the financial statements of Solidigm 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### Notes to Financial Statements

#### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Solidigm 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan documents for a more complete description of the Plan’s provisions.

##### **General**

The Plan, established on January 1, 2022 is a participant-directed defined contribution plan by SK Hynix NAND Product Solutions Corp. d/b/a Solidigm (the “Company”, “Employer”, or “Plan Sponsor”) to provide benefits to eligible employees as defined in the plan document. Generally, all employees of the Company are eligible to participate in the Plan immediately upon hire or eligibility (i.e. for transfers into U.S.). Excluded employees, described as residents of Puerto Rico, employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan, leased employees, interns, and nonresident aliens who have earned no income from sources within the United States are not eligible to participate. Fidelity Management Trust Company (“Fidelity” or the “Trustee”) is the Plan’s Trustee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### **Plan Administration**

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has appointed the Administrative Committee to oversee the operation and administration of the Plan. Fidelity serves as the Plan’s directed trustee and asset custodian and an affiliate of Fidelity provides record-keeping services and manages participant accounts and participant-related transactions.

##### **Contributions**

Participants may contribute up to 75% of pre-tax eligible compensation, as defined in the Plan, up to the maximum amount permitted by tax laws. The Plan contains an automatic enrollment feature. Participants that are subject to automatic enrollment will be notified approximately 30 days prior to when the Employer will begin to automatically deduct 5% from the participant’s pay on a pre-tax basis as a deferral contribution to the Plan. Participants may also elect to make Roth contributions, on an “after tax” basis, to the Plan and may contribute amounts representing distributions from other qualified plans (rollovers). Participants may stop or change this automatic contribution by following the instructions in the notice. During 2024 the maximum annual 401(k) pre-tax contribution limit was \$23,000, and the maximum annual catch-up contribution for participants aged 50 and older was \$7,500.

The Plan provides for safe harbor contributions based on a percentage of a participant’s compensation. For the year ended December 31, 2024, the Company made safe harbor matching contributions in an amount equal to 100% of the first 5% of eligible compensation which totaled \$10,490,532. For the year ending December 31, 2024, there were \$391,814 in forfeitures that were used to reduce employer matching contributions. The total contributions of the Company and participants for any Plan year cannot exceed the lesser of (1) 100% of the participants’ compensation or (2) maximum allowable by the Internal Revenue Code (“IRC”).

The Plan also provides for discretionary, qualified non-elective contributions (“QNECs”) for all eligible participants. \$7,117 of QNECs were made for the year ended December 31, 2024.

### **NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

#### **Participant Accounts**

Each participant's account is credited or charged with the participant's contribution and allocations of (i) employer's 401(k) matching contributions and (ii) the participant's share of earnings or losses on contributions and administrative expenses. Each participant directs all amounts credited into their account into one or more of the investment options available under the Plan. Accordingly, as a participant-directed plan, each participant's investments determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions, rollovers, safe harbor matching contribution, additional discretionary matching contributions, if any, plus actual earnings thereon.

#### **Investment Options**

Participants direct the investment of their contributions, into various investment options offered by the Plan. Participants may change their contribution investment options daily and may transfer part or all of past investments to other investment options daily. Participants may also elect to change their percentage daily.

#### **Notes Receivable from Participants**

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants (or "participant loans") are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates for instruments with similar characteristics at the time of issuance. The repayment period of any participant loan shall be no more than five years, but may exceed five years if the purpose of the loan is to purchase a principal residence. A participant may have two loans outstanding at any given time. Principal and interest is paid ratably through bi-weekly and semi-monthly payroll deductions. Participant loans outstanding at December 31, 2024, bear interest at rates ranging from 4.25% to 9.50%, and mature at various dates through October 2039.

#### **Forfeited Accounts**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. However, if the participant is re-employed and fulfills certain requirements as defined by the Plan, the participant's account will be reinstated. Unused forfeitures may first be used to reduce administrative costs of the Plan. Any remaining amounts will be used to reduce future employer matching contributions. Total forfeited nonvested accounts as of December 31, 2024 totaled \$549.

#### **Hardship and In-Service Withdrawals**

The Plan Administrator may authorize a lump-sum distribution of up to 100% of the participant's vested interest (excluding any investment earnings) but not to exceed the amount necessary to meet the financial need created by the hardship provided the participant submits positive evidence of an immediate and heavy financial need as defined in the Plan. In-service distributions of the participant's vested interest are available for any reason upon attaining age 59½.

### **NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

#### **Deemed Distributions**

When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Deemed distributions on defaulted loans are recorded in the calendar quarter following the calendar quarter during which the loan was defaulted. There were no deemed distributions for the year ended December 31, 2024.

#### **Benefit Payments**

Upon termination of service due to death, disability or retirement, as defined in the Plan, participants are entitled to a fully vested lump sum payment of their account balance. For termination of service due to other reasons, participants are entitled to the value of the vested interest in their account as a lump-sum distribution. If a participant's account balance is less than or equal to \$1,000 upon termination, the balance is distributed in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. Upon termination, balances greater than \$1,000 and less than or equal to \$7,000 will be rolled over to an individual retirement account designated by the administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over \$7,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, installment payments, partial payments, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents. As of December 31, 2024, all employees who elected to withdraw from the Plan had been paid.

### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Expenses of the Plan**

The Company absorbs certain of the administrative charges associated with the Plan. Expenses paid by the Company are excluded from these financial statements. Administrative expenses reflected on the statement of changes in net assets available for benefits consist of certain trustee, asset, loan, and third-party fees that are charged to the individual participant account.

#### **Investment Valuation and Income Recognition**

All Plan investments are held by the Trustee. The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for discussion of fair value measurements).

#### **Investment Valuation and Income Recognition (Continued)**

Security transactions are accounted for on the trade-date basis. Dividend income is accrued on the ex-dividend date. Interest income is recorded on the accrual basis. Net realized and unrealized appreciation/depreciation is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses is recorded as of December 31, 2024, as the notes are collateralized by the participant's account balance.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through the date these financial statements were available for issuance, August 19, 2025. No such events were identified.

### **NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the Trustee of the Plan, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in the fair value of investments, interest and dividend income, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023:

*Mutual funds and Money market funds:* Valued at the quoted market prices of shares or units held by the Plan.

*Stable Value Common Collective Trust:* Valued using the NAV provided by T. Rowe Price. The fund is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a one year redemption notice to liquidate its entire share in the fund.

*Self-directed Brokerage Accounts:* These accounts may include mutual funds, common stock and exchange-traded funds, all of which are valued at the closing price reported in the active market in which the securities are traded. The short-term investments are mutual funds and U.S. Government Securities valued as noted above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – EXEMPT PARTY-IN-INTEREST**

At December 31, 2024, certain Plan investments were managed by Fidelity, the Trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to the Trustee totaled \$18,645 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their Company contributions and earnings thereon.

### NOTE 7 – TAX STATUS

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a Cash or Deferred Arrangement (“CODA”) sponsored by Fidelity Management Research Co. which received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, as to the Plan’s qualified status. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and accordingly no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL. The Plan’s management does not believe that there are uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE 8 – PROHIBITED TRANSACTIONS

The DOL considers late deposits to be prohibited transactions. Plan Management determined that during the years ended December 31, 2023 and 2022, the Plan Sponsor failed to remit certain employee deferrals to the Plan in a timely manner according to DOL regulations. These late remittances totaled \$680 and \$151,096, respectively. Lost earnings and wages have been calculated on the full amounts of the late remittances. The Employer has undertaken the necessary procedures to calculate and reimburse the affected participants for lost earnings due to these late contributions under the DOL’s Voluntary Fiduciary Correction Program (“VFCP”). As of December 31, 2024, corrections for lost earnings and interest thereon, have been fully restored to the participants’ accounts for the late contributions made in the years ended December 31, 2023 and 2022 totaling \$680 and \$151,096, respectively.
