Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Messiah University Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to the Financial Statements

December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN:

The following brief description of the Messiah University Defined Contribution Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a 403(b) retirement plan covering all eligible employees of Messiah University (University). Other than student employees, all employees are eligible to make elective deferrals to the Plan. Employees regularly scheduled to work more than 1,000 hours during their first 12 months of employment are immediately eligible to receive employer matching contributions. Other employees become eligible to receive employer matching contributions upon completion of 1,000 hours of service during a 12 month period. Part-time, adjunct faculty are not eligible for the matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The University's retirement plan oversight committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Academy's Board of Trustees.

CONTRIBUTIONS

Participants may make elective deferral contributions up to limits prescribed by law. The University makes matching contributions corresponding to the elective deferral percentage as shown in the following table:

Elective Deferral	
<u>Percentage</u>	<u>Matching Rate</u>
0% - 2.49%	0%
2.5% - 4.99%	3%
5% - 7.49%	6%
7.5% or greater	8%

Contributions are subject to certain limitations prescribed by law. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants who have attained age 50 and/or 15 years of service before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants who receive the enhanced tuition reduction benefit are eligible for an employer match equal to 50% of the first 4% of their elective deferral instead of the tiered matching percentages above. Effective July 01, 2024, the Enhanced Tuition Reduction Benefit was discontinued.

1. DESCRIPTION OF THE PLAN, continued:

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the University's contribution and (b) Plan earnings and charged with allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the University's contribution portion of their accounts and related earnings is based on years of continuous service. A participant is 100% vested after two years of credited service.

PLAN LOANS

TIAA no longer allows plan loans, however previous participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans, totaling \$48,203 and \$75,720, at December 31, 2024 and 2023, respectively, are secured by the balance in the participant's account and bear interest at rates from 4.0% to 7.65%. The loans are not considered assets of the Plan and, therefore, are not included on the statements of net assets available for benefits.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts held by Reliance Trust Company (Reliance) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates between 3.25%-8.50%. Principal and interest are paid ratably through monthly payroll deductions. Participant loans are reported as notes receivable from participants on the statements of net assets available for benefits.

PAYMENT OF BENEFITS

Upon termination of service due to death, disability or retirement or attaining age 59 1/2, participants with vested account balances greater than \$7,000 generally receive payments in the form of a lifetime annuity, or, if married, as a joint and survivor annuity. Other forms of payment are available, providing that the participant, and spouse, if married, waive the annuity form of payment. Participants with vested account balances of \$7,000 or less will receive a single lump-sum payment. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

FORFEITURES

Amounts that are forfeited due to a participant's termination of employment prior to 100% vesting in employer contributions made on the participant's behalf are used to reduce future employer contributions or to pay plan expenses. As of both December 31, 2024 and 2023, the balance in forfeited nonvested accounts was \$1 and \$2, respectively. Forfeitures used to reduce employer contributions were \$2,298 for the year ended December 31, 2024.

ADMINISTRATIVE EXPENSES

Substantially all administrative expenses are paid by the Plan.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on investments valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans from participants are recorded as a distribution based upon the terms of the Plan document.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion on investments valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Variable annuity contracts are valued at the net asset value (NAV) of units held by the Plan at year end based on the fair value of the underlying investments. NAV is a readily determinable fair value which is published daily and is the basis for current transactions. Non benefit-responsive fixed annuity contracts are not actively traded, and significant other observable inputs are not available. Therefore, the fair value of the non-benefit responsive fixed annuity contracts is determined using an income approach by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. These contracts have liquidity restrictions and are non-benefit responsive. The fair value of the pooled separate account units is principally derived from the market value of the underlying real estate holdings or other real estate-related investments.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANIES:

The Plan has benefit-responsive guaranteed investment contracts with TIAA and Prudential. TIAA and Prudential maintain the contributions in a general account. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by TIAA and Prudential, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023, was \$8,842,985 and \$8,429,342, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are declared on a monthly basis.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANIES, continued:

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity date. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations.

6. PARTIES-IN-INTEREST:

The Standard performs recordkeeping services for the Plan; therefore, fees paid to The Standard qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping services amounted to \$267,369 for the year ended December 31, 2024. In addition, \$145,076 of direct fees were paid to other parties-in-interest for advisory and consulting services for the year ended December 31, 2024.

TIAA and CREF, custodians of the Plan, manage some of the Plan's investments. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions and earnings thereon.

8. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by Standard Retirement Services Inc. The prototype plan document has obtained an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However the Plan administrator and the Plan's counsel believe that the Plan is designed, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
