Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Versiti, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Versiti, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Versiti, Inc. and its affiliates (the Organization). Participating affiliates include Versiti Wisconsin, Inc. (“Wisconsin”), Versiti Illinois, Inc. (“Illinois”), Versiti Michigan, Inc. (“Michigan”), and Versiti Indiana, Inc. (“Indiana”). All employees of the Organization over the age of 18 are eligible to participate in the Plan. There are no other employment restrictions on Plan eligibility for employee deferrals and Organization matching and non-elective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Participants are automatically enrolled in the Plan at an employee deferral contribution pre-tax rate of 3% of eligible compensation. In general, such automatic enrollment will be effective the first pay period after 30 days of employment, unless the participant elects to participate at a different rate or elects to opt out of participation. Employee elective deferrals will have an automatic increase of 1% each Plan year, not to exceed 8% of eligible compensation, unless the participant elects to opt out of participation.

Fidelity Management Trust Company (“Fidelity”) serves as the Trustee of the Plan. Fidelity Workplace Solutions serves as the recordkeeper of the Plan.

Contributions

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan agreement, up to the maximum amount allowed by the Internal Revenue Code (“IRC”). In addition, participants may contribute after-tax annual compensation (Roth and regular after-tax contributions), as defined in the Plan agreement, up to the maximum amount allowed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing pre-tax and Roth distributions from other qualified defined benefit or contribution plans. Rollovers of after-tax contributions are not allowed. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2023, the Organization provides a discretionary match of 100% of the first 7% of eligible compensation that the participant contributes to the Plan for all eligible participants.

Additional discretionary non-elective amounts may be contributed for a select group of participants.

Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Organization’s discretionary matching contribution, allocations of the Organization’s discretionary non-elective contributions (when made) and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. A participant's interest in the Organization's contributions, plus actual earnings (losses) thereon, vests based on eligibility rules specific to certain groups of employees.

Notes Receivable from Participants

Participants may borrow from their vested balance a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the vested balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates on commercial loans. Principal and interest are paid ratably while the participant is employed by the Organization over a period not to exceed five years, unless for the purchase of a primary residence. A participant may have no more than two loans outstanding at any point in time.

Payment of Benefits

On termination of service due to employment termination, death, disability or retirement, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount or in annual installments equal to the value of the participant's vested interest in their account or an annuity. The Plan also allows for in-service distributions upon attaining age 59½.

Forfeitures

Forfeitures resulting from the non-vested portions of accounts of participants who terminate prior to being fully vested may be used to pay administrative expenses of the Plan or used to reduce Organization contributions. There were \$467,827 and \$422,910 of forfeitures used to reduce the Organization's contributions or pay administrative expenses of the Plan for the years ended December 31, 2024 and 2023, respectively. There were \$214,214 and \$54,729 of unallocated forfeitures from non-vested accounts as of December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. There is no allowance for credit losses as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to investment advisory and management fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

NOTE C - FAIR VALUE MEASUREMENTS

The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund - Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Self-directed brokerage - Accounts primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Fidelity, who acts as the Plan trustee. Any transactions with Fidelity qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

The Organization pays certain expenses of the Plan.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G - INCOME TAX STATUS

The Plan adopted a volume submitter plan document effective December 1, 2017, which received an advisory letter from the IRS on March 31, 2014, which stated that the volume submitter plan document is designed in accordance with the applicable sections of the IRC. The Organization has determined that it is eligible and has chosen to rely on the current IRS advisory letter. The Plan has adopted other discretionary amendments. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that would likely not be sustained upon examination by a tax authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENTS

Plan management evaluated its December 31, 2024 financial statements for subsequent events through August 8, 2025, the date the financial statements were issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the accompanying financial statements.
