Note 1 – Plan Description and Basis of Presentation

The following description of the QualityLogic, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was originally adopted on January 1, 1997. The Plan is a defined 401(k) savings plan covering all eligible employees of QualityLogic, Inc. (the “Company”), and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). QualityLogic, Inc. is the Plan’s sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Plan after completing three consecutive months of service. Participants, once eligible, may begin deferring a portion of their compensation into the Plan on the first day of the quarter following the satisfaction of eligibility requirements. Employees are not eligible to participate in the Plan if they are a leased employee, a nonresident alien, or a resident of Puerto Rico.

Participant Contributions – Participants can contribute up to the legal maximum of their eligible salaries, in 2024, not to exceed \$23,000. Participants age 50 or older may elect to defer additional amounts (called “catch-up” contributions) to the Plan. The maximum catch-up contribution that could be made in 2024 was \$7,500. The catch-up contributions can be deferred regardless of any other limitations on the amounts that can be contributed to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollover”).

Employer Contributions – Effective January 1, 2023, the Company makes safe harbor matching contributions equal to 100% of the amount that participants contribute up to 3% of Plan compensation and 50% of the next 2% of Plan compensation. The Company may also make discretionary employer contributions.

For the year ended December 31, 2024, safe harbor matching contributions of approximately \$195,000 were made to the Plan. In addition, the Company at its option, may make employer matching and employer nonelective contributions. There were no employer matching or employer nonelective contributions for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Plan Sponsor’s contributions and as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested interest in his or her account.

Note 1 – Plan Description and Basis of Presentation (Continued)

Vesting – Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Participants vest in the Company's nonelective contributions in annual ratable installments of 20% after the first year of service until fully vested after five years of service. Participants are fully vested in the event of death, disability, or attaining normal retirement age of 65 years old.

Payment of Benefits – The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship, or termination of employment. In-service distributions are also available to those participants who are 59½ or older. Participants who qualify for retirement benefits and withdrawals will receive their benefits as a lump sum in cash or installment payments. The benefit to which a participant is entitled is the benefit that can be provided solely from the participant's vested account balance. Participants who separate from service and have vested account balances of \$5,000 or less are subject to an administrative lump sum distribution.

Forfeitures – If a participant terminates prior to vesting 100% in the employer contributions, the forfeited balance will be used to reduce future employer contributions or administrative expenses. During the year ended December 31, 2024, there were no forfeitures used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$16,914 and \$12,399, respectively.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan repayment terms shall be no greater than five years (or such longer period as permitted by law) except when loan proceeds are used for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at variable rates. At December 31, 2024, all outstanding loans had an interest rate ranging from 3.25% to 8.50%. Principal and interest are paid over the term of the loan through payroll deductions. No allowance has been recorded as of December 31, 2024 or 2023.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America.

Note 2 – Summary of Significant Accounting Policies (Continued)

Use of Estimates – The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are stated at fair value and contract value as determined by the custodian. The carrying value of interest bearing money market accounts equal their fair value. Increases or decreases in fair value are recognized currently. Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits – Benefits are recorded when paid.

Risk and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 3 – Custodian Certification

Certain information related to investments and notes receivable from participants as disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, (The Standard Insurance Company group annuity contract certified at contract value) and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company (the trustee of the Plan).

Note 4 – Group Annuity Contract

The Plan entered into a fully benefit-responsive group annuity contract that invests in a fully benefit-responsive guaranteed investment contract (FBRIC) with The Standard Insurance Company. The Standard Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by the Plan by The Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Fair Value Measurements

The accounting standards regarding fair value measurements define fair value, establish a framework for measuring fair value, and provide for enhanced disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an "exit price") in the principal or most advantageous market for the asset or liability in orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 Valuation is based upon quoted prices in active markets for identical securities.
- Level 2 Valuation is based upon other observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).
- Level 3 Valuation is based upon unobservable inputs significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and December 31, 2023.

Pooled Separate Accounts

These investments are privately managed accounts valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. As the investments can be redeemed at NAV as of the measurement date, the administrator of the fund believes the investments have a "Readily Determinable Fair Value".

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Below are the Plan's financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels established in current accounting standards.

Note 6 – Related Party Transactions

Certain Plan investments are shares of mutual funds managed by The Standard Insurance Company. The Standard Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan to the custodian for administrative expenses and other related fees related to the Plan’s operations totaled approximately \$2,600 for the year ended December 31, 2024.

Transactions involving participant loans also qualify as party-in-interest transactions.

Note 7 – Plan Termination

Although the Company has expressed no intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, amounts allocated to a participant’s account shall immediately become fully vested.

Note 8 – Tax Status

The Plan has adopted the volume submitter profit sharing plan. The Plan obtained its latest opinion letter from the Internal Revenue Service dated March 31, 2014, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 9 – Subsequent Events

The Plan has evaluated subsequent events through August 22, 2024, the date which the financial statements were available to be issued. No events have occurred through this date requiring additional disclosure.
