We have performed an audit of the financial statements of Leif Johnson Ford II, Ltd. 401(k) Salary Reduction Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1: Description of Plan**

The following description of the Leif Johnson Ford II, Ltd. 401(k) Salary Reduction Plan provides only general information. Participants should refer to the Plan's adoption agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the participating companies ("the Company") except collective bargaining employees, and nonresident aliens who do not receive United States source income, who have 6 months of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The participating companies are Leif Johnson Ford II, Ltd., Riata Ford, Ltd., AJ Car and Truck Sales, Limited, and LJ Monahans I, LLC.

Administration: Under the terms of the Plan, certain corporate officers of the sponsor are designated as plan trustee. The Plan has contracted with The Vanguard Group, Inc. ("Vanguard"), to act as Contract Administrator, and Ascensus Trust Company ("Ascensus") to act as trustee. Vanguard has subcontracted with Ascensus, LLC to provide record keeping and compliance services.

Contributions - Each year, participants may contribute from 1% to 100% of included compensation, as defined in the Plan, and subject to IRS annual limits. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make matching contributions equal to a discretionary percentage, to be determined by the employer, of the participant's elective deferral. For the plan year ending December 31, 2024, the plan sponsor made matching contributions equal to 50% of each participant's deferral amount up to the first 6% of wages. The match is also limited to wages up to the annual social security tax wage limit, currently \$168,600.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expense. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of service.

Forfeitures - The total non-vested portion of terminated participants' account balances are used by the plan sponsor to pay plan expenses or allocated to participants as additional employer matching contributions. During the year ended December 31, 2024, there were \$54,238 of forfeitures generated, and \$20,067 used for fees. As of December 31, 2024 there were \$35,932 of forfeitures available.

Investment Options - Upon enrollment in the Plan, a participant may direct employee contributions in various increments to the investments administered by Vanguard. Participants may change their investments daily and choose from a variety of mutual fund and collective investment trust investments.

Payment of Benefits - Upon termination of employment, retirement, disability, or death, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump sum distribution. In service distributions may also be made due to financial hardship as defined by the Plan. All investments available in the plan allow for daily redemptions with no redemption notice period required.

**Note 1: Description of Plan (continued)**

Notes Receivable from Participant - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one loan outstanding. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan balances may be paid over a reasonable period of time not to exceed 5 years, unless the loan is to acquire a principle residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate (as specified in the Wall Street Journal) plus 1%.

Amendments - There were no amendments to the plan during the year ending December 31, 2024.

**Note 2: Summary of Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments consist of mutual funds. The mutual funds are stated at fair value as determined by Ascensus, based on quoted market prices.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Risks and Uncertainties - The Plan provides for various investment options which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is possible that changes in the values of investments will occur in the near term and would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Purchases and sales of securities - Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Plan management has evaluated subsequent events through August 27, 2024, the date the financial statements were available to be issued.

**Note 4: Fair Value Measurements**

Financial Accounting Standards Board ASC 820-10 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 4: Fair Value Measurements (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value ("NAV") of shares held by the plan at year end as reported by Ascensus Trust Company, the trustee of the Plan, based on quoted market prices.

Collective Investment Trusts: Valued at net asset value ("NAV") as provided by Ascensus Trust Company, LLC, the trustee of the Plan, based on the number of units held, and market prices of the underlying common stock investments. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan uses the prototype plan document Defined Contribution Basic Plan Document 01, sponsored by Ascensus, LLC who received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Basic Plan Document was amended on June 15, 2021 to adopt the provisions of the Bipartisan Budget Act of 2018 regarding hardship withdrawals. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC; therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administration has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**Note 7: Administrative Fees**

The Plan paid \$72,381 in direct fees from plan assets during the year ending December 31, 2024. The Plan's administrator, Vanguard, received \$42,508 in fees for contract administration. The Plan's advisor receives a asset based fee of .25%, and was paid \$29,873 for advisory services. Total fund level fees for the investments held at December 31, 2024 range from .05% to 1.14%, dependent on investment selection.

**Note 8: Corrective Distributions of Excess Contributions**

The Plan was required to make corrective distributions of \$65,839 and \$77,024 to certain active participants, to return to them excess deferral contributions to satisfy the relevant nondiscrimination provisions of the Plan for the 2024 and 2023 plan years, respectively. These amounts are reflected as Excess Employee Contributions Payable in the statement of net assets available for benefits as of December 31, 2024 and 2023.

**Note 9: Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Some of the plan investments are mutual funds offered by Vanguard, who is also the plan's record keeper. Vanguard is the investment advisor for these investments, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Vanguard for investment management services of these mutual funds are included as a reduction of the return on each fund. Notes receivable from participants also reflect party-in-interest transactions.
