## INDEPENDENT AUDITOR'S REPORT

To the Participants of the  
Prime Controls, L.P. 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the accompanying financial statements of Prime Controls, L.P. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Prime Controls, L.P. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information

prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

*Basis for Opinion*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Prime Controls, L.P. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

*Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Prime Controls, L.P. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

*Auditor's Responsibilities for the Audit of the Financial Statements*

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**Note 1      DESCRIPTION OF PLAN**

The following description of the Prime Controls, L.P. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan is a defined contribution plan established by Prime Controls, L.P. (the Company). The Plan qualifies as a profit-sharing plan under the Internal Revenue Code (Code) Section 401(a) and as a cash-or-deferred arrangement under Code Section 401(k).

The Plan is a defined contribution plan that covers all employees of the Company who are age 18 or older and have 90 days of service with the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan entry dates are the first day of each quarter.

**Employee contributions**

Participants are permitted to contribute all or part of their annual compensation to the Plan on a tax-deferred basis, up to the limits of the Code. Transfers (rollovers) from qualified plans are allowed under the provisions of the Plan.

**Employer contributions**

The Company makes safe harbor matching contributions based on each participant's contributions for the Plan year. The matching rate is 100%, limited to matching participant contributions up to 3% of salary and 50% of the next 2% of eligible employee contributions. All 2024 employer contributions were safe harbor matching contributions. All eligible participants receive safe harbor matching contributions.

The Company may also make other types of contributions including: nonelective (discretionary) employer contributions (profit sharing contributions) and qualified nonelective contributions (QNEC). These were not made in 2024.

**Administrative expenses**

The Company pays most of the Plan's administrative expenses.

**Participant accounts**

Each participant's account is credited with the participant's contribution, the Company's matching contribution, an allocation of other employer contributions, if any, and an allocation of Plan earnings. Allocations of Plan investment earnings or losses are based on participants' account balances invested in each fund.

**Investments**

All investments are participant directed.

**Vesting**

Participants are fully vested in their deferral, rollover, safe harbor match, and QNEC accounts. The employer may make discretionary profit sharing contributions which are 20% vested after the employee has two years of vesting service; the vested amount increases 20% per year until they are 100% vested after six years. Employees' discretionary matching balances become fully vested in employer contributions when a participant (while employed by the Company): (1) attains age 65, (2) becomes disabled, or (3) dies.

**Notes receivable from participants**

Participants may receive a loan from their participant accounts. The minimum amount of a loan is \$1,000; the maximum amount is the lesser of: (1) \$50,000 or (2) 50% of their vested account balance. These loans generally range up to five years in length. Participant loans are secured by the participants' vested balance in the plan. As of December 31, 2024, these loans bore interest from 5% to 11%, were payable in bi-weekly payments, and mature at various dates through December 2040.

**Payment of benefits**

Upon termination of service, participants with vested balances of \$5,000 or less receive a distribution of their vested balances, net of tax withholding, in a lump sum. If the amount to be distributed is between \$60 and \$5,000 and the participant does not affirmatively elect to have the distribution rolled into a qualified plan or paid to them (net of tax withholding), the balance is transferred into an individual retirement account set up for their benefit. Otherwise, terminated participants receive a lump-sum amount equal to the value of their vested interest in their account when they elect a distribution of their account balance.

In-service withdrawals of certain vested balances are available to participants in cases of hardship or other allowable circumstances. Also, contributions that were transferred into the Plan from another qualified plan may be transferred out of the Plan to an individual retirement account or another qualified plan.

**Forfeitures**

Forfeitures for 2024 and 2023 were trivial. Forfeitures may be used to pay administrative expenses or to reduce future employer contributions.

**Other plan provisions**

Other Plan provisions including investment options are described in the Plan Document.

**Note 2**      **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements of the Plan are prepared using the modified cash basis of accounting. This method differs from accounting principles generally accepted in the United States of America since revenues are recorded when received rather than when earned, and expenses are recorded when paid rather than when incurred.

**Investment valuation and income recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Participant loans are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income on participant loans is recorded when received.

**Payment of benefits**

Benefits are recorded when paid.

**Use of estimates**

The preparation of financial statements in conformity with the modified cash basis requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Subsequent events**

The Plan has evaluated subsequent events through August 19, 2025, the date which the financial statements were available to be issued.

**Note 3**      **TAX STATUS**

On December 11, 2017, the Plan adopted the Nova 401(K) Associates Volume Submitter Profit Sharing Plan and Trust, Basic Plan Document #003. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Volume Submitter Plan, as designed, was in compliance with the applicable requirements of the Code. Therefore, no provisions for income taxes are included in the accompanying financial statements.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that is more likely than not to be sustained upon examination by the U.S. Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 4**      **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan's sponsor has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a full or partial plan termination, affected participants will become fully vested in their accounts.

**Note 5**      **INFORMATION CERTIFIED**

The December 31, 2024 and 2023 statements of net assets available for benefits, the investment activities included on the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Principal Trust Company and Principal Life Insurance Company (collectively, The Custodians) in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income

Security Act of 1974. The information certified includes total investments of \$63,610,322 and \$54,687,260 at December 31, 2024 and 2023, respectively, and related investment earnings (losses) of \$7,106,801 for the year ended December 31, 2024.

These accounts are maintained by the Custodians, who are parties-in-interest.

**Note 6**      **FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets or liabilities. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

**Level 1**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Fair value of investments that calculate NAV**

Pooled separate accounts (PSAs) and common-collective trusts (CCTs) are measured at NAV per share as of December 31, 2024 and 2023. Their fair value is shown in the tables above. The PSAs and CCTs have no unfunded commitments or redemption notice requirements. In exceptional circumstances, PSAs and CCTs may place trading restrictions on incoming transfers; however, transfers out of a PSA or CCT are allowed at any time at the PSA's/CCT'S NAV. PSAs/CCTs are normally heavily-invested in a mutual fund. For example, the Principal Lifetime Hybrid 2055 CIT (a CCT) is heavily invested in the Principal Lifetime Hybrid 2055 Fund (the underlying mutual fund). The PSAs'/CCTs' objectives are to remain heavily-invested in the underlying mutual funds, and to mirror their performance as closely as possible.

**Note 7 REPORTABLE TRANSACTIONS**

There were no reportable transactions in 2024.

**Note 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
