### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of WorldLink 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1: Plan Description**

The following description of the WorldLink 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution retirement plan established on January 1, 2007, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers employees of ADI WorldLink, LLC (Company) who have attained age 21 and completed three consecutive months of service, or one year of service if the consecutive month threshold is not met. Temporary and seasonal employees are excluded from participation unless they complete one year of service (defined as 1,000 hours within a 12-month period). In August 2022, the Plan was restated to reflect current IRS requirements, including mandatory hardship distribution rules under the Bipartisan Budget Act of 2018, and to update eligibility terms by removing part-time employees from the excluded employee class, thereby broadening plan accessibility. The Company is responsible for the administration and oversight of the Plan.

**Contributions**

Each year, participants may contribute up to 90% of annual compensation, as defined by the Plan, limited to the maximum amount permitted under applicable Internal Revenue Service (IRS) provisions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year until reaching 6%.

The Plan does not allow for Company matching or non-elective contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their contributions plus actual earnings thereon.

**Forfeitures**

Due to participants being fully vested in their contributions and the Plan not offering Company contributions, there is no forfeiture account maintained by the Plan.

**Payment of Benefits**

On termination of service a participant or beneficiary of a deceased participant may elect to receive either a single lump-sum payment, or partial withdrawals equal to the value of the participant's vested interest in his or her account. However, if the value of the vested account balance does not exceed \$5,000, then a lump-sum distribution will be made without participants consent. Participants are also eligible to receive in-service distributions after attaining age 59 ½ or due to hardship (subject to certain restrictions).

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000. The maximum amount will be reduced by the participant's highest outstanding loan balance in the previous twelve months. A participant may only have one open loan at any time. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the participant loan fund. Loans must be repaid within five years, unless the loan is for the purchase of the participant's principal residence, in which case the Plan administrator may permit a longer repayment term. The loan is secured by the balance in the participant's account. The interest rate, unless otherwise determined by the custodian, will be the prime rate as published by the *Wall Street Journal* on the 14<sup>th</sup> of each month, plus one percentage point. Principal and interest are paid ratably through bi-weekly payroll deductions. Participant notes receivable are valued at amortized cost.

**Note 2: Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to accounting principles generally accepted in the United States of America (U.S. GAAP) and have been consistently applied in the preparation of the financial statements.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of the financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 6 for discussion of fair value measurements.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. There were no excess contributions for the year ended December 31, 2024. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

**Payment of Benefits**

Benefits are recorded when paid.

**Administration of the Plan**

Certain administrative expenses of the Plan may be paid by the Company. The Plan is not required to reimburse the Company for any administrative expenses paid by the Company. Expenses not paid by the Company are paid by the Plan.

**Date of Management's Review**

Subsequent events have been evaluated for potential recognition or disclosure through July 30, 2025, which is the date the financial statements were available to be issued. See Note 4.

**Note 3: Income Tax Status**

The Plan uses a non-standardized pre-approved plan document sponsored by ADP, LLC. The pre-approved plan sponsor received an opinion letter from the IRS, dated October 6, 2020, which states the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 4: Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance).

Effective January 1, 2025, the Plan's trustee will change from Reliance to ADP Retirement Trust Services LLC.

**Note 5: Party-in-Interest**

The Plan invests in mutual funds managed by Reliance, who acts as trustee of the Plan's assets, as defined by the Plan. ADP Retirement Services provides the recordkeeping and administrative services to the Plan. U.S. Capital Advisors, LLC is an investment advisor to the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the ERISA prohibited transaction rules.

**Note 6: Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts. The Company would then direct the distribution of the accounts in a manner permitted by the Plan as soon as practicable.

**Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
