To the Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Mikel, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of the Plan**

The following description of the Mikel, Inc. 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401(k) plan covering all employees of Mikel, Inc. (the Employer). Effective February 1, 2023, the Plan automatically enrolls eligible employees to contribute 3% of pre-tax compensation unless they opt out or choose a different contribution rate. Employees can also enter the Plan on the first day of the month after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the Plan Administrator. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company (Reliance) is the Plan's trustee; the trustee acts at the discretion of the Plan Administrator.

***Contributions***

Participants may contribute any percentage up to 80% of their eligible compensation, as defined in the Plan document, not to exceed annual limitations as provided by the Internal Revenue Code (IRC). In addition, participants may make Roth contributions into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

Effective January 1, 2025, the Plan was amended to increase the maximum allowable deferral percentage from 80% to 90% of eligible compensation.

The Employer's safe harbor non-elective contribution is equal to 3% of the participant's compensation. Participants will become eligible to receive safe harbor non-elective contributions upon completion of one year of service (1,000 hours).

In addition, the Employer may choose to make a discretionary matching contribution or discretionary profit sharing contribution, as permitted by the Plan. Participants will become eligible for discretionary matching contributions upon completing one year of service. The Employer did not make a discretionary matching contribution to the Plan for the year ended December 31, 2024.

Participants become eligible for discretionary profit sharing contributions upon completing one year of service and if they remain employed on the last day of the Plan year. The Employer did not make a discretionary profit sharing contribution for the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and their allocation of the Employer's safe harbor non-elective contribution, the Employer's discretionary profit sharing contribution, the Employer's discretionary matching contribution and earnings/losses and administrative expenses. The allocation of earnings/losses and administrative expenses is based on individual participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and safe harbor non-elective contributions, plus the allocation of Plan earnings on those contributions at the time of allocation. Participants become 100% vested in the Employer's discretionary matching and discretionary profit sharing contributions and the allocation of Plan earnings on those contributions after providing three years of service. Participants are immediately vested in all accounts upon death, disability or attainment of retirement age.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, unless for the purpose of acquiring a primary residence. The notes bear interest at a rate of prime plus 1% at the date that the note is issued. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

On retirement, death, disability or termination of service, a participant (or participant's beneficiary in the event of death) can elect to receive a single lump-sum distribution or a distribution in installments, roll over the balance to a qualifying retirement account, or defer receiving payments until age 70½. If a terminated participant's vested balance is equal to or less than \$5,000, the recordkeeper, within approximately 60 days of termination, will automatically establish a separate Individual Retirement Account (IRA) for the participant outside of the Plan and then will roll over the participant's balance, as a lump-sum payment, into the participant's IRA account.

The Plan allows for in-service distributions of the participant's vested account balance upon reaching the age of 59½ as defined by the Plan. The minimum permitted in-service distribution is \$500. Hardship withdrawals from the Plan are permitted.

***Plan Termination***

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

***Forfeitures***

Participants in the Plan who leave the employment of the Employer before completing three years of service forfeit the non-vested portion of their accounts. Forfeitures may be used to reduce non-elective Employer contributions and Plan administrative expenses. At December 31, 2024 and 2023, forfeited non-vested balances were \$1 and \$10, respectively. These amounts were trivial and had no material impact on Plan operations. No forfeitures were applied during 2024 to reduce non-elective Employer contributions or Plan administrative expenses.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan invests in a collective investment trust fund. The Plan's interest in the collective investment trust fund is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the collective investment trust at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation included in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balance plus any accrued interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Contributions***

Participant contributions are recorded bi-weekly when the Employer remits the contributions for investment into the funds. Employer safe harbor contributions are recorded bi-weekly when the Employer calculates and remits the contributions for investment into the funds. Employer discretionary profit sharing and discretionary matching contributions, if any, are remitted annually.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, and financial advising and consulting fees are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

Effective January 1, 2025, the Plan was amended to increase the maximum elective deferral limit to 90% of a participant's eligible compensation, including Roth deferrals where applicable.

Management has evaluated subsequent events through August 20, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* As of December 31, 2024, the Plan invested in the Stable Value Fund, Large Cap Growth Fund III, and Mid Cap Growth Fund II, which invest in benefit-responsive investment contracts, fixed income securities, and money market funds. All three funds are valued at NAV of units held by the Plan. The NAV, as provided through the flexPATH Funds of Great Gray Collective Investment Trust (Great Gray), is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments, less liabilities, and would not be used if it is probable that the investment will be sold for an amount different than the reported NAV. Unit values are calculated by dividing the fund's net assets at fair value by the units outstanding at the valuation date. Participant transactions may occur daily, with no unfunded commitments or redemption restrictions for participants, though there is up to a 12-month redemption restriction at the Plan level.

**5. Income Tax Status**

The Plan is operating under a prototype plan sponsored by ADP, which received a favorable advisory letter from the Internal Revenue Service (IRS) dated July 16, 2014, stating that the form of the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is tax-exempt. The Plan has been amended since receiving the advisory letter. However, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Reliance Trust Company, the trustee of the Plan. ADP Retirement Services (ADP) is the recordkeeper of the Plan. Therefore, transactions with these parties qualify as party-in-interest transactions. Fees paid for investment management services are paid directly to Massachusetts Mutual. The Plan made direct payments of \$22,145 to Massachusetts Mutual for investment advisory services and \$36,533 to ADP for recordkeeping services for the year ended December 31, 2024. Participant notes receivable also qualify as party-in-interest transactions.

**7. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items and the inclusion of contributions receivable in the accrual basis financial statements.
