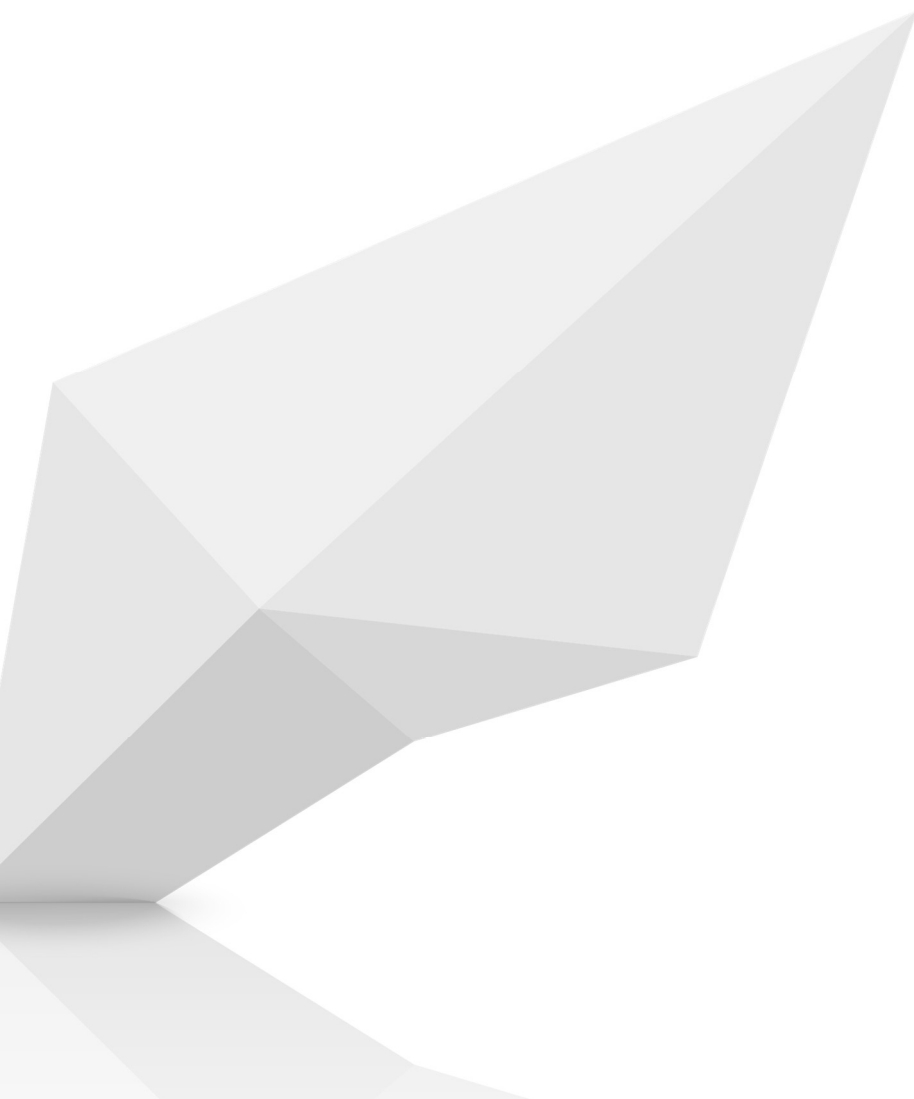

We have performed audits of the financial statements of Saelens Corporation 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Note 1: Description of Plan

The following description of the Saelens Corporation 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering eligible employees, as defined in the Plan, of Saelens Corporation 401(k) Savings Plan (Employer or Sponsor). The Plan is intended to be a qualified retirement plan under the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

Full-time or salaried employees are eligible to participate in the Plan after they have completed 90 days of service. Variable employees, defined as non-full-time or non-salaried employees, are eligible to participate in the Plan after they have completed one year of service. Entry dates into the Plan for eligible employees is on the first day of the month following the date requirements are met.

Eligible employees begin receiving Plan matching and profit sharing contributions, if any, after they have completed twelve consecutive months of employment during which they have a minimum of 1,000 hours of service and are employed by the Employer on the last day of the plan year.

#### Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers"). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make discretionary matching contributions as approved by the Employer's Board of Directors. In 2024 and 2023, the Employer matched 20% of participant deferrals up to 5% of each participating employee's compensation. Additional profit sharing amounts may also be contributed at the discretion of the Board of Directors. The Board of Directors did not approve any discretionary profit sharing contributions for 2024 and 2023.

### **Note 1: Description of Plan** (Continued)

#### **Funding**

The Employer remits participant contributions to the Plan as soon as practical after amounts are withheld from participant wages. Employer contributions, if any, are remitted annually, subsequent to the Plan's year end.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Employer matching contributions, and allocations of the Employer's profit sharing contribution and investment earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts plus actual earnings thereon is at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

A participant's accrued benefit is 100% vested upon a participant's death, total disability, or attainment of normal retirement age 60. Participants are credited with a year of vested service for completing 1,000 or more hours in the plan year.

#### **Investment Options**

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants may choose to direct their contributions and all of their account balances among the Plan's investment alternatives. All investments are participant directed.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at the market rate as determined at the time of the loan by the plan administrator. Principal and interest are paid ratably through payroll deductions.

### Note 1: Description of Plan (Continued)

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments for a period of time until the participant's account is exhausted. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000 (increased to \$7,000, effective January 1, 2024), the plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Employer's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,207 and \$6,490, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative expenses of the Plan in accordance with the plan document. Forfeitures used to reduce Employer contributions to the Plan were \$10 and \$13,662 for the years ended December 31, 2024 and 2023, respectively.

#### Contributions Payable

Contributions from participants for the 2025 plan year were received by the trust in 2024 in the amount of \$13,853. The amount has been recorded as a contribution payable on the Statement of Net Assets Available for Benefits at December 31, 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Expenses directly attributable to a participant's transaction are deducted from the participant's account. Certain expenses of maintaining the Plan are paid by the Plan, unless paid directly by the Sponsor and excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 19, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

### Note 4: Tax Status

The Plan adopted a nonstandard prototype document with an Internal Revenue Service notification letter, which states that the prototype plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 5: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at the NAV of units held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets of the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6: Party-in-Interest Transactions

Certain plan investments managed by the trustee and notes receivable from participants are party-in-interest transactions. These transactions are exempt from prohibited transaction rules of ERISA.

### Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Note 8: Information Prepared and Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income from notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.
