## Independent Auditor's Report

To the Participants and Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Epes Logistics Services 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

### ***Opinion***

### ***Basis for Opinion***

### 1. Description of Plan

The following description of the Epes Logistics Services 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Epes Logistics Services, Inc. (the “Company” or “Employer”). Employees are eligible to enter the Plan after 90 days of consecutive service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Eligible employees are automatically enrolled at a 4% deferral percentage, which will increase by increments of 1% each June 1<sup>st</sup> up to a maximum of 10% unless they elect an alternative percentage or decline participation. Participants may otherwise elect to defer up to 90% of their compensation as defined by the Plan. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company made a discretionary matching contribution of 50% up to 4% of participant compensation for 2024 and 2023. The Company may also make a discretionary profit sharing contribution to the Plan. Any profit sharing contribution is allocated to eligible participants based upon the percentage of each participant’s compensation to the total compensation of all eligible participants. No discretionary profit sharing contributions were made in 2024 and 2023. Contributions may not exceed limits set by the Internal Revenue Service (“IRS”).

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and Company’s contributions and allocations of (a) Plan’s net earnings and (b) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The portion of participants’ accounts attributable to employer contributions vests fully upon completion of three years of service. Participants’ accounts also become fully vested upon attainment of the normal retirement age of 65, in the event of death or total disability, or upon termination of the Plan.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are primarily up to five years or up to ten years for the purchase of a primary residence. Participants may only have one outstanding note at a time. The notes are secured by the vested account balance in the participant’s account and bear interest at the prime rate plus 1% at the date of the application. Principal and interest are paid ratably through payroll deductions.

### 1. Description of Plan (Concluded)

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum payment or installment payments. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

#### ***Forfeitures***

Forfeitures from non-vested participant accounts may be used to reduce plan expenses and future Company discretionary matching contributions. During 2024 and 2023, forfeitures of approximately \$12,000 and \$24,000 were used to reduce the Company's discretionary matching contributions. Available forfeited non-vested accounts were approximately \$2,000 and \$1,000 at December 31, 2024 and 2023.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as trustee and recordkeeping expenses, are permitted to be paid from the Plan's assets. Distribution and loan fees are paid from the affected participant's account.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts issued by Transamerica as described in Note 8.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through June 10, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company ("State Street"), the trustee of the Plan.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Tax Status

The Plan has adopted a prototype non-standardized plan document sponsored by Transamerica Retirement Solutions ("Transamerica"). The IRS had determined and informed Transamerica by a letter dated June 30, 2020, that the Plan and related trust was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Certain plan investments are managed by State Street and Transamerica, the respective trustee and recordkeeper of the Plan. Fees paid by the Plan to Transamerica for recordkeeping services totaled approximately \$18,000 and \$17,000 in 2024 and 2023.

Fees paid to MMA Securities for investment and other advisory services were approximately \$17,000 and \$14,000 in 2024 and 2023.

### 8. Guaranteed Investment Contract

The Guaranteed Investment Option is a group annuity product issued by Transamerica Life Insurance Co. ("TLIC"). The contract seeks to provide maximum return consistent with a guarantee of principal and interest backed by the financial strength of TLIC's general account. Generally, there are not any events that could limit the ability of the Plan to transact at contract value.

The Guaranteed Investment Option has a portfolio interest rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and there is no set maturity. The effective credited interest rate is set in accordance with contract provisions. The crediting rate under the contract was 2.65% and 2.25% at December 31, 2024 and 2023.

### 9. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer using the estimated fair value of the underlying assets held in the fund, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

### 9. Fair Value Measurements (Concluded)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
