We have performed audits of the accompanying financial statements of Profit Sharing Retirement Plan for Employees of RES and Kondex, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Profit Sharing Retirement Plan for Employees of RES and Kondex (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan is a defined contribution plan sponsored by DLSM, Inc. (DLSM or the Sponsor), which is the parent company of Kondex Corporation (Kondex). DLSM is under common ownership and in a controlled group with Res Manufacturing Company (RES). The eligible employees of Kondex and RES participate in the Plan. Fidelity Management Trust Company (Fidelity) is the trustee of the Plan's assets, executes investment transactions, and is the Plan recordkeeper.

Eligibility

Substantially all employees are eligible to participate in the Plan and receive Sponsor matching contributions after completing one month of service. Participants must complete one year of service and be employed on the last day of the year to be eligible to receive Sponsor discretionary contributions.

The Plan has an automatic enrollment feature for new employees. Auto enrollments start at 6% of eligible compensation and increases over time to 10%. Participants can stop or change their deferral rate at any time.

Contributions

Participants may contribute up to 90% of their compensation, as defined by the Plan, subject to the maximum contribution limits allowed by the Internal Revenue Code (IRC). The Plan also allows participants to "roll over" distributions from other qualified retirement plans.

The Sponsor makes nondiscretionary matching contributions equal to 25% of the participant's contributions, up to 4% of eligible compensation. Nondiscretionary matching contributions were \$215,086 in 2024.

RES and Kondex may each make discretionary contributions in amounts determined by each company's board of directors. Discretionary contributions made to the Plan by RES or Kondex are allocated to participants' accounts based upon the ratio that each participant's compensation bears to compensation of all eligible employees of RES or Kondex. Discretionary contributions were \$760,548 in 2024.

Funding

The Sponsor remits participant and Sponsor matching contributions to the Plan as soon as practical after the participant contributions have been withheld from the participant's wages. Sponsor discretionary contributions, if any, are remitted to the Plan on an annual basis.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Investment Options

Participants direct their contributions and Sponsor matching contributions into various investment options offered by the Plan. Sponsor discretionary contributions are invested in a portfolio of investments as directed by the Sponsor.

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor matching contributions, allocations of Sponsor discretionary contributions, forfeitures, Plan earnings (losses), and charged with an allocation of administrative expenses thereon. Allocations are based on participants' earnings (losses) or account balances, as defined by the Plan. The balance to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and Sponsor matching contributions, plus actual earnings (losses) thereon. Vesting in Sponsor discretionary contributions, plus actual earnings (losses) thereon, vest as follows:

Forfeitures

Forfeitures of RES's discretionary contributions are allocated to the accounts of RES participants and forfeitures of Kondex's discretionary contributions are allocated to the accounts of Kondex participants. At December 31, 2024 and 2023, unallocated forfeitures were \$71,283 and \$35,676, respectively. In 2024, forfeitures of \$71,773 were allocated to participant accounts.

Secure 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Note 1: Description of Plan (Continued)

Notes Receivable from Participants

Participants may receive a note from their account balance of a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their vested account balance. Notes are secured by the remaining balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or a designated beneficiary may elect to receive either a lump-sum payment equal to the value of the participant's vested interest in their account, or installment payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Participants may take hardship withdrawals of any portion of their account balance that is attributable to their participant contributions and earnings (losses) thereon.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the accompanying financial statements and notes. Actual results could differ from those estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expense (Credit)

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. The Plan received a credit of approximately \$60,000 of plan expenses in 2024 related to a pricing concession for prior year expenses. Expenses directly attributable to a participant's transaction are deducted from that participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Sponsor has evaluated subsequent events through August 27, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence in fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

There have been no changes to the methodologies used in 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3: Fair Value Measurements (Continued)

Common trust fund – stable value fund: Valued at the NAV as reported by the fund manager, based on the fair values of the underlying assets. The objective of the stable value fund is to seek the preservation of capital and provide a level of income over time that is consistent with the preservation of capital. Investments in the stable value fund can be purchased or sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

Common trust fund: Valued at the NAV of the shares held by the Plan at year end. The NAV's share price is quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market. Investments can be purchased or sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Nonparticipant-Directed Investments

Sponsor discretionary contributions are invested in accordance with the investment direction provided by the Plan trustee. Participant account balances, which are eligible to be diversified, but remain in the investments directed by the Plan trustee, cannot be separately determined and are reported as non-participant directed investments.

Note 5: Information Certified by Plan Trustee

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan. This information includes investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024.

Note 6: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 7: Income Tax Status

The Sponsor adopted a nonstandard prototype document with an Internal Revenue Service (IRS) notification letter, which states the prototype plan document is in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balances.

Note 9: Party-in-Interest Transactions

Plan investments managed by affiliates of Fidelity Management Trust Company, the Plan's trustee, and notes receivable from participants qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.
