INDEPENDENT AUDITORS' REPORT

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Avenue Logistics, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the



financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of the Avenue Logistics, LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Users of these financial statements should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Avenue Logistics, LLC (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). All eligible employees, as defined in the plan document, who have reached the age of 21, are eligible to participate in the Plan, after completion of defined periods of service (3 months for full-time employees, 12 months for part-time, temporary, and seasonal employees). Employees can enter the Plan on the first day of the month following attainment of the age and service requirements. Upon entering into the Plan, a participant may direct employer and employee contributions to any combination of various investment options.

As of January 1, 2023, the Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated investment fund until changed by the participant. One enrolled, the Plan does not have an automatic deferral rate increase provision, and participants may elect to increase or decrease percentages, as defined by the Plan.

Contributions – Participants may contribute up to 90% of their eligible pre-tax or after-tax (Roth) compensation, as defined in the plan document, up to the maximum annual dollar limit allowable by the Internal Revenue Service ("IRS"), which was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants may direct the investment of their contributions and the Company's contributions into one more investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Plan participants who are eligible to make salary deferrals and have attained age 50 by December 31 of a calendar year may make "catch-up" contributions in addition to regular salary deferrals for that year. Catch-up contributions are limited by the IRS to \$7,500 for each of the years ended December 31, 2024 and 2023.

The Company may make discretionary matching contributions equal to a percentage of eligible employees' elective contributions. During the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of 50% of each eligible participant's elective contribution, up to 5% of eligible compensation, with a maximum employer contribution of 25% of the participant's contribution deferral limit as determined by the IRS.

Participant Accounts - Each participant's account is credited with the participant's elective contributions, rollover contributions, an allocation of the Company's contributions, and Plan earnings or losses (net of administrative expenses). Allocations are based on the participant's

eligible compensation or account balance, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts - As of December 31, 2024 and 2023, the Plan held forfeited nonvested accounts totaling \$2,625 and \$0, respectively. These accounts can be used to pay administrative expenses and reduce future Company contributions. During the year ended December 31, 2024, \$2,110 of forfeited nonvested accounts were used to reduce Company contributions.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance from their fund accounts, whichever is less. The loans are secured by the balance in the participant's account, and bear interest at the quarterly prime interest rate, plus 1%. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years, unless the loan is used for the purchase of a primary residence, in which case a longer term may be granted that does not exceed thirty years.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan.

Administrative Expenses – Certain administrative operating expenses of the Plan are paid by the Company, as provided in the plan agreement.

Vesting - Participants are immediately vested in their salary reduction and rollover contributions, plus earnings thereon. Company discretionary matching contributions and earnings thereon vest in accordance with provisions of the plan document as follows:

Participants who leave the Plan because of death, normal retirement, or total and permanent disability, as defined in the Plan, are considered 100% vested. In addition, any employee hired on or before December 31, 2022 is considered 100% vested.

Payment of Benefits - Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the plan document.

The Plan provides for normal retirement at age 59 ½. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or rollover to an individual retirement account or another qualified retirement plan. Once a participant reached the age

59½, in-service distributions are allowed. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan document.

Benefits are recorded when paid. No amounts were allocated to accounts of persons who have elected to withdraw from the Plan but were not yet paid as of December 31, 2024 and 2023.

Plan Termination – Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates - The preparation of the financial statements in conformity with U.S. GAAP requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition - The Plan's investments are generally stated at their fair values with the exception of the Lincoln Stable Value Account (a group annuity contract), which is stated at contract value in the statements of net assets available for benefits at December 31, 2024 and 2023. The mutual funds are stated at fair value based upon quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties - The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Subsequent Events - The Plan has evaluated subsequent events occurring through August 27, 2025, the date that the financial statements were available to be issued, for events requiring recording or disclosure in the Plan's financial statements.

3. PARTIES-IN-INTEREST

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and transactions with investment funds managed and held by the trustees are considered party-in-interest transactions. Certain fees paid by the Plan to Lincoln Financial Group Trust Company ("Lincoln") for investment management and recordkeeping services are included in net appreciation in fair value of investment, rather than a direct payment.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820 ("ASC 820") defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities they are required to be recorded at their fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy which requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The standard establishes three levels of inputs that may be used to measure fair value:

- Level 1 - quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The Plan's valuation methodology used to measure the fair values of mutual funds were derived from quoted market prices as all of these instruments have active markets.

The plan sponsor is responsible for the determination of fair value. Accordingly, they perform periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services.

5. GROUP ANNUITY CONTRACT

The Plan has a fully benefit responsive group annuity contract with Lincoln, called the Lincoln Stable Value Account. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) layoffs, (3) Plan termination, (4) bankruptcy, (5) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value. The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan.

6. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, the trustee have certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Notes receivable from participants, as shown in the statement of net assets available for benefits as of December 31, 2024.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i – Schedule of Assets (Held at End of Year) – December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. TAX STATUS

The IRS ruled on June 30, 2020 that the Prototype Non-Standardized Profit Sharing Plan with CODA (the Volume Submitter of Lincoln, upon which the Plan is based), as then designed, qualified under Section 401(a) of the Internal Revenue Code (“IRC”) and the related trust was, therefore, not subject to tax under present income tax law. The Plan has not requested its own determination letter from the IRS. The plan has been amended since the previous IRS ruling; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. EXCESS CONTRIBUTIONS PAYABLE

The Plan is required to perform certain non-discrimination testing each year. Testing failures may result in refunds of contributions to certain participants. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding decrease to employee contributions. The Plan had excess contributions payable of \$28,107 and \$79,387 as of December 31, 2024 and 2023, respectively. Amounts were refunded in a timely manner to participants in the subsequent plan year.
