Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the S. Clyde Weaver, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C)(ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of S. Basis for Opinion

Notes to Financial Statements

Note 1 – Plan Description

The following description of the S. Clyde Weaver, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees of S. Clyde Weaver, Inc. (the “Company”) who have completed 1,000 or more hours of service in a 12-consecutive month period, who have attained the age of twenty-one, and who are not covered by a collective bargaining agreement. Effective October 1, 2023, the Plan was amended. Significant amendments include eliminating automatic enrollment, eliminating in-plan Roth rollovers, and permitting in-plan Roth transfers only from fully vested accounts.

Contributions – Each year, participants may contribute up to the maximum limits of the Internal Revenue Code, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may, at its discretion, decide to match participant contributions to the Plan. A matching contribution equal to 50% of each participant's contribution up to a maximum of 3% of a participant's compensation can be made for which a 401(k) elective deferral has been made. Also, the employer may make a qualified non-elective contribution that is sufficient to satisfy certain required regulations. There were no qualified non-elective contributions for the years ended December 31, 2024 and 2023.

Participant Accounts – Each participant's account is credited with the participant's deferred compensation and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in discretionary employer contributions plus actual earnings thereon based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits – Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his or her account. Automatic distributions will be made to terminated participants with vested balances less than \$1,000. If a participant's vested balance is in excess of \$1,000 but less than \$5,000, the third-party administrator will rollover the distribution into an individual retirement plan (IRA) absent a distribution direction from the participant. If a terminated participant's vested balance exceeds \$5,000, a written request from the participant is required before distribution. Hardship withdrawals are permitted from participants' pre-tax and Roth elective deferral accounts.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,531 and \$5,405, respectively. Forfeitures may be used by the Plan to pay any administrative expenses of the Plan or used to reduce employer contributions. There were no forfeitures used to pay Plan expenses for the years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, forfeitures used to reduce employer contributions were \$8,034 and \$7,121, respectively.

Note 2 – Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's Trustee. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. The money market fund is valued at the quoted redemption price at year end. The guaranteed option account is valued at contract value, which approximates fair value. The pooled separate accounts are valued at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative expenses will be paid by the Plan unless paid by the Company. Certain administrative expenses associated with the Plan were paid by the Plan.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through August 27, 2025 which is the date the financial statements were available to be issued.

Note 3 – New Accounting Standards

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

Note 4 – Investments

The Plan's investments were held in a trust fund administered by Principal Trust Company.

During the years ended December 31, 2024 and 2023, the Plan's investments in mutual funds (including gains and losses on investments bought, sold, and held during the year) appreciated in value by \$527,182 and \$619,583, respectively. The Plan's investments in pooled separate accounts appreciated in value by \$99,746 and \$205,847 during the years ended December 31, 2024 and 2023, respectively. The Plan's fund in the guaranteed option appreciated in value by \$29,017 and \$31,129 during the years ended December 31, 2024 and 2023, respectively.

Note 5 – Fair Value Measurements

Generally accepted accounting principles have an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 5 – Fair Value Measurements – Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices, which represent the net asset value (“NAV”) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) This class invests primarily in fixed income securities. The class's objective is to provide current income. Investments in this class can be redeemed daily at the current net asset value per unit based on the fair value of the underlying investments. The fair value of the investments in this class has been estimated using the net asset value per unit of the underlying investments. There are no unfunded commitments and no redemption period notice required.

(b) This class invests in equity securities of large, medium and small market capitalizations whose potential for growth and earnings is expected to be above average. The class's objective is long-term capital appreciation. Investments in this class can be redeemed daily at the current net asset value per unit based on the fair value of the underlying investments. The fair value of the investments in this class has been estimated using the net asset value per unit of the underlying investments. There are no unfunded commitments and no redemption period notice required.

Note 6 – Investment Contract with Insurance Company

In March 2021, the Plan entered into a group annuity contract with an insurance carrier. The contract, which is included in the Guaranteed Option Account, is fully benefit-responsive and has no stated maturity date. A fully benefit-responsive contract provides for a stated return on principal invested over a specified period and permits withdrawals at contract value for benefit payments or transfers. Contract value represents contributions made under the contract, plus interest at the crediting rate, less plan withdrawals, and administrative expenses. The average crediting rate for the years ended December 31, 2024 and 2023 was 5.50% and 4.70%, respectively. Investment contracts held by a defined contribution plan are required to be reported at fair value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to a fully benefit-responsive investment contract. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Accordingly, the fully benefit-responsive group annuity contract is included in the financial statements at contract value, which approximates fair value.

Note 7 – Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination or partial Plan termination, affected participants will become 100 percent vested in their accounts.

Note 8 – Party-In-Interest Transactions

The Plan had certain investments managed by affiliated Principal Trust Company. The value of these investments totaled \$2,826,021 and \$3,065,145 at December 31, 2024 and 2023, respectively.

Principal Trust Company, the trustee of the Plan, provided record keeping services to the Plan. Fees paid by the Plan for these services amounted to \$22,198 and \$20,683 for the years ended December 31, 2024 and 2023, respectively.

Note 9 – Tax Status

The Company adopted a non-standardized volume submitter 401(k) Plan, which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. The opinion letter stated that the Prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11 – Risk and Uncertainties

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
