**Opinion**

We have audited the accompanying financial statements of DE Corp. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of DE Corp. Employee Stock Ownership Plan as of December 31, 2024, and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Uncertainty**

As discussed in Note 7 to the financial statements, the Plan sponsor's common stock totaling \$42,797,914 as of December 31, 2023, has been valued by an independent appraisal firm in the absence of readily ascertainable market values. In 2024, we reviewed the procedures used in

arriving at the estimate of value of such securities and have inspected underlying documentation, and under the circumstances, we believe the procedures were reasonable and the documentation was appropriate. The Company stock was sold on March 11, 2024 and the proceeds were placed in a money market account that is held by the Plan trustee. The amount received for the sale was higher than the amount determined by the appraisal firm, by approximately \$1.25 million.

**Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including their form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1—DESCRIPTION OF THE PLAN**

The following brief description of the DE Corp. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

Prior to the election to terminate, the Plan was a defined contribution plan provided for all eligible employees of Engineering Holding Corporation and its wholly-owned subsidiary, DE Corp. (formerly Dannenbaum Engineering Corporation) (collectively “the Company,” “Employer,” and “Plan Administrator”). Participation was available for all employees who were at least 21 years of age and who had completed 1,000 hours of service. Employer contributions to the Plan were determined by the Company, not exceeding the lesser of 100% of each participant’s total annual compensation or the amount allowed under Section 415(c)(1)(A) of the Internal Revenue Code (IRC). The employer contributions could have been made in cash, Company stock, or a combination thereof. The Plan did not receive a contribution for the 2024 fiscal year; however, the 2023 employer contribution of \$500,000 was made in early 2024.

As authorized by the Plan document, the DE Corp. board of directors voted to terminate the Plan effective March 11, 2024. At this time, the Plan was converted to a profit-sharing plan with all participants becoming 100% vested in their accounts. The Plan will be considered terminated when all the assets are distributed to participants.

Until the date of conversion to a profit-sharing plan, two accounts were maintained for each participant. One account was invested entirely in Company common stock and the other in investments other than Company common stock. At the end of the plan year, earnings and losses of the Plan were allocated to participants’ accounts proportionately based on participants account balances at the beginning of the year. Employee contributions and forfeitures of terminated participants’ non-vested accounts, if any, were allocated at the end of the plan year to active participants’ accounts proportionately based on annual compensation. At the date of conversion of the Plan, all the Company shares were sold, and the proceeds from the sale were transferred to a newly created trust (DE Corp. Employee Stock Ownership Trust) “the Trust”, or “the ESOT”, which is administered by TI-Trust. All original participants of the Plan became participants of the Trust.

Robert D. Roten and Christopher Sallese (collectively “the Trustees”) were the trustees of the Plan as of December 31, 2023. TI-Trust replaced Robert Roten on January 2, 2024. TI-Trust holds and administers the assets of the Trust for the exclusive benefits of the participants of the Trust. TI-Trust invested the Trust assets in money market funds to protect the value of the assets for the benefit of the participants.

Prior to the Plan conversion, distributions could be made to participants or their beneficiaries upon reaching age 65, disability, death, or termination of employment. Also, participants who had attained age 55 and completed ten years of participation were offered the right to elect a diversification distribution of their Company common stock account, as defined. The Plan document was amended in February 2023 allowing distributions to be made in cash or, if a participant elected, in the form of Company common stock plus cash for any fractional share. The participants' distributable account balances were calculated based upon the fair value on the last day of the previous plan year for Company common stock and at current value for all other investments. However, if the articles of incorporation or bylaws of the Company were amended to provide that substantially all of the stock of the Company must be held by current employees of the Company, then the distribution would be entirely in the form of cash. Upon withdrawal from the Plan, participants might be subject to income tax on distributions.

As of December 31, 2023, the Plan owned 224,343 shares of Engineering Holding Corporation's common stock, representing approximately 78.2% of the outstanding shares. As mentioned earlier, the EHC shares were sold during the first quarter of 2024 at an estimated price of \$196.33 per share. The sale's price is about 3% above the December 31, 2023 valuation price.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Date of Management's Review**

Management has evaluated subsequent events through August 20, 2025, the date on which the financial statements were available to be issued.

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect reported amounts of net assets, liabilities and changes therein and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Payment of Benefits**

Benefits paid to participants or beneficiaries are recorded when paid.

**Investment Valuation and Income Recognition**

Investments of the Plan, or the Trust, are reflected at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date, and interest income is recorded on an accrual basis. Net appreciation or depreciation in the fair value of investments includes realized gains and losses on investments sold during the year, as well as appreciation or depreciation of the investments held at the end of the year.

**Administrative Expenses**

Administrative expenses may be paid by the Company or by the Trust. For the year ended December 31, 2024, substantially all expenses were paid by the Trust. Administrative expenses of the Trust typically consist of legal fees, audit fees, fees related to obtaining the annual valuation and participant account allocation, and fees paid to the Trustees.

**Forfeitures**

Plan forfeitures are allocated to each participant's account based upon the relationship of the participant's eligible compensation to total eligible compensation for the plan year. Forfeitures allocated to participants for the plan year ended December 31, 2023 totaled \$530,267. There were no forfeitures during 2024 as all participants became 100% vested upon conversion of the Plan. There were no unallocated forfeitures as of December 31, 2023.

**Risks and Uncertainties**

Prior to the liquidation of the Plan assets, the Plan provided for investment in the Company's common stock, other marketable securities, partnerships and interest-bearing cash. The Plan's performance was impacted by the market volatility of the marketable securities investments. Due to the level of risk associated with investment securities, it was reasonably possible that changes in the value of investments could occur in the near term and that such changes could affect participants' account balances and the amounts reported in the financial statements. Upon the conversion of the Plan and the sale of the Company stock on March 11, 2024, substantially all of the Trust assets were invested in money market or interest-bearing cash accounts.

**NOTE 3—FEDERAL INCOME TAX STATUS**

Plan termination requires approval from the IRS before implementing initial termination steps. Therefore, the Company timely obtained a letter of determination from the IRS (See Note 8). The Company believes that the Plan was qualified and the related trust was tax exempt as of December 31, 2024, and 2023. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**NOTE 4—CONCENTRATIONS**

The Plan's investments in the Company common stock made up approximately 94% of the Plan's net assets available for benefits as of December 31, 2023. The Company common stock was sold in March 2024, and as of December 31, 2024 approximately 99% of the Trust's net assets were invested in either money market or interest-bearing cash accounts.

Both the Plan and the Trust hold their cash in high credit institutions. Balances as of December 31, 2024 exceeded the FDIC insurance limits but did not exceed the FDIC insurance limits as of December 31, 2023.

**NOTE 5—PARTY-IN-INTEREST TRANSACTIONS**

Prior to the Plan conversion, the Plan provided for investment in Company common stock. The Company qualifies as a party-in-interest (party that is prohibited from doing business with the plan). These transactions with the party-in-interest are covered by an exemption from the "prohibited transactions" provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the IRC.

**NOTE 6—PLAN TERMINATION**

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company terminated the Plan as of March 11, 2024, and participants became fully vested in their accounts. The assets of the Plan were transferred to the Trust as noted in Note 1.

**NOTE 7—FAIR VALUE MEASUREMENTS**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2023. No appraisal was necessary as of December 31, 2024.

*Engineering Holding Corporation common stock:* This investment was valued using an independent appraisal. The appraisal assigned a value based upon a weighted average of two approaches: (1) the market approach and (2) the income approach. The weighted average is added to the value of the non-operating assets and reduced by a discount for lack of marketability and illiquidity. The market approach consists of valuing the Company by reference to the results of comparable businesses or business interests. The income approach assigns value based upon the capitalized cash flow method. Significant unobservable input used in the valuation include

the financial results of the Company, discount rates, comparable businesses, valuation multiples and discounts for lack of marketability and illiquidity.

*Interest-bearing cash and mutual funds:* These funds are valued daily based on quoted market prices.

*Stocks:* These investments are valued at the closing price reported by the active market in which the individual securities are traded.

*Money Market Funds:* These investments are valued daily based on known exchange or established markets.

**NOTE 8—SUBSEQUENT EVENT**

The Plan's step for termination outlined the distribution of 80% of account balances as soon as practicable following the Plan termination date. Between January and May 2025, distributions were made in the amount of \$32,516,191. The Company will follow ERISA rules regarding any participant account that has not been distributed.

The plan obtained its latest determination letter on July 10, 2025, in which the Internal Revenue Service stated that the Plan, as amended on June 5, 2023, was in compliance with the applicable requirements of the IRC. The IRS also stated that the determination applies to the conversion of the Plan as of March 11, 2024.

As part of finalizing the sale of EHC stock the Plan received an additional \$1,453,895 in January 2025.
