Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Crush City Construction 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Auditors' Responsibilities for the Audit of the Financial Statements (Continued)

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Crush City Construction 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Crush City Construction 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Crush City Construction 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Merger and Subsequent Transfer

On November 15, 2024, the Plan adopted and was merged with the Save for Your Future Retirement Plan PEP sponsored by Standard Retirement Services, Inc. Legal responsibility of the assets and all activity after that date were the responsibility of the Save for Your Future Retirement Plan PEP Plan. Plan assets were transferred from Empower as of November 18, 2024, as certified by Empower. These assets were received by Standard Retirement Services, Inc., the new plan recordkeeper, November 19, 2024.

Plan period end is November 15, 2024, based on this being the adoption date of the new plan. Net assets available for benefits for the Crush City Construction 401(K) Plan have been reported at zero as of November 15, 2024, as the legal responsibility for these assets was transferred to the new plan on that date.

General

The Plan was a defined contribution plan covering substantially all employees of Crush City Construction, Inc., Leafguard of Cincinnati, and Leafguard of West Michigan (the Companies) who were age 18 or older and had completed six months of service. Collective bargaining employees and nonresident workers were not eligible to participate in the Plan. Employees were eligible to make salary deferrals and receive QACA safe harbor contributions after six months of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees was responsible for oversight of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions

Each year participants were able to contribute up to 100% of eligible compensation, as defined in the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds and collective trust funds as investment options for participants. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of eligible compensation. These contributions were increased by 1% annually until they were at 6%. Contributions were automatically invested in a designated balanced fund until changed by the participant. The Plan was considered a QACA Safe Harbor 401(k) Plan, and the contribution each year had to be 100% of the first 1% of base compensation and then 50% up to 6% of base compensation that the participant contributed to the Plan (3.5% of compensation total). Additional profit sharing amounts could be contributed at the option of the Companies' Board of Directors. No profit sharing contributions were made in the current period. Contributions were subject to statutory limitations.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account was credited with the participant's contributions and the Companies' matching contributions, as well as allocations of the Companies profit sharing contribution (when applicable) and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled to the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Companies' contribution portion of their accounts was based on years of continuous service. A participant was 100% vested in their safe harbor contributions after two years and fully vested in all other Company contributions after six years.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at rates ranging from 4.25% to 9.50%, which were set at 1% above the prime rate. Principal and interest were paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At November 15, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$10,249, respectively. These accounts could be used to reduce the Plan's administrative expenses and then to reduce future employer contributions. During the period ending November 15, 2024, employer contributions were reduced by \$16,970 from forfeited nonvested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Contributions Received and Receivable

Contributions from the Plan participants and the Company were recorded in the period in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of November 15, 2024 and December 31, 2023. If a participant did not make loan repayments and the Plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses maintaining the Plan were paid by the Plan unless otherwise paid by the Companies. Expenses that were paid by the Companies were excluded from these financial statements. Fees related to administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in the net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 18, 2025, the date the financial statements were available to be issued. Except as discussed in Note 1, there were no subsequent events that required recognition or disclosure in the financial statements.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at November 15, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the period ended November 15, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments were reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The investment committee determined the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Observable inputs such as unadjusted quoted prices in active markets.

Level 2 - Inputs, other than quoted prices in active markets, which are observable either directly or indirectly; and,

Level 3 - Unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets that are measured at Net Asset Value (NAV) as the practical expedient to estimate fair value and are aggregated in the fair value hierarchy are as follows:

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practicable expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at November 15, 2024, and December 31, 2023.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the period ended November 15, 2024, are reported in net appreciation in fair value of investments.

The Plan's policy was to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the period ended November 15, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Fees incurred by the Plan for the investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing, rather than direct payment. As described in Note 2, the Plan made a direct payment to the custodian of \$88,692 which was not covered by revenue sharing. The Plan Sponsor paid directly any other fees related to the Plan's operations.

These party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

NOTE 6 - TAX STATUS

The Plan used a Volume Submitter Profit Sharing Plan document sponsored by Empower Trust Company, LLC. Empower Trust Company, LLC received an advisory letter from the Internal Revenue Service (IRS), dated November 14, 2022, which states that the volume submitter document Plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself did not receive a determination letter from the IRS. The Plan document was amended since receiving the advisory letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan was qualified, and the related trust was tax-exempt.

NOTE 6 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of November 15, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
