Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Trustmark Services Company Investment and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Note 1 - Description of the Plan

The following description of Trustmark Services Company Investment and Savings Plan (the "Plan") is provided for general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan of Trustmark Services Company (the "Company") and is subject to, and is designed to comply with, the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, applicable to defined contribution profit-sharing plans.

Eligibility and Participants

Eligibility in the Plan is available to almost all employees of the Company upon hire. Plan participants who transfer to a sister company have their participant accounts transferred to the plan of the sister company.

Contributions

Participant contributions are made by means of regular payroll deductions. Participants can contribute up to 75 percent of their eligible compensation on a pretax or Roth after-tax basis. Participants who are 50 years of age or older who are contributing at the Plan's maximum or who are scheduled to reach the annual Internal Revenue Service (IRS) contribution limit are eligible for total deferrals of up to 85 percent between the non-catch-up and catch-up deferrals. Participant contributions are limited to the maximum amount allowed by the Internal Revenue Code (the "Code"), and, for highly compensated employees, contributions may be limited by the Plan.

The Company has elected to match an amount not in excess of 6 percent of the participants' eligible compensation on a dollar-for-dollar basis. The benefits committee has the ability to change the percentage contribution matched on an annual basis.

The Company may also make discretionary retirement contributions. No discretionary retirement contributions were approved for 2024.

Participants who were participating in the Employees' Retirement Plan and Trust as of December 31, 2004 are eligible to receive a special company retirement contribution (the "Special Contribution"). The Special Contribution is 10 to 13 percent of the participant's eligible compensation based on the participant's age. Additionally, the Company may elect to match an amount not in excess of 4 percent of the participant's eligible compensation on a dollar-for-dollar basis in addition to the Special Contribution. The Special Contribution totaled approximately \$38,000 for the year ended December 31, 2024.

Participant Accounts and Vesting

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's and the Company's contributions and an allocation of the Plan's earnings, losses, and administration expenses and charged with withdrawals. Investment earnings are allocated daily based on participant account balances. Participants may direct the investment of their contributions into various investment options offered by the Plan.

Note 1 - Description of the Plan (Continued)

Participants are fully vested in their contributions and rollovers plus actual earnings thereon. A participant is fully vested upon reaching normal retirement age, death, or permanent disability. Effective January 1, 2023, participants become 100 percent vested in the remainder of their account balances graduated over two years of plan service. The following table summarizes the Plan's vesting schedule for company contributions:

Participants who transfer in from a sister company plan maintain the vesting schedule for any match made under the prior plan. For any match received under the new plan, the new plan's vesting schedule will apply.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balances or \$50,000. The loans are secured by an assignment of a participant's vested interest in the Plan and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed determined by the plan administrator. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence.

Benefit Payments

Upon termination of service with the Company, participants may elect to receive the value of their vested account interest. Benefit payments may be paid in a lump sum or in partial or installment payments. Minimum required distributions can be made in installment payments. Participant account balances of less than \$1,000 must be paid out in one lump sum after termination. Participant account balances between \$1,000 and \$5,000 will be rolled over into a Fidelity Management Trust Company individual retirement account (IRA). Participants may withdraw their vested contributions prior to termination of service in the event of hardship, as defined by the Plan.

Forfeited Accounts

Upon termination of employment, participants forfeit their nonvested balances. If a participant is rehired within a five-year period, the forfeited contributions may be reinstated. Forfeitures may be used for the following purposes: reinstating previously forfeited account balances of former participants, reducing future company contributions, paying plan expenses, making restorative payments to former participants, or reducing any additional amounts for which the Company is responsible under the Plan. During the year ended December 31, 2024, forfeitures totaling \$44,838 were used to reduce the Company's contributions. At December 31, 2024 and 2023, the amount of forfeitures that were not allocated was \$10,732 and \$33,158, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become 100 percent vested in their accounts, and the net assets of the Plan will be distributed to participants in an order of priority determined in accordance with ERISA and its regulations and with the plan document.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investments. Investments, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded as earned. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on the trade date.

Transfers

Net transfers in/out in the statement of changes in net assets available for benefits is used when an employee is transferred to/from the Plan from/to the plan of a sister company. At this time, the employee ends eligibility in the former sister company's 401(k) plan and starts eligibility in the Plan or vice versa. Employees of sister companies who transfer to the Company have their participant accounts added to the Plan and retain their previous plan's eligibility and their vesting. Plan participants who transfer to a sister company have their participant accounts transferred to the plan of the sister company. Each participant's prior vesting credit is recognized, and the participant is allowed to continue to earn vesting credit on prior contributions. During 2024, net transfers out equaled \$77,985.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain administrative expenses of the Plan are paid by the plan sponsor, as provided in the plan document. All investment management and transaction fees directly related to the plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 15, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following is a description of the valuation methodologies used for major categories of assets measured at fair value by the Plan:

Self-directed Brokerage Accounts

Self-directed brokerage accounts invest primarily in common stocks and mutual funds. The common stocks and mutual funds are valued at closing quoted market prices in active markets.

Mutual Funds

Mutual funds are valued at closing quoted market prices in active markets.

Common Collective Trusts

Common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets.

Note 4 - Common Collective Trust Stable Value Fund

The Plan holds the Fidelity Managed Income Portfolio II (the "Fund"), a common collective trust stable value fund. The Fund has certain limitations on withdrawals and exchanges as follows:

Participant-directed withdrawals made in order to accommodate distributions to participants or transfers to noncompeting investments may be made on any business day. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur.

There are no unfunded commitments or other redemption notice requirements related to the Fund.

Note 5 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances within the statement of net assets available for benefits and supplemental schedule of assets held at end of year, as well as the investment income and interest income on notes receivable from participant amounts included in the statement of changes in net assets available for benefits, are based solely on information certified by the Trustee.

Note 6 - Exempt Party-in-interest Transactions

Certain plan assets are in investment funds managed by the Trustee or its affiliates. The Trustee is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines, but they are exempt from the prohibited transactions rules under ERISA.

Note 7 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.
