Note 1 - Plan Description

The following brief description of the Kobelco Construction Machinery USA, Inc. 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Kobelco Construction Machinery USA, Inc. (the Company and the plan administrator), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Company on January 1, 2013 and has since been amended and restated. Empower Trust Company, LLC serves as the asset custodian of the Plan's mutual funds and notes receivable from participants. Empower Annuity Insurance Company of America serves as the asset custodian of the Plan's guaranteed investment contract.

Eligibility

Participation in the Plan is available for all employees, as defined, who are at least 18 years of age. Employees must also complete three months of service to be eligible to participate in the Plan. The Plan includes a savings feature designed to permit the employee and the Company to contribute to the Plan at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC).

Contributions

An eligible employee may participate in the Plan by electing to contribute a portion of their compensation, as defined, subject to the maximum limits allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans and certain other qualified sources as defined in the plan document.

Prior to July 1, 2024, eligible employees automatically began deferring at 3% of their compensation, unless an affirmative election not to contribute or to contribute at a different percentage was made by the employee. Effective July 1, 2024, the plan was amended to increase the percentage at which eligible employees automatically begin deferring, from 3% to 5% of their compensation, unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee. The contributions are made on a pre-tax basis unless the employee affirmatively designates that any portion or all of the contributions be treated as Roth contributions.

The Plan may contribute a discretionary matching contribution equal to a uniform percentage of each such participant's elective deferral. The amount is determined each year at the discretion of the Company. For the year ended December 31, 2024, the Plan made discretionary matching contributions equal to 100% of the participant's contribution not to exceed a 5% deferral of the participant's eligible compensation on a payroll-by-payroll basis.

Vesting and Forfeitures

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions is based on years of service. A participant's interest in Company contributions begins vesting at 20% after two years of service and increases 20% for each additional year of service until the employee is 100% vested after six years. Participants become fully vested upon death, disability, reaching normal retirement age of 65 or upon the declaration of a partial or complete plan termination.

Forfeitures are used to reduce employer contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, the forfeiture balance was \$45,260 and \$23,844, respectively. For the year ended December 31, 2024, forfeitures in the amount of \$9,385 were used to pay plan expenses.

Participant Accounts

Upon enrollment in the Plan, a participant may direct the investment of their accounts into various investment options offered by the Plan. Participants may change their investment options daily.

Under the Plan, earnings and losses are allocated to the participants' accounts daily according to an allocation formula provided in the plan document.

Notes Receivable from Participants

Notes receivable from participants are loans to participants secured by the vested portion of their accounts as prescribed in the plan document. Interest rates are based on the prime rate plus 1% on the date of issuance. The loans are repaid through payroll deductions. Prior to February 26, 2024, participants were allowed to have one loan outstanding at a time. Effective February 26, 2024, the Plan was amended to allow participants to have two loans outstanding at a time. Loans issued are no less than \$1,000, with a maximum value limited to the lesser of \$50,000, reduced by the highest outstanding loan balance during the preceding 12 months, or one-half of the participant's vested balance. Loan terms are limited to five years unless for the purchase of a principal residence, which may be repaid within a period of up to 30 years.

Benefit Payments

Distributions may be made to participants or their beneficiaries upon termination of employment, retirement, disability or death or for certain other reasons as defined in the plan document. Upon termination, participants with an account balance of \$1,000 or less shall receive an automatic lump sum distribution from the Plan. For participants who terminate with an account balance of more than \$1,000 but less than \$7,000, the plan administrator shall make a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to income taxes on contributions and income earned.

Note 2 - Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of the investments includes realized gains and losses on investments bought and sold during the year, as well as unrealized gains or losses on the investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023 as the notes are collateralized by the respective participant account balance. In general, notes receivable from participants are placed into default in the calendar quarter following the quarter in which no payment on the note is made, and such defaults are recognized as distributions based upon the terms of the plan document when a distributable event has occurred.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Benefit Payments

Benefits paid to participants or beneficiaries are recorded when paid.

Administrative Expenses

Administrative expenses not paid by the Company, at its discretion, are paid by the Plan.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were available to be issued. See Note 9.

Note 3 - Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Empower Trust Company, LLC and Empower Annuity Insurance Company of America as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and the accompanying notes to the financial statements as to investments, notes receivable from participants, investment income, interest income on notes receivable from participants, and all of the related information in the supplemental schedule of assets (held at end of year) is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying footnotes and the supplemental schedule of assets (held at end of year)..

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds: These funds are valued daily at their quoted market prices.

Note 5 - Guaranteed Investment Contract with Empower Annuity Insurance Company of America

The Plan has a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America, the Guaranteed Interest Fund. Empower Annuity Insurance Company of America maintains the contributions in an unallocated contract account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, the Guaranteed Interest Fund is a fully benefit-responsive investment contract that is reported at contract value. Contract value represents deposits made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.5%. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value. Such events include certain plan sponsor-initiated events, which require at least 30 calendar days advance notice and termination of the contract by the plan sponsor for any reason other than full plan termination, which requires at least 60 days advance notice. The plan sponsor cannot offer competing funds unless agreed upon by Empower Annuity Insurance Company of America and the plan sponsor. In order to discourage excessive trading, participant transfers may be restricted for up to 30 days in the event of excessive participant trading. Plan management does not believe the occurrence of any events that would limit the Plan's ability to transact at contract value with participants are probable.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Federal Income Tax

The pre-approved plan document adopted by the Plan received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan document was in compliance with the applicable requirements of the IRC. The pre-approved plan document has been amended since receiving its IRS letter; however, the plan administrator, through its adoption of the pre-approved plan document, believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Party-in-Interest Transactions

The guaranteed investment contract is with Empower Annuity Insurance Company of America and, therefore, transactions relating to this investment qualify as party-in-interest transactions. These transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the IRC.

Note 9 - Subsequent Events

Effective March 1, 2025, the Plan was amended to increase the percentage at which eligible employees automatically begin deferring from 5% to 6% of their compensation, unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee. Concurrently, the Plan was amended to change the eligibility service requirement from three months to 30 days of service.
