**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of **Utica First Insurance Company Employees Retirement and Savings Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **Utica First Insurance Company Employees Retirement and Savings Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Utica First Insurance Company Employees Retirement and Savings Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of *Utica First Insurance Company Employees Retirement and Savings Plan* (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement savings plan, covering employees of Utica First Insurance Company (Plan Sponsor) who have attained the age eighteen (twenty-one for 2023), completed 90 days of service, and elected to participate. An employee is eligible for a company matching contribution only if a pre-tax or post-tax (Roth elective) employee contribution is made. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a percentage of eligible pay on a pre-tax basis or post-tax basis every pay period, not to exceed the IRS limits (\$23,000 for 2024 and \$22,500 for 2023) with an additional catch-up contribution of \$7,500 for employees 50 years of age or over for 2024 and 2023 plan years. Participants have the option of contributing on a post-tax basis (Roth elective deferrals). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation, increasing by 1% annually to a maximum of 10%. Participant rollover contributions are permitted by the Plan. A discretionary matching contribution based on the percentage of the participants' pre-tax and post-tax contribution is to be determined annually by the Company. There were discretionary matching contributions made in the 2024 and 2023 plan years of approximately \$182,000 and \$180,000 respectively. For 2024 and 2023, the Company provides a 50% match on employee contributions up to 4% of salary. Matching contributions are made each pay period that a contribution is made.

In addition, the Plan Sponsor may make a discretionary contribution in an amount to be determined by the Plan Sponsor's Board of Directors. Discretionary contributions will be allocated in the ratio that eligible compensation bears to the total compensation paid to all eligible participants. There were discretionary contributions made in the 2024 and 2023 plan years of approximately \$651,000 and \$577,000, respectively. Contributions are subject to certain limitations set by the Internal Revenue Code.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

Participants' Accounts

Each participant's account is credited or charged with the participant's contributions, the Plan Sponsor's matching contribution, an allocation of the Plan Sponsor's profit-sharing contribution and Plan earnings and losses and administrative fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All funds are participant-directed unless otherwise noted.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service. Employer matching contributions and earnings are vested at the rate of 20% per year commencing after the first year of service. A participant is 100% vested after six years of service or upon reaching the normal retirement age of 65.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions to any of the available investment options sponsored by the Plan. Participants may change their investment options at any time thereafter. The Plan provides twenty-three investment options to the Plan participants.

Payment of Benefits

Plan benefits are paid upon the normal retirement age of 65, late retirement, death, disability, or other employment termination. Participants may elect a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments for various periods or joint and survivor benefit for married participants. In-service distributions are allowed in the event of financial hardships. The Plan is required to withhold any applicable federal income taxes if distributions are made before the participant reaches the age of 59 ½.

Plan Administrative Expenses

The administrative expenses of the Plan, if not paid by the Plan Sponsor, are paid from the remaining participants' account balances on a pro-rata basis or in such other reasonable manner as directed by the Plan Sponsor.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

Forfeitures

Forfeitures of non-vested contributions are retained in the Plan and may be used to reduce future employer contributions. The forfeited employer's contribution, including earnings on such forfeitures, amounted to \$38,155 and \$22,244 for the Plan years ended December 31, 2024 and 2023, respectively. Forfeited funds used to cover discretionary matching contributions amounted to \$27,146 and \$4,936 during the years ended December 31, 2024 and 2023, respectively.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles of the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes, disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value as dictated by quoted market prices and have been certified by Principal Trust Company (the "Custodian").

Purchases and sales of investments are accounted for on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recorded on the accrual basis. Realized gains and losses are calculated as the difference between the proceeds from sale and original acquisition cost. Unrealized gains and losses are calculated as the difference between fair value of the investment at the end of the year less the fair value at the beginning of the year, or acquisition cost, if acquired during the year.

Payments of Benefits

Benefits are recorded when paid.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. FASB Accounting Standards Topic 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs on the hierarchy consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices in active markets for similar assets or liabilities or quoted prices in inactive markets for identical or similar assets or liabilities; Level 3 inputs on the hierarchy are unobservable and significant to the fair value measurement, and have the lowest priority. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. The valuation methodology used for the fair value measurements of pooled separate accounts is net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the fund less its liabilities.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account.

**NOTE 6 - TAX EXEMPT STATUS**

The Plan is exempt from federal and state taxation under Section 401 of the Internal Revenue Code. The Plan follows a prototype plan, which has obtained a favorable tax determination letter from the Internal Revenue Service in June 2020. Although the plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's Form 5500 is subject to examination by the Internal Revenue Service. Plan years that remain open for examination include the years ended December 31, 2021 and later.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 – PARTIES-IN-INTEREST**

Certain plan investments are sponsored by the Plan Custodian, Principal Trust Company. Total investments held by the custodian at December 31, 2024 and 2023 that are party-in-interest transactions under ERISA amounted to \$3,063,911 and \$2,757,499, respectively. Also, the Plan paid certain expenses related to plan operations and investment activity to various service providers. Total expenses paid by the Plan to Principal Trust Company were \$47,764 and \$38,819 for the years ended December 31, 2024 and 2023, respectively. In addition, the Plan utilizes Strategic Financial Services for investment advisory. Total expenses paid by the Plan to Strategic Financial Services were \$83,475 and \$69,151 for the years ended December 31, 2024 and 2023, respectively. These transactions are party-in-interest transactions that are exempt from the prohibited transaction rules under ERISA.
