## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Carroll Fulmer Logistics Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Carroll Fulmer Logistics Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## NOTES TO FINANCIAL STATEMENTS

### YEARS ENDED DECEMBER 31, 2024 AND 2023

#### Note A - Description of Plan

The following description of the Carroll Fulmer Logistics Corporation (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the most current Plan instrument for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution 401(k) plan covering all full-time employees of the Company. Employees (except for drivers) are eligible to participate in the Plan after they have completed one year of service and attained the age of 18. Truck drivers must meet certain annual mileage requirements. The primary purpose of the Plan is to provide employees of the Company with financial benefits upon retirement. The Plan is subject to the provisions of the *Employee Retirement Security Act of 1974 (ERISA)*.

**Contributions.** Each year, participants may contribute up to the maximum amount allowed by law of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (i.e. rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions equal to 100% of the first 3% of base compensation that a participant contributes to the Plan plus 50% of each participant's elective deferrals in excess of 3% but not to exceed 5%. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. For the years ended December 31, 2024 and 2023, the Company's Board of Directors elected not to make profit sharing contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of the Company's profit sharing contributions (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus the earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant does not begin to vest until year two (20%) and increases ratably until fully vested in year six. Upon attaining normal retirement age, death, or permanent disability while a participant is employed, their entire balance becomes fully vested.

**Payment of Benefits.** On termination of service due to death, disability, retirement, or for other reasons, a participant's vested account is distributed as a lump sum distribution as soon as administratively feasible. Active employees may receive hardship distributions only from their pre-tax elective deferral account, their Roth elective deferral account, or from their rollover account. Active employees that have attained age 59 1/2 may receive in-service distributions from all vested portions of their accounts.

**Forfeited Accounts.** At December 31, 2024 and 2023, forfeited non-vested accounts total \$2,606 and \$2,536, respectively. These accounts will be used to reduce future employer contributions and/or plan administrative expenses. In 2024 and 2023, total forfeitures plus investment returns were \$87 and \$240 and plan administrative expenses were reduced by \$17 and \$13, respectively.

### Note B - Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for disclosure of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### Date of Management Review

Subsequent events were evaluated through July 14, 2025, which is the date the financial statements were available to be issued.

### Note C - Trust Agreements

Transamerica Life Insurance Company (Transamerica), acting as trustee for the Plan, executes investment transactions for the Plan, and makes distributions to participants as directed by the Plan administrator. Carroll Fulmer Logistics Corporation serves as the Plan administrator.

**Note D - Certified Investments by Transamerica Life Insurance Company**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Transamerica Life Insurance Company, the Trustee, and furnished to the Company. The Company has obtained certifications from the Trustee as of and for the years ended December 31, 2024 and 2023, that such information is complete and accurate.

The Plan entered into a traditional fully benefit-responsive group annuity contract with Transamerica Financial Life Insurance Company (Transamerica Financial) totaling \$215,540 for 2024, and \$298,531 for 2023. Transamerica Financial maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The effective credited interest rate is based on a formula established by the contract issuer. The effective credited interest rate is set semi-annually and effective on the first day of the semi-annual period. During 2024 and 2023, the average crediting rate was 1.58% and 1.18%, respectively. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica Financial, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under *ERISA* (5) premature termination of the contract. At December 31, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (1) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### **Note G - Parties-in-Interest**

At December 31, 2024 and 2023, Plan investments totaling \$6,957,559 and \$6,792,333, respectively, are shares of pooled separate accounts and group annuity contracts of Transamerica Life Insurance Company. Purchases and sales of these shares qualify as party-in-interest transactions.

Transamerica rebates certain amounts to the plan based on a fee concession. The rebate amount is equal to 0.35% of the total assets per year based on the balances with Transamerica. This rebate is calculated on a monthly basis and credited to the Expense Budget Account (EBA). The EBA is considered a plan holding and is invested in the group annuity contract. During 2024 and 2023, the plan received rebates of \$24,452 and \$23,185 and administrative expenses of the plan were reduced by \$24,551 and \$22,738, respectively. At December 31, 2024 and 2023, the account balance is \$27,931 and \$27,843, respectively.

#### **Note H - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **Note I - Right to Terminate Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the Plan's provisions and those of *ERISA*. In the event of Plan termination, participants would become 100% vested in their accounts.

#### **Note J - Tax Status**

The Plan sponsor adopted a new Defined Contribution Volume Submitter Plan and Trust effective April 1, 2015. The IRS did issue an opinion letter on the acceptability of this plan and trust in a letter dated March 31, 2014. Although the Plan has been amended since the issuance of the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however there are currently no audits for any tax periods in progress.
