## INDEPENDENT AUDITOR'S REPORT

### Opinion

We have audited the accompanying financial statements of Moscow Bancshares, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF PLAN AND OTHER MATTERS

The following brief description of the Moscow Bancshares, Inc. (the Corporation) Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

#### *General*

The Corporation established the Plan effective January 1, 2006. The Plan is a non-participant directed, noncontributory, defined contribution plan that covers substantially all employees of the Corporation and its participating subsidiaries (the Companies). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Trustees who are appointed by the Corporation's Board of Directors. The Corporation's subsidiary serves as the Plan's custodian.

#### *Eligibility*

Employees of the Companies are generally eligible to participate in the Plan after 3 months of service providing they are age 21 or older. Participants who do not have at least 1,000 hours of serving during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Companies' contributions for such year.

#### *Employer Contributions*

The Companies may make discretionary contributions to the Plan as determined annually by the Board of Directors. Employee contributions are not permitted.

#### *Payment of Benefits*

Distributions on account of death, disability, or retirement are made in a lump sum in the Plan year following the event. Distributions for other separations from service commence in the fifth Plan year following the separation from service and are made in five annual installments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Corporation common stock plus cash for any fractional share of common stock. Under the provisions of the Plan, the Corporation is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

#### *Expenses*

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Companies. The Companies have historically paid all operating expenses for the Plan.

### *Voting Rights*

The trustee of the Plan will vote all Corporation stock held by it as a part of the Plan assets. Provided that if any agreement provides for voting of any shares of Corporation stock pledged as security for any obligation of the Plan, then such shares of Corporation stock shall be voted in accordance with such agreement. Notwithstanding the forgoing, each participant or beneficiary in the Plan shall be entitled to direct the trustee as to the manner in which voting rights on shares of Corporation Stock which are allocated to the Corporation Stock Account of such participant or beneficiary are to be exercised with respect to any corporate matter which involves the voting of such shares with respect to the approval or disapproval any corporate merger or consolidation, or similar transaction as defined by the Plan.

### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of the Companies' contributions, Plan earnings, and forfeitures of terminated participants' non-vested amounts. Allocations of the Companies' contributions are based on a participant's eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance to the total Plan balance.

### *Vesting*

If a participant's employment with the Companies ends for any reason other than retirement, permanent disability, or death, the participant will vest in the balances in his or her account based on total years of service with the Companies. Participants vest 20% per year beginning after the second year of service and are 100% vested after six years of credited service.

### *Put Option*

Under Federal income tax regulations, the Corporation stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Corporation buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the Corporation stock. The Corporation can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### *Plan Termination*

The Corporation reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, all amounts credited to the affected participant's accounts shall become 100% vested, and all unallocated amounts, including forfeitures, shall be allocated to the accounts of all participants in accordance with the Plan provisions.

### *Forfeitures*

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024, totaled \$17,133. There were no forfeited, non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Management considers the fair value of investments to be a significant estimate. See Note 4 for discussion of fair value measurements.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought as well as held during the year.

### *Subsequent Events*

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation process involves the selection of an independent appraiser annually. Plan management accumulates the data for the appraiser from historical and projected financial information of the Companies. The appraiser prepares a report of the per share value of the Corporation.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market account:* Valued at amortized cost, which approximates fair value.

*Corporation common stock:* The fair value of the Corporation's common stock held by the Plan is valued at fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The unobservable inputs used by the appraiser for the income valuation included: projected financial information, anticipated growth rate, and risk-free rate of return. The unobservable inputs used by the appraiser for the market valuation included: revenue multiple, forecasted financial metrics, fair value of the Company's assets and liabilities, risk-free rate of return, and market comparables.

The valuation process involves the trustees' selection of an independent appraiser annually. Management accumulates the data for the appraiser from the audited financial statements and projected financial information of the Corporation. The appraiser prepares a report which management and the Corporation Board of Directors review in detail and approve.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Corporation stock as well as a money market account for which the Corporation's subsidiary serves as the custodian. These are related-party and party-in-interest transactions. As described in Note 1, the Companies pay all Plan expenses. The Plan also has a number of other service providers. Such parties are parties-in-interest under ERISA.

## 6. INCOME TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated May 18, 2012, stating that the Plan is qualified, under the Internal Revenue Code (IRC) and, therefore, is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and tax-exempt as of the financial statement date.

U.S. GAAP require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. RISKS AND UNCERTAINTIES

The Plan can accumulate, from time to time, bank balances in excess of the insurance provided by federal deposit insurance authorities. The risk of maintaining deposits in excess of amounts insured by federal deposit insurance authorities is managed by maintaining such deposits in high quality financial institutions. The Corporation common stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
