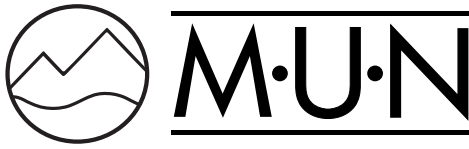

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
STAAR Surgical Company 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of STAAR Surgical Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of STAAR Surgical Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1: DESCRIPTION OF PLAN

The following description of the STAAR Surgical Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan providing all eligible employees of STAAR Surgical Company (the "Company") who have completed 1 hour of service during the first month of employment and are at least 21 years of age, with the opportunity to defer a portion of their eligible compensation on a pretax basis and receive Company matching contributions. An employee may enter the Plan on the date the employee satisfies all eligibility requirements. Excluded employees consist of union employees, nonresident aliens, residents of Puerto Rico, and all employees of any employer acquired as part of Code 410(b)(6)(c). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Each year, participants may contribute up to the maximum limits established annually by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Company makes discretionary matching contributions to the Plan in an amount equal to 80 percent of the salary reduction contribution up to the first 6 percent of the employee's compensation. The Company may also contribute nonelective contributions.

Vesting

Participants are immediately vested in their voluntary contributions, including rollovers plus actual earnings thereon. Vesting in the Company contributions is based upon years of credited service using the hours of service method. Participants vest in the discretionary Company matching contributions as follows:

<u>Years of Vesting Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

For vesting purposes, one year of service is a year in which a participant has worked at least 1,000 hours during a plan year. A participant is also fully vested upon reaching normal retirement age, upon death, or upon becoming disabled.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest. Principal and interest is paid ratably through bi-weekly payroll deductions. The notes receivable are secured by the balance in the participant's account and bear interest commensurate with the prime rate of interest charged by banks as published in The Wall Street Journal as of the last day of the preceding month plus 2 percent. As of December 31, 2024, interest rates range from 5.25% - 10.50%. The notes are repaid ratably through payroll deductions over a period of five years or less, or up to 25 years if used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Payment of Benefits

Upon termination of service due to death, disability, retirement or any other reason, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account as a lump-sum distribution. If a terminated participant has an account balance of less than \$5,000 and does not request that the account balance be rolled into another qualifying plan, the participant will receive a cash lump-sum payment. Terminated participants with account balances greater than \$5,000 may elect to leave their account in the Plan or roll their account balance into another qualified plan. Participants may also receive in-service distributions on account of hardship or after reaching normal retirement age (age 65). As of December 31, 2024 and 2023 there were no benefits payable to participants that have elected to withdraw from the Plan but have not yet been paid.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are utilized to reduce the employer contributions for the plan year. During the year ended December 31, 2024, forfeitures in the amount of \$50,920 were used to reduce employer contributions. The balance in the forfeiture account as of December 31, 2024 and 2023 totaled \$9,487 and \$1,293, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid for by the Company are excluded from these financial statements. Participant-related transactions fees are paid by the participants and are included in the Statement of Changes in Net Assets Available for Benefits as administrative expenses.

For the year ended December 31, 2024, the Plan was charged third-party administration fees of \$15,490 and investment advisory and management fees of \$235,877. These fees are deducted from individual participant accounts, which are calculated at the end of each month and deducted on a quarterly basis. Included within these fees are asset maintenance fees, loan fees, redemption fees and distribution fees. The Company has absorbed the remaining administrative costs of the Plan for the year ended December 31, 2024. Investment related expenses, including plan advisor fees, are included in net appreciation of fair value of investments.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. See Note 4 for discussion of fair value measurements and a description of the method(s) and significant assumptions used to determine the fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on ex-dividend dates. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities. Actual results may differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through July 29, 2025, the date on which the financial statements were available to be issued.

Future Accounting Pronouncements

In 2022, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2022-03, *Fair Value Measurement* (Topic 820): Fair Value Measurement of Equity Securities Subject to Contractual Sale Restrictions.

The amendments in this ASU clarify that a contractual restriction on the sale of an equity security is not considered part of the unit of account of the equity security and, therefore, is not considered in measuring fair value. The amendments also clarify that an entity cannot, as a separate unit of account, recognize and measure a contractual sale restriction. The amendments in this ASU also require the following disclosures for equity securities subject to contractual sale restrictions: 1. The fair value of equity securities subject to contractual sale restrictions reflected in the balance sheet 2. The nature and remaining duration of the restriction(s) 3. The circumstances that could cause a lapse in the restriction(s).

The new requirements are effective for the Plan's December 31, 2025 year-end. Management has not yet determined the impact of this accounting standard on the Plan's financial statements.

NOTE 3: UNAUDITED INFORMATION - CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the financial statements, including the associated investment income and interest income from notes receivable from participants, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Life Insurance Company (U.S.A). This information has not been audited by independent accountants.

NOTE 4: FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification 820, Fair Value Measurements and Disclosures, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 or 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Pooled Separate Accounts: Valued at Unit Value per share that is based on the net asset value (NAV) of shares held by plan at year-end after the deduction of applicable investment management, fund administration, and financial accounting charges. The Unit Value is not publicly-quoted in price in an active market.

NOTE 5: GUARANTEED INTEREST ACCOUNT

The Plan offers as an investment option the guaranteed interest account (the “GIA”) investment contract with John Hancock. The repayments of principal and interest credited to the Plan participants is a financial obligation of John Hancock. Accordingly, the GIA is considered to be a fully benefit-responsive contract and is presented on the face of the Statements of Net Assets Available for Benefits at contract value.

This GIA is a group annuity product, with interest rates that are adjusted monthly to reflect prevailing market rates. The GIA is valued by deposits made to the contract, plus earnings guaranteed at crediting rate, less withdrawals and fees. The Plan owns a promise to pay interest at crediting rates, which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. Guarantees are based on the claims-paying ability of the issuing company. There are not any events that could limit the ability of the Plan to transact at contract value, paid within 90 days, or in rare circumstances, contract value paid over time. There are also not any events that allow the issuer to terminate the contract and that require the Plan sponsor to settle at an amount different than contract value, paid either within 90 days or over time. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contributions to the GIA are invested in the general funds of, and are guaranteed by, John Hancock. The GIA guarantees the return of principal plus compound interest earned over the defined term of 3, 5 or 10 years, provided all contributions remain in the account until the end of the guarantee period. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 6: INCOME TAX STATUS

The Plan has adopted the Ascensus LLC pre-approved defined contribution plan, which received a favorable opinion letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: TRANSACTIONS WITH PARTIES-IN-INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and a person who owns fifty percent or more of such an employer. Substantially all administrative expenses of the Plan are paid by the Plan Sponsor. The Plan holds investments issued by the custodian. The Plan issues notes receivable to participants, which are secured by the balance in the participant's accounts. These transactions qualify as party-in-interest transactions.

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, and the IRC. Upon termination of the Plan, the total net assets of the Plan are to be distributed to the participants in proportion to their account balance.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
