### **Notes to Financial Statements**

#### **NOTE 1 SUMMARY OF ACCOUNTING POLICIES**

##### ***Basis of Accounting***

The financial statements of the NSB Profit Sharing 401(k) Plan ("Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

##### ***Investments Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

##### ***Payments of Benefits***

Benefits are recorded when paid.

##### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results may differ from those estimates.

##### ***Related Party Transactions / Expenses***

Certain administrative functions are performed by the officers or employees of the North Side Bank & Trust Co. (the "Plan Sponsor" and "Company"). These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees to the Plan. All fees and expenses of the Plan, to the extent not paid by the Plan Sponsor, are paid by the Plan. Certain investment related expenses are included in the net appreciation of fair value of investments.

Certain plan assets are in investment funds managed by Empower Annuity Insurance Company of America, as the custodian of the Plan and therefore, these transactions qualify as party-in-interest transactions.

#### **NOTE 1 SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

##### ***Subsequent Events***

The Plan has evaluated events subsequent to the balance sheet date through August 12, 2025, which is the date the financial statements were available to be issued.

#### **NOTE 2 DESCRIPTION OF PLAN**

The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering all employees of the Company. Employees become eligible after one year of service and after reaching age 21. Participants are eligible to enter the Plan immediately after meeting the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### ***Contributions***

With respect to employee contributions, participants may contribute up to 100% of compensation, as defined by the Plan, on a pre-tax or after-tax basis. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations (\$7,500 at December 31, 2024).

The Plan allows for a discretionary safe harbor contribution not less than 3% of Plan Compensation and a discretionary profit sharing contribution. During 2024, the Company allocated a safe harbor contribution totaling \$228,581, which is equal to 3% of Plan compensation. During 2024, the Company allocated a discretionary profit-sharing contribution totaling \$221,419.

##### ***Rollover Contributions***

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

##### ***Participant's Account***

Each participant's account is credited with the participant's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## NSB PROFIT SHARING 401(K) PLAN

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

##### *Vesting*

Participants are vested immediately in their contributions and the safe harbor contributions. Profit sharing contributions vest 100% after 3 years of service. A year of service is earned by attaining 1,000 hours during a Plan year.

##### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited accounts totaled \$5 and \$2,239, respectively. Non-vested portions of participant accounts that are forfeited upon payment of benefits are retained in the Plan and used to reduce future employer contributions or pay Plan administrative expenses. During 2024, \$2,239 of funds were used to offset the 2024 allocation for discretionary safe harbor contribution and discretionary profit sharing contribution.

##### *Payment of Benefits*

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in a lump sum.

In-service distributions are permissible for participants that have attained the age of 59½. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits from all accounts.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of their account necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

### Notes to Financial Statements (Continued)

#### NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

*Mutual funds:* Valued using quoted market prices of the shares of each applicable mutual fund or corporate stock, as publicly traded on an active market.

*Common/collective trust:* Investment fund formed by the pooling of investments by institutional investors, such as a group of not necessarily affiliated pension or retirement plans, typically with the intention of achieving cost savings over similar investment options such as mutual funds. Common/collective trusts are similar to mutual funds, with a named investment manager and documented investment objective. These investments, however, are not registered with the Securities and Exchange Commission (unlike mutual funds, which are registered) and participation is not open to the public. The NAV is measured by the custodian or investment manager as of the close of regular daily trading. When measuring the fair value of such funds, the NAV, as provided by the fund sponsor, is corroborated with observable inputs provided by pricing services for the securities. In certain instances, NAVs may require adjustments to more appropriately reflect the fair value. No adjustments to NAVs were required.

*Life insurance policies:* Valued at cash surrender value of each policy held by participants.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 6 TAX STATUS

The Plan Sponsor has adopted a prototype plan, which has received an opinion from the Internal Revenue Service ("IRS") dated November 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. Both the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related Plan was tax exempt as of the financial statement date.
