## Independent Auditor's Report

### The Plan Administrator Kaleris 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kaleris 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1      DESCRIPTION OF THE PLAN**

The following description of Kaleris 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

Kaleris 401(k) Plan (formerly Navis 401(k) Plan) was established on May 26, 2021 and has been amended several times since that date (see Note 13). The sponsor of the plan is Kaleris (the “Company” or “Plan Sponsor”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was created for the benefit of all eligible employees of the Company.

**Eligibility and Participation**

Employees are eligible to participate in the plan on the first day of the calendar month, coincident with or next following the date after completion of 30 days of service, measured from the participant’s date of hire. Certain employees, including union employees, leased employees, employees who are bona fide residents of Puerto Rico or performing services in Puerto Rico, interns, apprentices, employees who participate in public or private retirement programs outside of the United States, and employees who are eligible for benefits under another retirement plan sponsored by the Company are not eligible for participation in the Plan.

**Contributions**

Eligible participants may elect to make pre-tax or Roth contributions. Participants may make salary deferral contributions of eligible annual compensation as defined in the Plan document, up to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). An employee who is age 50 or older before the end of a Plan year can contribute an additional catch-up contribution to the Plan, subject to IRS limits. The Plan also permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Company makes safe harbor matching contributions to the Plan on behalf of all eligible participants. The safe harbor matching contribution is limited to 100% of the participant’s contribution up to 3% of the employee’s compensation and 50% of the participant’s contribution for the next 2% of the employee’s compensation under safe harbor plan provisions. The Company’s safe-harbor matching contribution is invested in a portfolio of investments as directed by the participants. During the years ended December 31, 2024 and 2023, the Company made \$1,375,821 and \$916,394 in safe harbor matching contributions to the Plan, respectively.

The Plan also allows for discretionary contributions and non-elective contributions by the Company. There were no discretionary contributions and non-elective contributions made for the years ended December 31, 2024 and 2023. Contributions are subject to certain IRS limitations.

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their accounts. Notes receivable may not exceed 50% of the vested portion of the participant's account (or \$50,000, whichever is less) and must be a minimum of \$1,000. The note receivable must be repaid within five years unless the loan proceeds are used to purchase the participant's primary residence, in which case the note may be repaid over a 10-year period. All notes receivable will provide for the repayment of interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Excess Contributions Payable**

Amounts payable to plan sponsor for contributions in excess of the amounts allowed to comply with the annual compliance testing requirements of the Internal Revenue Code (IRC).

**Payment of Benefits**

Benefits are generally payable on termination, retirement, death, or disability. Benefits may be paid by either lump-sum, partial, or installment, but only with respect to minimum required distributions, over a period of not more than the participant's assumed life expectancy, or in case of death, does not exceed the limitations on when the entire benefit must be paid. After the age of 59 ½, a participant may elect to receive an in-service distribution from a portion of their vested balance, except from profit share employer contributions. In addition, hardship distributions are also available from elective deferral accounts, subject to regulatory requirements.

**Vesting**

Participants are immediately 100% vested in their elective salary deferrals, rollovers, Company safe-harbor matching contributions, and any related investment earnings, gains and losses.

A participant shall become vested in his or her Company discretionary contributions and non-elective contributions under the following schedule:

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Net Appreciation (Depreciation) in Fair Value of Investments**

Realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments.

**Contributions**

Contributions from Plan participants and the matching contributions from the employers are recorded in the year in which participant compensation is earned.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments and the Plan Administrator deems the note receivable from the participant to be in default, the note receivable from the participant balance is reduced and a benefit payment is recorded.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

**NOTE 3      FAIR VALUE MEASUREMENT**

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**NOTE 3      FAIR VALUE MEASUREMENT (CONTINUED)**

*Level 2* - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investments measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end shares of registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

Pooled separate accounts: The fair values of these assets are based on the mutual funds' Net Asset Value (NAV) based on the aggregate unit value of shares held by the Plan. Portfolio valuation procedures for these accounts are determined by the mutual fund company. The NAV, as published daily by the custodian, is generally based on the fair value of the underlying securities held by the pooled separate accounts less its liabilities. The asset class provided in correspondences released by Empower Annuity Insurance Company, LLC (Empower) may be that of the primary asset class of the mutual fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 INVESTMENT AT CONTRACT VALUE**

The Plan invests in an evergreen fully benefit-responsive Group Annuity Contract with Empower Annuity Insurance Company (Empower). Empower maintains the contributions in a general account. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable timeframes.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract value is also often referred to as "book value". The contract is effected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer.

Generally, there are no events that could limit the ability of the plan to transact at contract value paid within 90 days or contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than the contract value paid either within 90 days or over time.

The Plan's investment in guaranteed investment contract as of December 31, 2024 and 2023 amounted to \$6,617,873 and \$6,597,247, respectively.

**NOTE 5 FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN AND TRUSTEE**

The Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified by Empower and Prudential Bank & Trust, FSB for plan activity occurring through March 31, 2023, and Empower Trust Company, LLC (Empower Trust) for activity thereafter. The Plan Administrator has obtained certifications from the custodians that information provided to the Plan Administrator by the custodians related to the Plan's assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following:

- Investments and notes receivable as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- Investment information disclosed in Notes 3 and 4 to the Plan's financial statements; and
- Investments, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 6 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares in mutual funds, pooled separate accounts and guaranteed investment contract managed by Empower and Empower Trust. Empower and Empower Trust are the custodian and trustee of the Plan, respectively, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid for such services qualify as party-in-interest transactions that are exempt under ERISA. Fees paid by the Plan for investment management services amounted to \$73,243 and \$82,751 for the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other fees related to the Plan's operations.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

**NOTE 7      INCOME TAX STATUS**

On January 1, 2022, the Plan adopted a Non-standardized Plan sponsored by Prudential Insurance Company of America (Prudential). The IRS has determined and informed the sponsor of the Non-standardized Plan by a letter dated September 16, 2022, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The non-standardized preapproved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8      PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the Company's discretionary and non-elective contribution portion of their account.

**NOTE 9      RISK AND UNCERTAINTIES**

The Plan invests in various investment securities that are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 10     QUALIFIED NON-ELECTIVE CONTRIBUTIONS**

Kaleris has made a Qualified Non-Elective Contribution (QNEC) to certain eligible participants under the Kaleris 401(k) Plan. This contribution was made as part of a year-end true-up process to ensure participants received the full employer matching contribution to which they were entitled, regardless of the timing or consistency of their elective deferrals throughout the plan year. Accordingly, corrective contributions totaling \$1,231 for the year ended December 31, 2024 were deposited into the Plan on March 20, 2025. This amount has been recognized as other employer contribution receivable in the Statements of Net Assets Available for Benefits as of December 31, 2024. The corresponding addition to other employer contributions has been recorded in the Statements of Changes in Net Assets Available for Benefits.

**NOTE 10      QUALIFIED NON-ELECTIVE CONTRIBUTIONS (CONTINUED)**

The QNEC is fully vested upon contribution and is intended to restore the benefits of participants impacted by the identified operational errors.

**NOTE 11      EXCESS CONTRIBUTIONS PAYABLE**

During the plan year ended December 31, 2024, the Plan Sponsor made employer matching contributions that exceeded the allowable limits under the plan document and applicable IRS regulations. These excess contributions were identified during the plan's annual compliance testing and are required to be refunded to the Plan Sponsor.

As of December 31, 2024, the Plan recorded a liability of \$5,122 under excess contributions payable, representing the total amount of excess employer contributions and associated earnings to be returned. These amounts were subsequently refunded on August 18, 2025.

**NOTE 12      NONEXEMPT TRANSACTIONS**

During 2024, the Plan Sponsor inadvertently failed to deposit \$10,690 in participant contributions within the required time frame as outlined by the DOL regulations. Lost earnings related to the late remittances totaling \$871 were deposited into the Plan in 2025.

**NOTE 13      PLAN MERGER**

In September 2022, the Company merged with Navis, LLC. Effective January 1, 2024, the Navis 401(k) Plan, sponsored by Navis LLC, was merged with the SCES Retirement Plan. Following the merger, the combined plan was renamed the Kaleris 401(k) Plan, and the plan sponsor was changed to Kaleris. As a result of these mergers, net assets amounting to \$6,038,240 from SCES Retirement Plan were transferred to the Plan in January 2024.

This merger does not impact participant benefits, as all benefit provisions have been incorporated into the Plan. The Plan continues to be administered in accordance with the provisions of the governing plan document, as amended. The financial statements for the year ended December 31, 2024 reflect the activity of the merged plan under the new plan name.

**NOTE 14      NEW LAWS AND REGULATIONS**

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE Act 2.0) became law. The new law makes changes to include provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE Act 2.0 changed the retirement plan rules for long-term, part-time employees. The 401(k) plan requirement to allow employees to contribute elective deferral was expanded to 403(b) plans.

For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods, for plans years beginning after December 31, 2024. The Plan will implement this legislative change and plans to formally execute the required plan amendments reflecting their implementation by the deadline, which is December 31, 2026.

The IRS issued proposed regulations in February 2023 addressing the use and timing of forfeitures in qualified retirement plans. These regulations apply to plan years beginning on or after January 1, 2024. The regulation states that forfeitures must be used no later than 12 months after the end of the plan year in which the forfeitures were incurred. However, the transition rule also provides that any forfeitures that were incurred in any plan year beginning before 2024 are treated as having been incurred in the first plan year that begins on or after January 1, 2024, and, thus, must be used no later than December 31, 2025, for a calendar year plan.

**NOTE 15      SUBSEQUENT EVENTS**

The Plan has evaluated events subsequent to December 31, 2024 to assess the need for potential recognition and/or disclosure in the financial statements. Such events were evaluated through August 25, 2025, the date on which the accompanying financial statements were available to be issued. Based upon this evaluation, management determined no subsequent events require disclosure or adjustment to the accompanying financial statements.
