Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Axcelis Technologies, Inc. Long-Term Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements

themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

December 31, 2024

1. Description of the Plan

General

The Axcelis Technologies, Inc. (Plan Sponsor or Company) Long-Term Investment Plan (the Plan) is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and covers all eligible employees of the Company. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions. Copies are available from the plan administrator.

Contributions

The Plan was amended effective January 1, 2019 to include automatic enrollment with the following provisions applying:

- Eligible employees not participating in the Plan on January 1, 2019 were automatically enrolled with a deferral rate of 6% unless an employee chose to opt out within the 30-day grace period that ended on February 2, 2019.
- Employees participating in the Plan with a deferral rate of less than 6% on January 1, 2019 had a one-time automatic contribution rate increase up to 6% unless an employee opted out within the 30-day grace period that ended on February 2, 2019.
- Employees who become eligible to participate in the plan after January 1, 2019 are automatically enrolled with a deferral rate of 6% unless an employee chooses to opt out within the applicable 30-day grace period.

Effective January 1, 2024, the Plan allows for Roth contributions.

Participants may change their tax-deferred and Roth contributions, limited to 35% of compensation as defined in the Plan. Participants may also make after-tax contributions to the Plan, up to 17% of eligible compensation. Highly compensated employees are limited to 3% after-tax contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

1. Description of the Plan (continued)

All matching contributions are discretionary and any discretionary match amount will be determined by the Plan Sponsor.

For the 2023 plan year, a discretionary match was made and was equal to 50% of the aggregate tax-deferred contributions up to the first 6% of eligible compensation. To be eligible to receive the match, a participant must be employed on December 31, 2023.

For the 2024 plan year, a discretionary match was made and was equal to 50% of the aggregate tax-deferred contributions up to the first 6% of eligible compensation. To be eligible to receive the match, a participant must be employed on December 31, 2024.

For the 2025 plan year, a discretionary match will be made and will be equal to 50% of the aggregate tax-deferred contributions up to the first 6% of eligible compensation. To be eligible to receive the match, a participant must be employed on December 31, 2025.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, if any, and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

For participants hired prior to January 1, 2003, their vested interest in their tax-deferred, Roth and after-tax contributions, rollover contributions, employer contributions, and actual earnings shall be 100% at all times. Participants hired after January 1, 2003, are 25% vested in employer contributions after one year of service and vest an additional 25% per year until they are fully vested (after four years of service).

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Plan Sponsor contributions or to pay Plan expenses, in accordance with the Plan agreement. The unallocated forfeited balances were \$115,302 and \$34,384 on December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions applicable to the 2024 and 2023 employer match were \$126,350 and \$34,384, respectively.

1. Description of the Plan (continued)

Notes Receivable From Participants

Participants may borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The minimum loan is \$1,000. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the date of issuance as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions over terms of not more than five years, except for loans to purchase a principal residence. Upon default or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable.

Benefit Payments

Upon retirement, death, disability or termination of service, a participant may receive a lump-sum amount equal to the value of his or her vested account, or an optional form of payment, as defined in the Plan. In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan and are strictly regulated by the Internal Revenue Service (IRS).

Administrative Expenses

The Plan Sponsor generally pays expenses associated with the administration of the Plan, except for certain fees which are paid by the Plan or participants in the Plan. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

2. Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Investments, Valuation, and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further discussion and disclosures related to fair value measurements.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Security transactions are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

3. Fair Value Measurements (continued)

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Investments in mutual funds are stated at fair market value based on quoted prices in an active market on the last business day of the Plan year. Securities listed on a registered exchange are valued at the last reported sales price in an active market on the last business day of the Plan year. The Common Collective Trust Fund is valued at net asset value of the Fund.

4. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Trust Company LLC, the trustee of the Plan.

5. Risks and Uncertainties

The Plan and its participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Income Tax Status

The Plan has received a determination letter from the IRS, dated October 26, 2017, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

6. Income Tax Status (continued)

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related-Party Transactions

The Plan holds shares of investment funds managed by Empower Trust Company LLC. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

8. Subsequent Events

Management evaluated subsequent events for the Plan through August 27, 2025, the date the financial statements were available to be issued.
