Opinion on the 2024 Financial Statements

We have audited of the financial statements of Inland Star Distribution Centers, Inc. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of Inland Star Distribution Centers, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Effective January 1, 2005, Inland Star Distribution Centers, Inc. (the Company) established the Plan. The Plan, as amended, operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company's Board of Directors. The Board of Trustees is the Plan's Trustee (Trustee).

On September 15, 2006, the Company made an initial contribution of common stock to the Plan in the amount of 96,701.556 shares, valued at \$870,314. On December 20, 2006, the Plan entered into an agreement to acquire an additional 383,298.444 shares of common stock of the Company in exchange for a promissory note in the amount of \$3,449,686. On September 30, 2019, the Plan entered into various agreements with the Company to acquire the remaining 320,000.000 shares of common stock at a purchase price of \$12.00 per share, in exchange for a new loan. Concurrently, the Plan refinanced the remaining balance of the initial loan. The resulting loan (the ESOP loan) is payable in annual installments of \$508,438 beginning December 31, 2019, including interest at 2.21% per annum, through December 31, 2028 (See Note 3).

The ESOP loan is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- a. - the accounts of employees with rights in allocated common stock (allocated), and
- b. - common stock not yet allocated to employees (unallocated).

During the year ended December 31, 2021, approximately one-quarter of the shares owned by the ESOP were allocated to the ESOP accounts of participants who were no longer employed by the Company (the Terminated Participants). On December 10, 2021, by written resolution of the Company's Board of Directors, the Company directed the Trustees of the ESOP to make benefit distributions from the ESOP for the plan year ended December 31, 2020, by distributing 174,038.000 shares (the Distributed Shares) to ESOP participants in accordance with the ESOP's benefit distribution policy by offering a one-time opportunity offered by the Company during October to December of 2021, whereby Terminated Participants could elect to receive a distribution of all or a portion of their ESOP account balance (the Distribution).

General (Continued)

Immediately following the Distribution, the Company redeemed the Distributed Shares from the Terminated Participants for a total redemption price of \$2,469,597 (the Redemption) or \$14.19 per share, in accordance with the ESOP's benefit distribution policy. Simultaneously with the Redemption, the ESOP Trustee exchanged the investment of 48,974.520 shares of company stock of Terminated Participants who did not elect a distribution for the plan year ended December 31, 2020, into assets other than company stock (the Reshuffled Shares) at the exchange rate of \$14.19 per share for a total reshuffling price of \$694,948, in accordance with the ESOP's benefit distribution policy.

Effective December 10, 2021, the ESOP entered into an agreement with the Company to buy the Distributed and Reshuffled Shares for the same price of \$14.19 per share (the 2021 ESOP loan). The 2021 ESOP loan is payable in annual installments of \$350,840 beginning December 31, 2022, including interest at 1.90% per annum, through December 31, 2031 (See Note 3). The 2021 ESOP loan is secured by a pledge of the underlying shares.

Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching the age 21 and after completing one year of service in which at least 1,000 hours are worked. Participants must be employed as of the last day of the plan year to be eligible to receive any employer paid contribution.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equals the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans. Employee contributions are not permitted.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company, according to the following schedule:

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required to vote any unallocated shares on behalf of the collective best interests of plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase in a lump sum or in equal annual installments with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments that are more diversified. Participants who are at least the age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Payment of Benefits

Distributions on account of death, disability, or retirement are made in a lump sum in the plan year following the event. Distributions for other separations from service commence in the sixth plan year following the separation from service and are made in a lump sum or five annual installments, up to ten years if participant's capital accumulation account exceeds certain limits), at the Company discretion. The amount to be distributed is based upon the immediately preceding valuation date. Account balances of \$1,000 or less, their consent is not required for the Company to distribute the participant's capital accumulation balance. This allows the Company to repurchase the shares held by the participant and distribute cash as soon as practicable. The participant is permitted to rollover the distribution to an IRA or another qualified retirement plan as required by IRS regulations.

Distributions are made in cash, shares of company common stock, or a combination of both as determined by the Company and the participants' rights under the Plan. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan, if the shares are not publicly traded or if the shares are subject to trading limitations.

Forfeited Accounts

Forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts to be allocated to participant accounts. For the year ended December 31, 2024, forfeitures of dollars and shares amounting to approximately \$316,747 and 11,607, respectively, were allocated to participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Plan Expenses

Certain administration expenses of the Plan are absorbed by the plan sponsor. Those expenses are not included in these financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standards Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The shares of company common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – LOAN PAYABLE

In 2006, the Plan entered into a \$3,449,686 term loan agreement with the Company. In 2019, this loan was refinanced and increased to \$4,591,570 at an interest rate of 2.21% through December 31, 2028. In December 2021, the Company entered into a \$3,164,546 term loan agreement at an interest rate of 1.90% through December 31, 2031. The proceeds of the loans were used to purchase company common stock. Unallocated shares are collateral for the loans. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral times the ratio of the current year payments divided by the total of this year's payments plus all future years' principal and interest payments. This resulted in 59,949 shares being released and allocated for the plan year ended December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan adopted FASB ASC 820, *Fair Value Measurements*. FASB ASC 820 defines a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 - inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 - inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 - inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

The plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The fair value of the company stock is determined using the following methodology:

The market approach and earnings approach were employed in valuing the Company's operations using the capitalization of public company method and discounted cash flow method.

The earnings approach method utilized in the analysis of the Company involves estimating the level of economic earnings of the Company, determining the applicable relationship between economic earnings and value, and then converting the expected economic earnings into an estimate of value. When the Company is profitable and generating a return for its investors, the earnings capacity of the Company is generally considered to be the most representative measure of the value of the Company.

Theoretically, the market value of an investment in the Company is the present value of the expected future economic earnings generated by the Company. The discounted cash flow method is used when future economic earnings can be reasonably forecasted and are expected to increase at a non-constant rate in the future. The capitalization of earnings method is a simplified version of the discounted cash flow method and is utilized when a representative level of the expected economic earnings of a business can be estimated and this level of economic earnings is expected to increase at a constant rate in the future.

The market approach utilized in the analysis of the Company uses information from actual transactions of comparable businesses or value parameters of guideline publicly traded companies as a basis for estimating the value of a business. When applied to the valuation of an ownership interest in a privately held business, consideration is given to the financial condition and operating performance of the business being valued relative to the companies used to determine the value parameters.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in company common stock and has indebtedness due to former owners of the Company. These are related party and party-in-interest transactions. Additional parties-in-interest include Acuity Advisors, who performed an appraisal of the stock; Navia Benefit Solutions, who is the recorder keeper for the Plan; Moss Adams, LLP the plan auditor for 2023; and HHM CPAs, the plan auditor for 2024.

NOTE 6 – TAX STATUS

The Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) and is therefore not subject to income taxes. The Plan obtained its latest determination letter on February 14, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain its qualification.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, *Income Taxes*. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years from December 31, 2021 through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.

NOTE 7 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS

As of December 31, 2024, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the plan sponsor totaled \$1,011,294. Of those balances, the amount that had been requested to be paid to the participants but were not paid until subsequent to the Plan's year end, was none.

NOTE 8 – SUBSEQUENT EVENTS

Management has evaluated events and transactions subsequent to December 31, 2024 through July 31, 2025 (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. Management has not identified any items requiring recognition or disclosure.
