**1. DESCRIPTION OF PLAN**

The following description of the On Site Management 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan is a voluntary defined contribution plan qualifying under Section 401(k) of the Internal Revenue Code of 1986. It covers substantially all employees of the Company who have attained one year of service and age 20. Effective July 1, 2017, employees who have reached age 20 become eligible for the salary deferral component of the plan upon reaching 90 days of employment. Employees may enter the Plan on the first day of the month coinciding with, or next following, the date eligibility requirements are met. Effective September 1, 2022, employees become eligible for deferral and match provisions at six months of employment with no age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is a single employer plan.

**Plan Administration:**

The administration of the Plan is the responsibility of the Plan Sponsor. All money that is contributed to the Plan is held in various investments with Empower Annuity Insurance Company of America and Empower Trust Company, LLC. The Plan has engaged the services of a third party administrator to handle many of the plan reporting functions.

**Funding Policy:**

Transfers of investments from one fund to another fund are allowed daily using online accounts. Participants may direct contributions to investment funds in various increments of their total contribution.

1. Employee contributions: Participant contributions are made through payroll deduction. Participants may contribute up to 100% of defined earnings, as limited by §402(g) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may choose Roth elective deferrals. Plan management has installed an automatic enrollment provision whereby, upon meeting salary deferral eligibility requirements, participants will have 1% automatically withheld from pay and contributed to the Plan. Employees may complete a salary deferral election form indicating some other deferral percent, or elect to have no amount withheld. The automatic deferral percent will increase by 1% each year up to a maximum of 10% unless the employee elects otherwise.
2. Employer safe harbor match contributions: A safe harbor match contribution is made for eligible participants. This match contribution is equal to 100% of salary deferrals up to the first 3% of compensation plus 50% of salary deferrals up to the next 2% of Plan compensation. The safe harbor contribution for the years ended December 31, 2024 and 2023 were \$407,150 and \$373,844, respectively.

3. Employer discretionary contributions: The Company may make discretionary contributions which are calculated using a cross testing method. A participant must be employed on the last day of the plan year and have completed 1,000 hours of service in order to receive a discretionary contribution. Exceptions to this allocation condition will apply to participants who die, become disabled, or terminate employment after attaining the early retirement age. The nonelective contributions for both years ended December 31, 2024 and 2023 were \$200,000.

**Investment Options:**

Upon enrollment in the Plan, a participant may direct employee and employer contributions into any of a variety of funds made available through the Plan. The Plan sponsor may change the investment options offered at any time, as deemed appropriate. Participants have access to their account information through the Internet and may make allocation changes at any time, subject to the Securities & Exchange Commission restrictions on excess trading.

**Participant Accounts:**

Each participant's account is credited with the participant and the Company's contributions and an allocation of Plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:**

Participants are immediately 100% vested in their elective deferrals and safe harbor match contributions plus actual earnings thereon. The profit sharing contribution is subject to a six year graded vesting schedule.

**Notes Receivable from Participants:**

Participants may obtain loans from their vested account balance. The amount of the loan permitted by the Plan is a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. Principal and interest are paid by payroll deductions. Only one outstanding loan at a time is allowed for each participant. The interest rate is prime plus 2%.

**Payment of Benefits:**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum, installment, or partial amount equal to the vested value of the participant's account. Alternatively, the participant may transfer the vested value of their account to another retirement investment vehicle. Premature payments may also be obtained, subject to the limitations imposed by the Internal Revenue Code.

**Basis of Accounting:**

The accompanying financial statements have been prepared on an accrual basis and present the net assets available for benefits and changes in those assets.

**Estimates:**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition:**

The Plan's investments are stated at fair value with the exception of the Key Guaranteed Portfolio fund which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Income Tax Status:**

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan's federal tax returns generally remain open for the last 3 years.

**Payments of Benefits:**

Benefits are recorded when paid.

**Forfeited Accounts:**

Forfeitures are used to either pay Plan administrative expenses or to reduce the employer contribution to the Plan. Forfeitures used to pay administrative fees or reduce the employer contribution for the plan years ended December 31, 2024 and 2023 totaled \$11,688 and \$15,429, respectively.

**3. INFORMATION CERTIFIED BY CUSTODIAN**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the custodians of these investments, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, except for comparing such information certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC to information included in the Plan's financial statements and supplemental schedule. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC has certified to the completeness and accuracy of the following information as of and for the years ended December 31, 2024 and 2023.

**4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

*Level 1*

The fair value of mutual funds is based on the quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

**5. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACTS (FBRICS)**

*Traditional Investment Contract with Insurance Company*

The Plan maintains a benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but many not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The average yields earned by the Plan and the average interest rate credited to participants for the years ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) the Plan fails to comply with any provisions contained in the contract, (c) the Plan fails to qualify for or becomes disqualified under Code section 401(a), (d) the Plan notifies Empower of its intent to terminate the contract. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract permits either the insurance company or the Plan to terminate the agreement prior to the scheduled maturity date at a mutually agreed upon date.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, partially terminated, or if there is a complete discontinuance of contributions by the employer, all amounts credited to the accounts of participants shall vest and become non-forfeitable.

**7. ADMINISTRATIVE EXPENSES**

The Plan sponsor pays for some of the administrative expenses for operating the Plan. The Plan permits the payment of plan-related expenses to be made from plan assets. These expenses will be allocated proportionately based on the value of the account balances or as an equal dollar amount based on the number of plan participants. The Plan permits the payment of expenses which are incurred by or attributable to a particular individual based on the use of a particular plan feature to be assessed against an individual participant's account. Examples of these are loan fees, expenses related to qualified domestic relations orders (QDROs) and hardship distributions.

**8. PARTY IN INTEREST TRANSACTIONS**

Fees paid by the Plan for investment advising and management, recordkeeping, and audit services totaled \$80,905 and \$73,484 for the years ended December 31, 2024 and 2023, respectively. These fees were paid to the investment advisor or custodian, third party administrator, and auditor of the plan and qualify as exempt party in interest transactions.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. TERMINATED PARTICIPANTS WITH ACCOUNT BALANCE**

As of December 31, 2024 and 2023, terminated participants had vested account balances totaling \$6,285,793 and \$4,097,718, respectively.
