We have performed audits of the accompanying financial statements of Braun Electric Company, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Braun Electric Company, Inc. 401(k) Plan (the Plan) provides only general information with regard to the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution profit sharing plan with 401(k) provisions for eligible employees of Braun Electric Company, Inc. (the Company), who have completed 6 months of service and attained age 18. An employee is not eligible if the employee is a resident of Puerto Rico, covered under a collective bargaining agreement, a leased employee, or a nonresident alien with no income from a United States of America source. The Company is a wholly owned subsidiary of C&B Holding Company, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 6, 2023, the Company became a signatory company, at which time all its field labor positions are now covered under a collective bargaining agreement. Employees under a collective bargaining agreement are not eligible to participate in the Plan.

Contributions:

Participating employees are allowed to make elective deferrals as defined in the Plan, pursuant to Section 401(k) of the Internal Revenue Code. Effective November 3, 2023, participating employees are allowed to make after-tax elective deferrals as defined in the Plan, pursuant to Section 401(k) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified contribution plans. The Company is required to make safe harbor matching contributions equal to 100% of a participant's elective deferrals that do not exceed 3% of the participant's compensation and 50% of the participant's elective deferrals that exceed 3% of the participant's compensation but not exceeding 5% of the participant's compensation. The Company can make discretionary employer contributions and nonelective discretionary nonelective contributions to the Plan. For the year ended December 31, 2024, the Company made required safe harbor matching contributions of \$91,062. The Company made no discretionary contributions for the year ended December 31, 2024. Contributions are funded bi-weekly.

Forfeitures of terminated employees' nonvested account balances can be used to offset employer contributions and expenses. Forfeitures used to offset employer contributions and Plan expenses for the year ended December 31, 2024 was \$-0-. The nonallocated forfeiture balance at December 31, 2024 and 2023 was \$456 and \$447, respectively.

Participant accounts:

Separate accounts are kept for each participant. Each participant's account is credited with the Company's contributions, the employee's contributions, and allocation of Plan earnings or losses and expenses.

Notes to Financial Statements

All amounts are participant-directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are immediately vested in safe harbor contributions made by the Company. Vesting in the Company's discretionary employer contributions plus earnings thereon is based on continuous years of service. A participant is 100% vested after one year of credited service.

Notes receivable, participants:

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance. The maximum aggregated dollar amount of loan outstanding to a participant may not exceed \$50,000. Loans are secured by the participants' vested interest in the Plan. The maximum number of loans allowed is one. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefit payments and withdrawals:

On termination of service, participants may elect to receive a lump-sum distribution equal to the vested value of their account or leave the value of their account on deposit until normal retirement (age 65). Participants are automatically 100% vested upon termination due to death or disability. If a participant's vested account balance is less than \$5,000, they will automatically receive payment in the form of a lump-sum. Effective September 1, 2024, if a participant's vested account balance is less than \$7,000, they will automatically receive payment in the form of a lump-sum. Participants with vested account balances greater than \$7,000 may elect payments in the form of lump-sum, installments or combination of lump-sum and installment payments.

The participant may request for in-service withdrawals if the participant has reached age 59 ½, and may elect to withdraw all or a portion of the entire vested account while the participant is still employed by the Company. The participant may also request for hardship withdrawals in which the participant may withdraw employee pretax and after elective deferral contributions to satisfy specific and heavy financial needs in accordance with Internal Revenue Service regulations.

Amounts allocated to accounts of participants who, at December 31, 2024, have elected to withdraw from the Plan but have not been paid are \$-0-.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts.

Notes to Financial Statements

Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to full benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates:

The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable, participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits:

Benefit payments are recorded when paid.

Plan expenses:

During the year ended December 31, 2024, certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Notes to Financial Statements

Tax status:

The non-standardized pre-approved Profit Sharing Plan with CODA Adoption Agreement obtained its latest determination letter June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 3. Plan Termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their discretionary employer contributions. Payment of such amounts will be made to participants by the Trustee as directed by the Plan Committee.

Note 4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies (mutual funds): The fair values of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Guaranteed Investment Contract with Insurance Company

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Fidelity Management Trust Company (Fidelity). Fidelity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$16,009 and \$14,837, respectively. The crediting rate is based on a formula established by the contract issuer but may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan documents (including complete or

Notes to Financial Statements

partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe that any events that would limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants or the issuer are probable occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 7. Party-in-Interest Transactions

For the year ended December 31, 2024, certain Plan investments are shares of mutual funds and common/collective trusts managed by Fidelity Management Trust Company (Fidelity), the Plan's Trustee. The Plan paid fees of \$38,044 to its service providers for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transactions rule.

Note 8. Reconciliation of Financial Statements to Form 5500

Certain balances included on Schedule H Part I and II on the Annual Return/Report of Employee Benefits Plan (Form 5500) have been reclassified for the purpose of presentation in the financial statements.
