### Note 1 - Plan Description

The following description of Nagel Precision Inc. Profit Sharing 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees. An employee is eligible to participate in the Plan after three consecutive months of service and can enter the Plan on the first day of the month subsequent to becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and qualifies under Internal Revenue Code Section 401(k).

#### **Contributions**

The Plan allows participants to make annual contributions on a pretax basis between 1 and 50 percent of base salary subject to Internal Revenue Service limits. Such contributions must be made in 1 percentage point increments, and a participant may increase or decrease pretax contribution amounts on a monthly basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The plan sponsor has elected to make safe harbor nonelective contributions to the Plan. Safe harbor contributions are allocated to each participant as a fixed percentage of eligible compensation, as defined by the Plan. Participants must be eligible to make employee 401(k) contributions in order to be eligible for the safe harbor contributions. During the year ended December 31, 2024, the plan sponsor made safe harbor contributions totaling \$395,563.

The plan sponsor can make other discretionary contributions but did not do so for the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of company contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants' contributions, employer safe harbor contributions, and employer discretionary contributions, along with related earnings, are fully vested at all times and are not subject to forfeiture for any reason.

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, attainment of age 59½, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement. The plan administrator must approve any such hardship withdrawals.

#### **Participant Notes Receivable**

The Plan allows participants to borrow up to the lesser of 50 percent of their account balances or \$50,000, secured by the account balance and bearing interest at the prime rate, as established by *The Wall Street Journal*, plus 1 percent. The minimum borrowed amount is \$1,000. Participants are allowed a maximum of one loan outstanding at any time. Participant notes receivable are collateralized by the participant's account balance.

**Note 1 - Plan Description (Continued)**

***Termination***

While it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event that the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value based on quoted market values. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

See Note 5 for additional information.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the plan sponsor.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 7, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Ascensus Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Ascensus, LLC, as agent for Ascensus Trust Company.

### Note 4 - Tax Status

The Plan is a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
