Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of IPG Photonics Corporation 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to, or is derived from, the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to, or derived from, the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of Plan

The following description of the IPG Photonics Corporation 401(k) Retirement Plan (the “Plan”) provides only general information about the Plan’s provisions. Participants should refer to the plan document and summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of IPG Photonics Corporation and related employers, Genesis Systems Group, LLC and Genesis Tree Holdings, LLC (referred to collectively as the “Company” or “Employer”) after attaining 21 years of age. Effective April 1, 2024, the Plan was amended to exclude interns from being an eligible class of employees. The entry date to the Plan is the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The IPG Photonics Savings Plan Committee, the plan administrator, is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, monitoring investment performance, and reporting to the Company’s compensation committee at least annually.

Contributions

Contributions to the Plan are made by both the Company and participants. Participants may elect to defer 401(k) contributions up to 60% of their annual eligible compensation on a pre-tax or after tax (Roth) basis as defined in the Plan, subject to Internal Revenue Service (“IRS”) limitations (\$23,000 in 2024). Participants may elect to change their deferral contributions as of the beginning of each payroll period. With proper notice and approval, the Employer may allow a participant to enter into a special salary reduction agreement to make additional deferral contributions up to 100% of their available compensation, as defined, for the payroll period designated by the Employer, subject to IRS limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, as defined by the Plan and subject to IRS limitations (\$7,500 in 2024). Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan as soon as administratively feasible on or after the participant’s entry date, as defined, unless the participant affirmatively elects to change or revoke such deferral contributions. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions are invested in a designated balanced fund until changed by the participant. Under the automatic enrollment provisions of the Plan, the Employer may automatically increase the participant contributions by 1% on or about June 30 (unless automatically enrolled for less than six months) until they reach a maximum of 10%. The Company makes a non-discretionary employer matching contribution of 50% of a participant’s deferrals, up to 6% of eligible compensation contributed to the Plan, which is calculated for each plan year.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and company contributions, as well as an allocation of the plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Administrative expenses for participant directed transactions such as loan requests and other withdrawal requests are charged directly to the participant’s respective account upon initiation by the participant. All other administrative expenses incurred by the Plan are paid by the Company.

Vesting

Participants are vested immediately in their contributions and employer matching contributions, and all earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (1) \$50,000 or (2) 50% of their vested account balance. Note terms range from one to five years in most cases, or ten years if proceeds are used for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates, as determined by the plan administrator. A participant may take only one new note receivable during the plan year, and may not have more than one note receivable outstanding at any given time. Principal and interest are paid ratably through payroll deductions and interest is recognized as income when received. Certain direct fees are charged to the participant to set up and maintain the note.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant, or a participant's beneficiary in the case of death, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum or in periodic installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions generally require written consent; however, the Plan provides for the direct rollovers to an individual retirement account ("IRA") for terminated participants with vested balances greater than \$1,000 and not more than \$5,000, unless directed otherwise by the participant. The Plan also allows the plan administrator to automatically distribute the entire vested account balance of terminated participants with vested account balances of \$1,000 or less, unless otherwise directed by the participant. Participants are eligible for in service distributions of any portion of their account balance after attaining the age of 59 ½. Before age 59 ½ withdrawals can be made in the event of demonstrated financial hardship, as provided in the plan document. Terminated participants are required by law to receive minimum distributions by April 1 of the year following the year they turn 73.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The

IPG Photonics Savings Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, the custodian, and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, respectively. Delinquent notes receivable are reclassified as distributions based upon terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The Plan has entered into a revenue credit agreement with the plan trustee to reduce participant expenses. As a result, a revenue credit of \$60,352 was allocated to eligible participants and was included with dividends and interest income during the plan year. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 14, 2025, the date the financial statements were available to be issued.

3. Certified Investments

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule, Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to their fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds and Money Market Fund

The Plan’s mutual funds and money market fund are valued at the daily closing price as reported by the fund. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. Those funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded and are considered Level 1 assets within the fair value hierarchy.

5. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are shares of registered investment companies and managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan, therefore, any transactions between Fidelity Management Trust Company and the Plan qualify as party-in-interest transactions. The Plan made direct payments to Fidelity Management Trust Company totaling \$43,026 which are included in administrative expenses during the year ended December 31, 2024. The Plan extends notes receivable to participants which are also considered party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. As described in Note 2, the Company also pays certain administrative expenses of the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would remain 100% vested in their employer contributions.

7. Tax Status

The Plan adopted a pre-approved plan document (formerly referred to as a "volume submitter" defined contribution plan document) sponsored by Fidelity Management & Research Company LLC, which received an IRS opinion letter dated June 30, 2020, which states that the Plan is qualified under Section 401(a) of the Internal Revenue Code ("IRC") and therefore, the related trusts are tax exempt. Although there have been amendments to the Plan since receiving the most recent opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been made in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax provisions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, as of December 31, 2024 there were not any audits in progress for any tax periods.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.
