Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Portland Group Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Portland Group Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of The Portland Group Savings and Retirement Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan adopted and effective as of January 1, 1990 and August 2, 1990, respectively. The Plan covers substantially all employees of The Portland Group, Inc. (the Sponsor) and is subject to the provisions of ERISA, as amended, and the Internal Revenue Code (IRC).

Eligibility

All full-time employees having attained the age 18, as defined, are eligible for participation.

Contributions

A participant may contribute a percentage that is at least 1% and is not in excess of 60% of his/her compensation, as defined in the Plan and subject to maximums in accordance with federal regulations. Such contributions are deducted from the participant's pre-tax earnings. A participant may subsequently elect to increase or decrease the rate of contributions at the beginning of each Plan month. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6% of eligible compensation. Contributions are automatically invested in Fidelity Personalized Planning & Advice At Work until changed by the participant

Participants become eligible for employer matching contributions if they make deferral contributions and satisfy an additional service requirement of one year with 1,000 hours. A participant's contributions up to 6% of his/her compensation qualify for the employer matching contribution at a rate equal to 50% of the employee's contribution.

The Sponsor, at the discretion of the Board of Directors, may contribute an employer nonelective contribution. Both Sponsor and participant contributions are subject to certain limitations, as defined in the Plan documents, and in accordance with the applicable regulations.

Participants' Accounts

Contributions made by the participants and the Sponsor are sent to the trustee and are allocated to the respective participants' accounts. Each participant's account is credited with his/her pre-tax contributions, the employer matching contributions and investment earnings. The benefit, which a participant is entitled to, is the benefit provided by his/her account.

Vesting of Contributions

A participant's contributions and earnings thereon are fully vested at all times. Under normal vesting circumstances, the employer matching contributions and earnings thereon are 20% vested after two years of service, and an additional 20% vested each subsequent year until 100% vested after six years of vesting service, as defined in the Plan. Any participant automatically becomes fully vested upon death, disability, or attainment of age 65.

Forfeited Accounts

The nonvested portion of a participant's employer matching contributions is tentatively forfeited after one year of severance, as defined in the Plan. If the participant is reemployed prior to five years of severance and repays the Plan an amount equal to the total distribution, the tentatively forfeited amounts without investment income will be reinstated. Amounts not reinstated serve to pay administrative expenses and reduce future employer matching contributions.

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,468 and \$6,243, respectively. For the year ended December 31, 2024, forfeitures used to reduce matching contributions amounted to \$24,470.

Notes Receivable from Participants

A participant may borrow against his/her vested account balance. A participant's loan is limited to his/her vested account balance not to exceed \$50,000. The minimum loan amount is \$1,000. A loan bears interest at a fixed rate, as determined by the Plan administrator, which is credited to the participant's account. A loan is required to be repaid in at least quarterly installments of principal and interest over a period not to exceed six years; 10 years if the purpose of the loan was to acquire a primary residence.

Payment of Benefits

Upon termination of service due to retirement or disability, a participant may elect to receive either a lump-sum distribution equal to the value of his/her account or to defer receipt of his/her account balance, provided a distribution is made or commences no later than the April 1st following the end of the calendar year in which the participant attains age 70-1/2.

In the event of death, a participant's entire account balance will be distributed to his/her beneficiary.

Distributions to participants who otherwise terminate employment will be deferred until the age 65, unless the participant elects immediate payment or the distribution is less than \$5,000. In such cases, the participant will receive a lump-sum distribution equal to the nonforfeitable value of his/her account.

Withdrawals

Withdrawals are not permitted except for a severe financial hardship, such as the purchase of a primary residence, educational expenses, uninsured medical expenses or the prevention of eviction from or foreclosure on a primary residence. Hardship guidelines adhere to the final 401(k) regulations of the IRC.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to benefits paid to participants. The Plan distributed the excess contribution to the applicable participants prior to March 15.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through July 17, 2025, the date the financial statements were available to be issued, and it was determined that there were no events requiring adjustment to, or disclosure in, the financial statements.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year-end.

Common Collective Trust: The common collective trust is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of the units held of the common collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of Fidelity. Fidelity is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Sponsor who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions.

NOTE 6 INCOME TAX STATUS

The Plan has adopted a nonstandardized prototype plan that received a favorable opinion letter from the IRS that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
