**Note A – Description of Plan**

The following brief description of the Petland, Inc. 401(k) Retirement Plan (the Plan) is provided for general information purposes. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

**General Information**

The Plan is a defined contribution 401(k) and profit-sharing plan covering substantially all employees of Petland, Inc. (the Company) who are not classified as a non-salaried retail associate. Employees are eligible to participate in the Plan and to receive an allocation of Company contributions after reaching the age of 21 and completing one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is qualified under the Internal Revenue Code (Code).

**Contributions**

Each year, participants may contribute up to the lesser of 90% of their eligible compensation, as defined by the plan document, or the maximum dollar amount allowed by the Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct investment of their account balances into various investment options offered by the Plan. Currently, the Plan offers 23 mutual funds, one money market fund, and one group annuity contract as options for participants.

The Plan has automatic enrollment for all employees who meet the eligibility requirements. An automatic deferral election of 3% will be withheld if an election is not made by the date the participant becomes eligible.

The Plan allows for safe harbor and discretionary matching contributions, as determined by the Company with respect to each plan year. The safe harbor matching formula is equal to (i) 100% of the employee contributions that are not in excess of 3% of eligible compensation, plus (ii) 50% of the amount of the employee contributions that exceed 3% of eligible compensation but that do not exceed 5% of eligible compensation. This safe harbor matching contribution is 100% vested. The Company's safe harbor matching contributions for the year ended December 31, 2024, were \$247,112. There were no discretionary matching contributions for the year ended December 31, 2024.

**Rollover Contributions**

Participants may roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis.

**Participant Accounts**

Charles Schwab Trust Bank (CSTB) is the plan trustee and holds the funds; the Company does not have access to the funds. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed; however, the Company has complete control over the investment offerings made available to plan participants.

**Vesting**

Participants are immediately vested in their elective deferral contributions, rollovers, and discretionary employer contributions plus any earnings they generate. Employer matching contributions to the Plan made prior to January 1, 2022 plus any earnings they generate vest at 20% each year and are fully vested after five years of service. Safe harbor employer matching contributions made subsequent to January 1, 2022 are 100% vested.

**Participant Loans**

Participants may borrow up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates equal to the prime rate as determined by the plan trustee as of the time the application for the loan is made plus 2.00%. The participant loans must be repaid over a period not to exceed five years, or up to 10 years if for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions. The loan is charged a commercially reasonable rate of interest based on interest rates charged for similar types of loans by other lenders plus 2.00%. The interest rate is fixed for the duration of the loans and ranges from 4.25% to 10.50% as of December 31, 2024.

**Payment of Benefits**

Participants become eligible for benefit payments upon retirement, termination of employment, disability or death. Additionally, the Plan provides for in-service distributions after a participant has reached age 59½ and after their account is fully vested. Distributions may be made under several options including as a single lump-sum payment or installments over a certain period. Hardship withdrawals are permitted within the Plan document.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the employer matching contributions.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts can be used to reduce employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeitures were \$711 and \$4,152, respectively. For the year ended December 31, 2024, \$6,540 of forfeitures were used to reduce employer contributions.

**Expenses of the Plan**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses paid by the Plan were \$35,316 for the year ended December 31, 2024.

**Note B – Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully-benefit responsive group annuity contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. The fully-benefit responsive group annuity contract is reported at contract value because it represents the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of Benefits**

Benefit payments are recorded when approved. There were no approved unpaid distribution requests at December 31, 2024 or 2023.

**Note C – Investments (Information Certified By the Plan Trustee)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and dividends and interest for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by CSTB. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note D – Fair Value Measurements**

Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC Topic 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

- **Mutual funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The money market fund held by the Plan is an open-end mutual fund that is registered with the SEC. This fund is required to publish its daily NAV and to transact at the price.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note E – Investment Contract with Insurance Company**

As of December 31, 2024 and 2023, the Plan held a group annuity contract with CSTB. The group annuity contract, The Standard’s Stable Asset Fund I, is a fixed account. The methodology for calculating the interest credit is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate (which will never be less than 0% as stated in the contract), and prevailing market conditions. The interest crediting rate is reset quarterly. At December 31, 2024 and 2023, The Standard’s Stable Asset Fund I’s contract value was \$169,500 and \$204,195, respectively.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such events that would limit the Plan’s ability to transact at contract value with participants is probable.

The average yield earned by the Plan is derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for the years ended December 31, 2024 and 2023 was 2.97% and 2.62%, respectively.

**Note F – Risks and Uncertainties**

The Plan provides for various investment options including any combination of certain mutual funds. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants’ individual account balances.

**Note H – Tax Status**

The underlying non-standardized plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Code, and therefore, the related trust is tax exempt. In accordance with Revenue Procedure 2017-41 and Announcement 2020-4, the plan sponsor has determined that it is eligible for, and has chosen to rely on, the current IRS plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) of the Plan if the Plan has taken an uncertain tax position that is more likely than not would not be sustained upon examination by the IRS. There were no uncertain tax positions of the Plan as of December 31, 2024 or 2023.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note I – Related-Party Transactions and Parties-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan issues loans to participants, which are secured by the balances in the participants' accounts.

Certain administrative expenses are provided by the Company at no cost to the Plan and certain administrative expenses of the Plan are paid by the Company.

**Note J – Corrective Contributions**

For plan years prior to the year ended December 31, 2021, the plan administrator identified errors in the administration including the calculation of the employer match for certain participants, the definition of compensation for certain participants, and failure of the Plan's Annual Deferral Percentage Compliance Test calculation. The plan administrator believes it made necessary changes to the design of the Plan's internal controls relating to the administration of employer matching and definition of compensation. The Company intends to make contributions to the identified Plan participants for missed Plan contributions and associated lost earnings and has filed with the IRS a request for a compliance statement under the Voluntary Correction Program (VCP) to resolve the Plan's operational errors.

At December 31, 2024 and 2023, included within the employer contribution receivable was \$8,948 and \$28,781, respectively, to record corrective matching contribution receivables related to the errors discussed above in previous plan years.

**Note K – Subsequent Events**

In connection with the preparation of the Plan's financial statements for the year ended December 31, 2024, events and transactions subsequent to December 31, 2024 through August 13, 2025 have been evaluated by the plan administrator for possible adjustment and/or disclosure. No subsequent events requiring financial statement adjustment and/or disclosure have been identified.
