Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of U.S. Healthcare, Inc. Retiree Health Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of U.S. Healthcare, Inc. Retiree Health Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 1 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of U.S. Healthcare, Inc. Retiree Health Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about U.S. Healthcare, Inc. Retiree Health Benefit Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of U.S. Healthcare, Inc. - conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about U.S. Healthcare, Inc. Retiree Health Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Notes to Financial Statements (Modified Cash Basis)

Note 1 – Description of the Plan

The following is a brief description of the U.S. Healthcare, Inc. Retiree Health Benefit Plan (the Plan).

Participants should refer to the Plan document for a complete description of the Plan's provisions, including participation, benefit, and forfeiture provisions.

General – The Plan is a defined contribution health and welfare plan designed to provide funding for premiums for post-retirement health care benefit coverage to eligible retired employees and their eligible spouses. Designated employees of Aetna U.S. Healthcare, Inc. (renamed Aetna Inc.) and its subsidiaries and affiliates (the Employer or Plan Sponsor) are generally eligible to participate in the Plan if they are employed on a full-time basis, meet other eligibility requirements of the Plan and are not “key employees,” as defined in the plan document. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan administration – Aetna Inc. (the Company) is the Plan Administrator and the Plan Sponsor. The trustee of the Plan is State Street Bank and Trust Company (SSBT). The recordkeeper for the Plan is USI Consulting Group, Inc. (formerly known as Hooker & Holcombe Retirement Services, Inc., prior to its acquisition by USI Consulting Group, Inc. as of May 1, 2024).

Plan amendment – The Plan was amended by action taken October 9, 1998, effective December 31, 1998, and as a result, a) no contributions shall be made and no participants shall be added after December 31, 1998, b) the Plan will continue to operate as a frozen plan after 1998, c) effective January 1, 1999, for eligible participants (as defined in the plan document), the Employer subsidy for retiree medical benefits will continue to be paid out of the Plan account and, once assets are exhausted in an eligible employee's Plan account, retiree medical benefits for eligible participants of the Plan may be paid out of the Aetna Inc. Medical/Dental Benefit Plan, or a successor plan, if applicable and, d) the cost of services to carry out the Plan including administrative expenses shall be paid out of Plan accounts effective December 31, 1998. Prior to December 31, 1998, administrative expenses were paid by the Employer.

Contributions – Employer contributions, which were made at the Employer's sole discretion, were paid to a voluntary employees' beneficiary association trust (the Trust) established by the Employer. Such contributions were allocated to separate accounts established for each eligible participant and each participant's eligible spouse. Funds accumulated in these separate accounts are used to fund all or a portion of the premiums for health care benefit coverage for eligible retirees and their eligible spouses who elect to participate in the health coverage selected by the Plan. When funds in these separate accounts are exhausted, neither the Employer, the Plan, nor the Trust have any obligation to make further contributions or payments.

Vesting – Employees with an account become fully vested in the Plan upon retirement from the Employer, upon meeting certain eligibility requirements at retirement (as defined in the Plan Document) and electing to participate in the Plan.

Notes to Financial Statements (Modified Cash Basis)

Forfeitures – Various events trigger account forfeitures including separation from service from the Employer or death prior to becoming an eligible retiree (i.e., attainment of age 60 and 10 years of service with the Employer). Refer to the plan document for a complete description of the Plan's provisions regarding forfeitures. Upon forfeiture of an account, the amount is allocated among the accounts of other eligible employees, retirees, and spouses in accordance with an allocation method determined by the Plan Administrator. Forfeiture allocation occurs as of the last day of each Plan year and any interim dates that the Plan Administrator shall prescribe. Forfeitures for the years ended December 31, 2024 and 2023, amounted to \$1,279,379 and \$767,716, respectively.

Termination – The Plan shall terminate upon the termination of the last contract available to pay for health care premiums for participants and their spouses. In addition, although it has not expressed any intention to do so, the Plan Sponsor reserves the right to terminate the Plan at any time, for any reason, by action of its board of directors. Upon termination or partial termination of the Plan, each participant having an account shall be entitled to have the account pay for benefits until all amounts in the account have been exhausted.

Certified information – The Plan has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, SSBT has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income, reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 2 – Significant Accounting Policies

Basis of presentation – The financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under this basis, plan income and certain expenses have been determined based on cash receipts and disbursements where under U.S. generally accepted accounting principles (GAAP), plan income is recorded when earned and expenses are recorded when incurred. In addition, investments are recorded at fair market value.

The preparation of the financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, and disclosure of contingent assets and liabilities, and changes therein. Actual results could differ from those estimates.

Investment valuation – The Plan's investment funds are sponsored by State Street Global Advisors Trust Company, a subsidiary of SSBT.

Net appreciation in fair value of investments, which consists of the realized gains and losses and unrealized appreciation on those investments, is presented on the statement of changes in net assets available for benefits.

Purchases and sales of securities are recorded on a settlement basis. Interest income is recorded when received. Capital gain distributions are included in the dividend income.

Note 3 – Fair Value Measurements

Certain financial instruments are measured at fair value in the statements of net assets available for benefits. The fair values of these instruments are based on valuations that include inputs that can be classified within one of three levels of a hierarchy. The following are the levels of the hierarchy and a brief description of the type of valuation information (inputs) that qualifies a financial asset or liability for each level:

Level 1 – Unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs other than Level 1 that are based on observable market data. These include quoted prices for similar assets in active markets, quoted prices for identical assets in inactive markets, inputs that are observable that are not prices (such as interest rates, credit risks, etc.) and inputs that are derived from or corroborated by observable markets.

Level 3 – Developed from unobservable data, reflecting our own assumptions.

Financial assets and liabilities are classified based upon the lowest level of input that is significant to the valuation. When quoted prices in active markets for identical assets and liabilities are available, we use these quoted market prices to determine the fair value of financial assets and liabilities and classify these assets and liabilities as Level 1. In other cases where a quoted market price for identical assets and liabilities in an active market is either not available or not observable, we estimate fair value using valuation methodologies based on available and observable market information or by net asset value. These financial assets and liabilities would then be classified as Level 2. If quoted market prices are not available, we determine fair value using broker quotes or an internal analysis of each investment's financial performance and cash flow projections. Thus, financial assets and liabilities may be classified in Level 3 even though there may be some significant inputs that may be observable.

The following is a description of the valuation methodologies used for the Plan's financial assets measured at fair value:

Money market funds – Investments in money market funds are stated at fair value, which approximates amortized cost because the underlying investments are comprised of short-term, highly liquid investments.

Common trust funds – Common Trust Funds invest in other collective investment funds otherwise known as the underlying funds. The Plan's interest in the common trustfunds is based on the fair values of the investments of the underlying funds. The underlying assets primarily consist of U.S. government, agency, corporate, mortgage-backed, asset-backed securities, U.S. and international stocks, cash, and cash equivalents.

Interest-bearing cash – Interest-bearing cash in a financial institution are carried at cost.

Note 4 – Related-Party and Party-In-Interest Transactions

Certain Plan investments are managed by State Street Global Advisors Trust Company (State Street), a subsidiary of SSBT. SSBT is the Plan Trustee as defined by the Plan and, therefore, these investments constitute party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$39,304 for the year ended December 31, 2024.

The Plan entered into an insurance policy with Aetna Life Insurance Company and this arrangement qualifies as a party-in-interest transaction. Premiums paid under this policy for the year ended December 31, 2024, amounted to \$408,293. Fees paid for legal, accounting, actuary and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Notes to Financial Statements (Modified Cash Basis)

Note 5 – Income Tax Status

The Internal Revenue Service (IRS) ruled on October 7, 1994, that the U.S. Healthcare, Inc. Retiree Health Benefit Plan Trust qualifies for tax-exempt status. The Plan Sponsor believes the Plan, as amended, continues to qualify and to operate as designed. However, because the Plan is designed to provide funding for premiums for post-retirement health care benefit coverage, the earnings in the Trust are subject to Unrelated Business Income Tax (UBIT) under current Internal Revenue Code provisions.

The modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 7 – Subsequent Events

The Plan has been evaluated for subsequent events through May 28, 2025, the date at the financial statements were available to be issued and determine there were no events requiring adjustments to or disclosure in these financial statements and related notes.
