Basis for Opinion

Health and Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

1. DESCRIPTION OF PLAN

The following description of the Davis Memorial Goodwill Industries Inc. Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan, as restated effective July 1, 2007, is a defined-contribution health and welfare plan, established for the exclusive benefit of participants. The Trust for the Health and Welfare Plan of Davis Memorial Goodwill Industries, Inc. (the Trust), serving as an agent for the Plan, holds the Plan's assets. Participants in the Plan are employees of Davis Memorial Goodwill Industries, Inc. (the Company or Plan sponsor) who are engaged in the performance of a contract or subcontract for a participating employer that would cause the individual to be required to be covered by the participating employer under the Service Contract Act (the Act or SCA).

Eligibility - All SCA employees are eligible for employee assistance program, life insurance, accidental death and dismemberment insurance, and short- and long-term disability insurance after a 60-day waiting period. Part-time SCA employees working 20 to 29 hours per week are eligible for dental and vision benefits. Full-time SCA employees are eligible for all benefits provided by the Plan.

Contributions - Employer contributions to the Plan are made by the Company in the amount and manner required by the Act. The Act requires the Company to provide an hourly fringe benefit rate to covered employees. The applicable rate is set by the U.S. Department of Labor and implemented through contractual provisions. The rate is applied to the first 80 hours worked in a pay period. Hours worked in excess of 80 are not eligible for the rate. In addition to deductibles and copayments, participants may contribute specified amounts to the Plan. The employee contributions are deducted from payroll and are remitted to the Trust together with employer contributions.

Insured benefits - The Plan provides insured health benefits (medical, dental, vision, hospital and prescription drug coverage), an employee assistance program, life insurance, accidental death and dismemberment insurance, and short- and long-term disability insurance for certain active employees of the Company who are eligible and their covered dependents.

The Plan uses Kaiser Permanente for health benefits except for dental and vision. During the years ended December 31, 2024 and 2023, dental and vision benefits were provided through insurance contracts with Cigna Health and Life Insurance Company. The Plan switched from Lincoln National Life Insurance Company to Mutual of Omaha for life insurance, accidental death and disbursement insurance, employee assistance program and short- and long-term disability insurance benefits during 2024.

Administration - The Company has contracted with a third-party record keeper, The Boon Group, to maintain participant benefit records and to process insurance premiums. The Plan has also contracted with Independent Fiduciary Services to serve as trustee. Plan administrative expenses, field operations fees, trustee, audit and tax services are paid by the Plan.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the dates of the financial statements and changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Contributions receivable - Employer and employee contributions due but not paid to the Trust at year end are recorded as contributions receivable. There was no allowance for doubtful accounts at December 31, 2024 and 2023.

Payment of benefits - Premiums paid are recorded as Premium payments to insurance companies in the accompanying statement of changes in net assets available for benefits. Benefits are recorded when paid to insurance providers.

Participant reserve balances - The Plan requires each participant to maintain a reserve balance equal to the estimated cost of providing benefits for a two-month period. Participant reserve balances are funded through contributions made to the Plan by the Plan sponsor on behalf of the participants during the two-month waiting period prior to joining the Plan. In periods of unemployment or underemployment, benefits will be paid out of a participant's reserve balance. Upon resumption of normal activity, participants will be required to build up the balance in their reserve accounts to required levels.

Subsequent events - In accordance with Financial Accounting Standards Board Accounting Standards Codification 855, *Subsequent Events*, the Plan has evaluated subsequent events through August 12, 2025, the date on which these financial statements were available to be issued. There were no material subsequent events that required recognition or disclosure in these financial statements.

3. PARTICIPANT RESERVE BALANCES

Participant reserve balances reflect the current estimate of the cost to provide two months of benefits to the Plan participants as of December 31, 2024 and 2023. At termination of employment, the unexpended portion of a participant's reserve balance is remitted to a retirement account on behalf of the terminating participant. Participant reserve balances totaled \$149,643 and \$140,655 as of December 31, 2024 and 2023, respectively, and are included as a liability in the accompanying Statements of Net Assets Available for Benefits.

Changes in participant balances result from changes in plan participants and in the estimated cost of providing benefits for a two-month period. Such estimates are prepared using the previous month's actual expenses. Accordingly, participant reserve balances fluctuate between periods depending on changes in the number of participants, changes in participant elections, and the cost of benefits negotiated with insurance companies.

4. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

The Boon Group is the Plan's third-party administrator and Independent Fiduciary Services is the Plan's trustee. Therefore, transactions with these parties qualify as party in interest transactions. The Plan paid fees to The Boon Group and Independent Fiduciary Services for the year ended December 31, 2024.

Certain administrative functions of the Plan are performed by officers or employees of the Plan sponsor. No such officer or employee receives compensation from the Plan.

5. RISKS AND UNCERTAINTIES

The Plan maintains its cash in a bank deposit account with a financial institution, which, at times may exceed federally insured limits. Plan management periodically evaluates the balance and believes this account does not pose a financial risk to the Plan.

All of the Plan participants are SCA employees of the Company working under contracts with the federal government. As such, federal contracts are subject to termination clauses whereby the government may terminate contracts for cause or convenience. Any contract termination or funding delays caused by political, budgetary, or other administrative matters may affect employees participating in the Plan and the ability and necessity of the Plan sponsor to fund and maintain the Plan.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits on account of the participant. No assets of the Plan may revert to the Plan sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. TAX STATUS

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from federal or state income taxes. The Plan is required to pay federal and state taxes on unrelated business income as defined by Internal Revenue Code (IRC). Unrelated business income consists of the investment income earned on the excess of the net assets available for benefits over the required reserve balance allowable under the IRC. The Plan sponsor believes that the Plan does not have any net taxable income for the years ended December 31, 2024 and 2023; therefore, no tax liability is reflected in these financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.
