Notes to Financial Statements
December 31, 2024 and 2023

Note 1 - Description of Plan

The following description of the Alley-Cassetty Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and amendments for a more complete description of the Plan's provisions.

General

The Plan, as amended, is a defined contribution plan maintained for substantially all eligible employees of Alley-Cassetty Companies, Inc. (the Plan Sponsor/Employer). The Plan covers substantially all full-time employees who are age twenty-one or older and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 1, 2023, the Plan elected to add an automatic enrollment service feature. All participants will be enrolled upon obtaining eligibility at the enrollment dates listed in the Plan agreement at 4%. Participants will have 60 days to opt out or make an affirmative election before the automatic enrollment default percentage is effective. If nothing is selected, the default opt-out period is 30 days. The automatic deferral percentage will increase by 1% annually until the maximum deferral percentage elected is reached. The maximum automatic deferral percentage is 6%. This increase will occur at the beginning of the Plan year. A participant's default deferral rate will not change if they were enrolled at the default rate within 6 months of the automatic escalation date.

Contributions

Participants may elect to make pre-tax contributions, subject to the annual additions limitations per the Internal Revenue Code (IRC) or may be made after-tax in the form of a Roth 401(k) contribution. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are permitted up to 50% of compensation subject to certain Internal Revenue Service (IRS) limitations.

The Plan Sponsor may contribute and allocate a matching contribution equal to a discretionary percentage of each eligible participant's salary deferrals. During 2024 and 2023, the employer match was 25% of deferrals up to 4% of participant compensation which totaled \$153,218 and \$124,630, respectively.

The Plan Sponsor may also make profit sharing contributions to participants with a minimum of 1,000 service hours during the Plan year, in the form of nonelective contributions, to the Plan each year, but is not required to do so in any particular year. Profit sharing contributions to the Plan are out of its net profits or accumulated net profits and are determined by appropriate action of the Board of Directors of the Employer. During 2024 and 2023, the Plan Sponsor did not make a profit sharing contribution.

Participant Accounts

Each participant's account is credited (charged) with the participant's contributions and the Plan Sponsor's employer matching contributions, as well as allocations of the Plan Sponsor's profit sharing contribution and Plan, investment earnings (losses), and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's discretionary contributions are based on years of continuous service. Participants vest 20% after two years of service and 20% each year thereafter until they become 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The participant notes receivable are secured by the balance in the participant's account and bear interest at fixed rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant may elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution. If the participant's account is less than \$1,000, the total vested balance is distributed as an automatic lump-sum payment in cash.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures reduce the Plan Sponsor's contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,253 and \$1,009, respectively. These accounts will be used to reduce future Plan Sponsor matching contributions. During 2024 and 2023, Plan Sponsor matching contributions were reduced by \$1,838 and \$867, respectively, from forfeited nonvested accounts.

Hardship Withdrawals

The Plan permits distributions in the event of a hardship, as defined in the Plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Plan Changes

Effective December 29, 2022, the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0 Act) was passed which allows for certain changes to the Plan. Written amendments to the Plan to reflect operational changes to the Plan were adopted through an amendment to the Plan effective January 1, 2023 in accordance with applicable law and IRS guidance.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Events Occurring After Reporting Date

The Plan Sponsor has evaluated events and transactions that occurred between January 1, 2025 and August 7, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

Note 3 - Certified information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) **Mutual Funds:** Valued based on the funds' reported closing net asset values of shares held by the Plan as of the last business day of the Plan year. The mutual funds are deemed to be actively traded.

- (ii) **Collective Trust Funds:** Valued at the net asset value of units of the bank collective trusts. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trusts, the issuer reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan holds various collective trust funds that are not direct filing entities. A majority of these collective trust funds are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. Certain other collective trust funds seek to mirror the investment objectives and strategies of the underlying mutual fund for which the collective trust funds is named.

Note 5 - Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, the Plan distributed \$12,182 and \$16,142 of excess contributions payable to the applicable participants, respectively. The excess contributions were returned to the participants within the two and a half months as required by the IRS.

Note 6 - Income Tax Status

The Plan Sponsor adopted a prototype 401(k) profit sharing plan, as amended, which received a favorable opinion letter from the IRS on November 14, 2022, which stated that the prototype plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan administrator believes that the adopted prototype plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Note 8 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Empower Trust Company, LLC and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and holds notes receivable from participants which also qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, the Plan Sponsor incurred payroll related service fees from a third party provider, LBMC, advisory fees from Onedigital Investment Advisors, and audit services from Puryear & Noonan, CPAs, which are deemed to be parties-in-interest.
