## **Note 1 - Description of Plan**

The following brief description of Assurance Mfg Co. Inc. Employee Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

Assurance Manufacturing, Inc. (the Company) established the Plan effective as of January 1, 1993. The Plan operated as a leveraged employee stock ownership plan (ESOP) until December 31, 2008, and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by management of the Company.

### **Eligibility**

Employees become eligible to participate in the Plan upon attainment of age 19. Participants who do not have at least 1,000 hours of service during each Plan year, or who are not employed on the last working day of a Plan year, are generally not eligible for an allocation of Company contributions for such year.

### **Entry Date**

Employees may enter the Plan on the date they satisfy the Plan's eligibility requirements.

### **Contributions**

Contributions to the Plan are made by the Company at the discretion of the Company. The contributions are allocated according to the pro rata share of each participant's compensation to total eligible compensation. Participants must have completed 1,000 hours of service and be actively employed at the end of the year, unless terminated due to retirement, death, or disability, to receive an allocation of the contribution. In 2024, the Company contributed \$2,000,000 in cash to the Plan.

### **Voting Rights**

The trustees of the Plan will vote on behalf of all common stock that is held as part of the Plan's assets. The provision provides that participants (or their beneficiaries) are entitled to direct the trustees as to the manner in which voting rights on shares of Company stock, which are allocated to a participant's account, are exercised as to the following: (1) with respect to any corporate matter which involves the voting of such shares with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or similar transaction; and (2) with respect to all corporate matters, if at the time of the vote, the Company stock is a "registered-type" class of security. If a participant does not timely exercise his or her right to vote, the trustees will vote on their behalf.

**Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants, and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation. Plan earnings and losses, interest, and administrative expenses are allocated to each participant's account based on the ratio of the participant's account balance.

Participants who are no longer active participants in the Plan have their individual accounts moved out of the Company stock and have the option to direct these investments into one of three fund choices with Principal Bank. More information on these funds can be seen in Notes 3 and 4.

**Vesting**

Vesting in the participants' accounts and related earnings thereon is based on years of continuous service. Vesting is based on years of credited services as set forth in the following table:

Participants are 100% vested in their account balances upon retirement, death, or disability.

**Forfeitures**

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account, as all forfeitures are used in the same year they are forfeited. Forfeited accounts are used to reduce future employer contributions or allocated to eligible participants. During the year ended December 31, 2024, forfeited non-vested accounts totaling \$21,067 were allocated to eligible participants. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation.

### **Payment of Benefits**

Upon death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments, as defined in the Plan document. Required minimum distributions that exceed \$5,000 can be paid out in monthly, quarterly, semiannual, or annual installments.

Distributions have historically been made in cash. However, the Plan's trustees reserve the right to distribute a participant's account balance as shares of Company stock.

### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. The Plan allows participants who have completed ten years of service, attained age 55, and have given notice 90 days after the Plan year-end to diversify up to 25% of their account balance. In the sixth year, the percentage changes to 50%. Diversification is offered to each eligible participant either in a lump-sum or participants are allowed to have payments made in substantially equal installments over a period not to exceed five years.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their account. Upon termination of the Plan, the Employee Benefits Administration Committee directs the trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale will be necessary. Subsequently, the interest of each participant in the trust fund will be distributed to such participant, or his or her beneficiary, at the time prescribed by the Plan terms and the IRC.

## **Note 2 - Significant Accounting Policies and Use of Estimates**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

### **Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. The Employee Benefits Administration Committee determines the Plan's valuation policies utilizing information provided by the investment custodian.

The classification of investment earnings (losses) reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings (losses) on Form 5500 due to different reporting requirements on Form 5500.

**Payment of Benefits**

Benefits payments to participants are recorded when paid.

**Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan sponsor has evaluated subsequent events through August 26, 2025, the date which the financial statements were available to be issued.

**Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stock – The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities, including discounts for lack of control and lack of marketability.

Common collective fund – Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the trustee or custodian, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund, less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Note 5 - Certified Information**

Other than the common stock and related net appreciation and dividend income, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Bank (the custodian of the Plan). Company common stock of \$50,236,209 and \$43,955,550 as of December 31, 2024 and 2023, respectively, including net appreciation of \$6,280,659 and dividends of \$2,752,022 for the year ended December 31, 2024, were not certified.

**Note 6 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated May 19, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company and Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified and the related trust continues to be tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Related Party and Party-In-Interest Transactions**

The Plan invests in Company common stock. In addition, the Plan received \$2,752,022 in dividends and \$2,000,000 in cash contributions from the Company for the year ended December 31, 2024. These are related party and party-in-interest transactions.

As described in Note 2, the Plan paid certain expenses related to Plan operations to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

**Note 8 - Risks and Uncertainties**

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

**Note 9 - Right of First Refusal**

Company stock that has been distributed to a participant and not immediately repurchased by the Company or trust may be subject to a right of first refusal if so determined by the Company. Prior to any subsequent transfer, the shares must be offered by written offer to the trust and the Company at a price and terms consistent with what the offering would be to a third-party. The trust has priority over the Company in rights to acquire the stock.
