Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Central California Blood Center 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Central California Blood Center 401(k) Plan and Trust is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: Central California Blood Center 401(k) Plan and Trust was initially organized as the Central California Blood Center Pension Plan and covered substantially all employees of Fresno Madera Medical Society, Central California Blood Center (CCBC), and Professional Exchange Services Corporation. On October 22, 1993, Fresno Madera Medical Society and Professional Exchange Services Corporation elected to terminate their participation in the Plan. The Plan continued to exist as the Central California Blood Center Pension Plan. Distributions were made on November 11, 1993, to Fresno Madera Medical Society in the amount of \$20,870, and to Professional Services Exchange Corporation for \$107,917. The Plan was restated and amended to become the Central California Blood Center 401(k) Plan and Trust effective August 1, 2002. In 2010 the Plan was converted to a “safe harbor” 401(k) plan.

The plan continues to be subject to the provisions of Section 401 of the Internal Revenue Code, the Employee Retirement Income Security Act of 1974 and Fiscal Responsibility Act of 1982 and the 1986 Tax Reform Act.

Eligibility: Employees of CCBC are eligible to participate in the Plan when they have completed 2 months of service and have attained age 18. An employee’s entry date will be the first day of the month coinciding with or next following the date they satisfy the eligibility requirements.

Contributions to the Plan: Participants may elect to have CCBC contribute a portion of their compensation to the Plan. These contributions made under their election are elective deferrals. For any calendar year, a participant’s elective deferrals may not exceed a specific dollar amount determined by the Internal Revenue Service. For each Plan year, CCBC will make a safe harbor matching contribution equal to 100% of a participant’s salary deferral up to 3% of their eligible compensation, plus 50% of a participant’s salary deferral between 3% and 5% of their eligible compensation. For the year ended December 31, 2024, CCBC made contributions to the plan totaling \$600,178.

CCBC may choose to make additional discretionary matching contributions to the Plan for a particular Plan year. If CCBC makes additional discretionary matching contributions for a Plan year, CCBC will allocate those contributions to the separate accounts of those participants who are eligible for an allocation for the Plan year based upon the participant’s share of total compensation paid during that Plan year to all participants eligible for the allocation.

NOTE 1 - DESCRIPTION OF THE PLAN (continued)

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contribution(s) and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeited balances of terminated participants' non-vested accounts may be used to reduce future Company contributions.

Vesting: A participant's vested interest in the Plan is determined by the number of years of service they have completed. A participant will have completed a year of service for vesting purposes if they are credited with 1,000 hours of service during a Plan year, even if they were not employed on the first or last day of the Plan year. The vesting schedule does not apply to a participant's deferral contributions account or safe harbor contributions. Instead, participants are 100% vested at all times in their deferral and safe harbor contributions account. A participant's vested interest in their account is determined under the following schedule and is based on vesting years of service. Participants will always, however, be 100% vested upon their normal retirement age. If a participant terminates employment before they are entitled to their full benefits under the Plan, the non-vested portion of their account becomes a forfeiture.

Notes receivable from participants: Generally, participants may borrow from their fund accounts a minimum of \$1,000 and to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. Participants may have two loans outstanding at any given time, subject to the above limitations. The loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates as determined by the Plan administrator, currently 4.25% - 9.50%. The loans mature at various dates through July 2028. Principal and interest are paid ratably through payroll deductions. The participant loan balance at December 31, 2024 totals \$242,235.

Payment of benefits: The Plan is designed to encourage participants to stay with CCBC until retirement. Payment of the participant's account balance under the Plan is generally available upon the participant's death, disability or retirement. When a participant terminates employment with CCBC (including retirement and disability) the time at which the Plan will commence distribution to you and the form of that distribution depends on whether your vested account balance exceeds \$5,000. If your vested account balance does not exceed \$5,000, the Plan will distribute that portion to you, in a lump sum, as soon as administratively practicable after you terminate employment with CCBC. If your vested balance exceeds \$5,000, the Plan will make distributions to you as soon as administratively practicable following your election to begin payment. You may elect to receive payment as follows: lump sum, installment payments, or an annuity.

Forfeitures: The Plan utilizes non-vested portions of distributions to former participants for reductions of future employer contributions or for the payment of future Plan expenses. Until such time as the forfeitures are applied, they are held as unallocated assets of the Plan. Forfeitures totaling \$50,330 were applied during the year ended December 31, 2024 to offset plan expenses and contributions. The remaining balance of forfeitures available for future use is \$9,708 and \$16,026 at December 31, 2024 and 2023, respectively.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation: The investments are reported at fair value. The Plan's custodian, Alerus Financial, N.A. (Alerus), certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition: Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants: Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payments of benefits: Benefits are recorded when paid.

Expenses: General plan administrative expenses may be paid out of the forfeiture account or paid by CCBC. Investment management, distribution, and loan transaction fees are paid by the Plan participants.

Subsequent events: Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 8, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements and Disclosures* (ASC 820) provides a framework for measuring fair value under U.S. generally accepted accounting principles. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The following provides a general description of the three levels of inputs that may be used to measure fair value under ASC 820:

Level 1 - Inputs to the valuation methodology are based on quoted prices available in active markets for identical assets or liabilities on the reporting date.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology include significant inputs that are generally unobservable from objective sources. These inputs may be used with internally developed methodologies that result in management's best estimate of fair value including assumptions regarding risk. Level 3 instruments include those that may be more structured or otherwise tailored to the Plan's needs.

As required by ASC 820, financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies (mutual funds and common collective trusts) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies for assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. NOTE 4 - INCOME TAX STATUS

The Plan obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan, as it is currently designed and being operated, is in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan administrator and Trustees intend to amend the Plan on a timely basis to comply with all applicable, recently adopted tax laws and regulations.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, net appreciation or depreciation in fair value of investments, and interest and dividend income for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus, the trustee of the Plan.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments include registered investment company accounts managed by Alerus. As Alerus is the custodian of the Plan, transactions between the Plan and Alerus qualify as exempt party-in-interest transactions.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intention to do so, CCBC has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, the net assets will be distributed among the participants and beneficiaries of the Plan in accordance with the amount allocated to the account of each participating employee. Upon termination or partial termination of the Plan, all funds in each affected participant's account will be fully vested.
