We have performed audits of the financial statements of Imprivata, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Imprivata, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of Imprivata, Inc. (the Plan Sponsor and the Company). The Plan was established by the Company on January 1, 2002. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan administration: Effective December 1, 2019, Fidelity Management Trust Company (Fidelity) was the trustee of the Plan. An employee of the Company serves as the Plan Administrator.

Eligibility: Employees of the Plan Sponsor who have reached 21 years of age are eligible to contribute a portion of their compensation to the Plan as of the first day after completing one month of eligible service.

Contributions: Under the Plan, participants may make both pre-tax and post-tax (Roth) contributions up to 50% of their eligible compensation, subject to annual deferral limits defined by the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions, subject to annual limitations. Eligible employees are automatically enrolled at a 3% deferral rate, unless the employee elects to opt out of the Plan or change the deferral rate. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company may elect to make matching contributions equal to a discretionary percentage, as determined by the Company. In 2024, matching contributions totaled \$2,905,107 of which \$61,317 were contributed from the forfeiture account for a net employer match of \$2,966,424. The Company may also make discretionary profit-sharing contributions to the Plan based on a pro rata formula. No such discretionary profit-sharing contributions were made to the Plan in 2024.

Investment elections: Each participant shall direct the investment of their account among a selection of investments made available and determined by the Plan Sponsor. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's contribution and the Plan Sponsor's matching and an allocation of the profit-sharing contributions, plan earnings/losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their salary deferral and rollover contributions plus any earnings thereon. The vesting schedule for Plan Sponsor matching and profit-sharing contributions plus any earnings thereon is based on the years of continuous services as follows:

A participant's balance will become immediately vested when they reach the age of 65, or upon death or disability, or the termination of the Plan.

Note 1. Description of Plan (Continued)

Forfeitures: Forfeitures represent the non-vested portion of the terminated participants' account balances. Forfeitures will be used to reduce future employer contributions or pay plan expenses. During the plan year ended December 31, 2024, \$157,990 of non-vested account balances were forfeited and the cumulative forfeitures balance generated earnings of \$3,713. During 2024, forfeitures of \$72,640 were used to pay plan expenses and \$61,317 were used to reduce employer contributions. Forfeited non-vested accounts totaled \$55,316 and \$27,570 at December 31, 2024 and 2023, respectively.

Notes receivable from participants: The Plan permits its participants to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, excluding vested balance derived from Roth deferrals. Loan terms range up to five years or over a reasonable period of time for the purchase of a primary residence, as established by the Plan Administrator at the time of the loan. The loans are secured by the balance in the participant's account and bear interest at the prime rate at the date of loan. Subsequent to November 10, 2015, new loans bear interest at prime plus 1%. The interest rate is 4.25% to 9.50% on loans outstanding at December 31, 2024, and mature through 2032. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of benefits: Withdrawals may be made from a participant's account at retirement, termination of employment or when a participant becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59 ½ for withdrawals of salary deferrals and 65 for withdrawals of the Plan Sponsor's matching and profit-sharing contributions. Participants with a rollover account balance are permitted to withdrawal all or a portion from the amount of rollover contributed to the Plan at any time. Benefits are payable in lump-sum payments.

Administrative expenses: Certain investment and recordkeeping services, such as participant transaction fees, are paid by the Plan. All other administrative expenses of the Plan are paid by the Plan Sponsor.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (U.S. GAAP) to ensure net assets available for plan benefits and changes in net assets available for plan benefits are consistently reported. References to U.S. GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (ASC). The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Income taxes: U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

Note 3. Information Prepared and Certified by the Plan's Trustee

The following is a summary of the Plan's asset information included in the Plan's financial statements and ERISA-required supplemental schedule that was prepared by or derived from information provided by the Fidelity Management Trust Company, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and the ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

Fair value measurements: FASB ASC 820, Fair Value Measurements and Disclosures, defines fair value, and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the quoted market prices, which represents the net asset value (NAV) of the shares held by the Plan. These securities are categorized in Level 1 as they are actively traded, and no valuation adjustments have been applied.

Money market account: The money market account is valued at the closing quoted price reported on the active market on which the money market is traded. This account is categorized as Level 1 as this account is actively traded and no valuation adjustments have been applied.

Stable value fund: Valued at NAV per unit based on the underlying investments comprising the trust and based on audited financial statements adjusted for account level fees. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plans financial statements.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and a money market fund managed by Fidelity Management Trust Company, the trustee of the Plan, and, therefore, these transactions qualify as party-in-interest transactions as that term is defined in Section 3(14) of ERISA. The Plan Sponsor also paid certain administrative expenses of the Plan. The Plan issues loans to participants, which are secured by the balances in the participant's accounts, which also constitute party-in-interest transactions.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, the date on which the financial statements were available to be issued.
