## Independent Auditors' Report

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the International Bonded Couriers, Inc. Tax Sheltered Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **1. Description of Plan**

The following description of the International Bonded Couriers, Inc. Tax Sheltered Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of International Bonded Couriers, Inc., Jet Mail Services, Inc., Zipx Package Service and Great Lakes Fulfillment (collectively the "Company"). An employee is eligible for participation in the Plan upon completion of six months of service and attainment of age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2025, Reliance Trust Company will be replaced by ADP Retirement Trust Services, LLC.

***Contributions***

Each year, participants may elect to have a percentage deducted on a pre-tax or after-tax (Roth) basis from their eligible compensation as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible employees will automatically be enrolled in the Plan at a 2% elective deferral rate, unless they affirmatively elect otherwise within the reasonable period established by the plan administrator. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Company. There is an annual limit as to the amount that can be contributed that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified plans.

In addition, the Company may make discretionary matching contributions on behalf of each participant in the amount equal to the percentage declared by the Company for the contribution period. For the year ended December 31, 2024, the Company did not make any discretionary matching contributions to the Plan.

***Vesting***

A participant is 100% vested in their accounts including allocated earnings thereon at all times. A participant vests in the Company matching contributions at a rate of 20% after one year of service with full vesting upon completion of five years of service.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts both totaled \$9,141 and \$6,817. Forfeitures are used to reduce future employer contributions or pay administrative expenses. During 2024, no forfeitures were used to reduce employer contributions or pay administrative expenses.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 % of their account balance. The maximum number of loans that can be outstanding at any time is two. Participant loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

**1. Description of Plan (continued)**

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of Plan earnings (losses). Employer contributions, if any, are allocated based on a percentage determined by the Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, in-service or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. This can be distributed in either a single lump-sum amount, installments or partial withdrawals. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, are subject to restrictions as to the use of the proceeds.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**2. Summary of Significant Accounting Policies (continued)**

***Investment Valuation and Income Recognition (continued)***

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and March 15, 2024.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in the NAV of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 27, 2025.

**5. Common/Collective Trust**

The Reliance Trust Company Stable Value Fund (the "Fund") is a collective investment trust that was formed for the purpose of allowing plan sponsors of defined contribution plans qualified under Sections 401(a) and 501(a) of the IRC to invest in the MetLife Group Annuity Contract 20053 and MetLife Group Annuity Contract 37000. Both contracts were issued by Metropolitan Life Insurance Company to Reliance Trust Company, which is the trustee of the Fund.

Units of the Fund are valued daily. Unit purchases and redemptions are transacted at the NAV determined as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

At December 31, 2024 and 2023, the Fund represents approximately 6% and 8% of the Plan's net assets available for benefits.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will vest 100% in Employer contributions.

**7. Tax Status**

The Plan's prototype plan document preparer has obtained an opinion letter dated October 6, 2020 from the Internal Revenue Service ("IRS") stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**8. Party-in-Interest Transactions**

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
