### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Cowin Equipment Company, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and disclosure under ERISA. **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Cowin Equipment Company, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan of Cowin Equipment Company, Inc. (Employer) is a defined contribution employees' profit sharing plan covering employees (except collectively bargained employees, non-resident aliens, and leased employees) of the Company who have completed one year of service and have attained the age of 19. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Congress passed the Setting Every Community Up For Retirement Act of 2019 and the CARES Act in 2020 with several provisions affecting the Plan. Effective February 17, 2022 the Plan sponsor adopted the restated Principal plan document as approved by the IRS on June 30, 2020. In addition, the Plan was amended on August 2, 2023 to change normal retirement age to age 65 effective January 1, 2024.

**Contributions:** Each year, participants may contribute an amount of their pretax annual compensation as defined by the Plan up to the maximum amount permitted under Internal Revenue Code 402(g). Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective investment trust as investment options for participants.

The Employer may make a discretionary annual matching contribution to the Plan. Employer matching contributions are allocated to participants' accounts based on the participants' elective contributions up to a specified percentage of annual compensation. In addition, the Employer may make a discretionary profit sharing contribution. The profit sharing contribution is allocated to participant accounts based on annual compensation. Contributions are subject to certain limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contribution, allocations of the Employer's contribution and Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Participants acquire nonforfeitable rights to their Employer contribution accounts and the related earnings based on graduated vesting which begins after two years of service and reaches 100 percent after six years of service. In addition, a participant who attains normal retirement age (65 effective January 1, 2024 as defined by the Plan) while still working for the Employer becomes 100% vested automatically.

**Payment of Benefits:** Upon termination of service or attainment of normal retirement age, a participant may elect to receive the value of his or her vested account balance in the form of a lump sum distribution or installment payments.

**Unallocated Assets:** All employer contributions were allocated to individual participant accounts at December 31, 2024 and 2023.

**NOTE A - DESCRIPTION OF THE PLAN - CONTINUED**

**Forfeited Accounts:** At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$44,112 and \$42,863, respectively. These accounts are used to reduce future employer contributions to the Plan. Also, employer contributions were reduced by \$45,243 and \$41,632 for the years ended December 31, 2024 and 2023.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Date of Management’s Review:** Subsequent events were evaluated through August 25, 2025 which is the date the financial statements were available to be issued.

**Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Investment Valuation and Income Recognition:** The Plans investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

**Payment of Expenses:** Certain Plan administrative expenses are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation and depreciation of fair value of investments.

**Payment of Benefits:** Benefits are recorded when paid.

**NOTE C- FAIR VALUE MEASUREMENTS**

FASB ASC 820-10 provides a framework for measuring fair value under GAAP. It establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- (a) Quoted prices for similar assets or liabilities in active markets
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets
- (c) Inputs other than quoted prices that are observable for the asset or liability; and
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE C- FAIR VALUE MEASUREMENTS- CONTINUED**

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 in the amount of \$5,457,887 are reported in net appreciation (depreciation) in fair value of investments and are related to Level 1 investments.

For years ended December 31, 2024, and 2023, there were no Level 2 or Level 3 investments and therefore no transfers between Levels 1 and 2, no transfers in or out of Level 3, and no purchases of Level 2 or 3 assets.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual funds- Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U. S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Principal Stable Value Fund- This is a collective investment trust and is valued at the net asset value of the units of the collective trust. The net asset value is used as a practical expedient to estimate fair market value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE E - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Principal Funds, Inc. Since Principal Trust Company also serves as trustee as defined by the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services rendered by Principal Life Insurance Company that have been included in administrative expenses in the accompanying financial statements amounted to \$3,077 during 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE G - TAX STATUS**

The Plan is a nonstandardized 401(k) profit sharing plan based on the Principal Life Insurance Company prototype non-standardized 401(k) profit sharing plan. Since it is an adoption of a prototype plan previously determined on June 30, 2020 to be qualified by the Internal Revenue Service, it is believed that the Plan is also qualified and therefore exempt from income tax. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in accordance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

**NOTE H- RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
