Independent Auditor's Report

1. Description Of The Plan

The following description of the River Valley Primary Care Services, Inc. ("the Company") Retirement Plan (the "Plan") provides only general information. For a more complete description of the Plan's provisions, participants should refer to the Plan Document and Summary Plan Description which are available from the plan administrator.

a. General

The Plan is a defined contribution plan according to IRC Section 403(b) sponsored by the Company for the benefit of its employees. Employees of the Company who are age 18 or older and work at least 20 hours per week are eligible to make employee and ROTH deferrals immediately upon hire. Employer matching contributions can be made to the Plan once the employee has completed 3 months of service and attained age 18. The entry date will be the first day of the next month after the employee has satisfied the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee is responsible for oversight of the Plan. A third party service provider determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Administrative Committee.

b. Contributions

Each year the participant may contribute to the Plan by making an elective deferral up to the maximum percentage allowable by the Internal Revenue Code for traditional and Roth contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The Company provides a discretionary matching contribution equal to a percentage of each participant's total compensation for the Plan year. The employer's matching contribution is limited to the participant's total deferred compensation up to a maximum of 5% of each participant's total compensation. To be eligible for the discretionary employer match, the employee must be employed on the last day of the Plan year. On March 24, 2025 and April 19, 2024 the Plan Sponsor Board of Directors voted to make a discretionary employer matching contribution of \$353,275 and \$320,907 for the Plan years ended December 31, 2024 and 2023, respectively. Participants direct the investment of their contributions as well as the Company's contribution into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

c. Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and Plan earnings, and may direct these amounts into various investment options offered by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are vested immediately in their contributions, plus their actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is fully vested in Company contributions after three years of credited service. The non-vested balance is forfeited upon termination of service. Forfeitures may be used to reduce Company contributions or allocated to participants based on their account balances.

e. Payment of Benefits

On termination of service due to death, disability, retirement, or termination of service, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments over their life expectancy in compliance with the required minimum distribution requirement of the Internal Revenue Code. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan has a mandatory distribution amount equal to \$5,000 which includes rollover amounts. All accounts which are less than \$5,000 should be distributed to the participant upon severance of employment from the Plan Sponsor.

f. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 (or 50%) of their vested account balance, whichever is less. The notes are secured by the balance of in the participant's account and bear interest. Principal and interest are repaid over the term of the loan through payroll deductions.

g. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

h. Forfeited accounts

Forfeitures may be used to reduce employer matching contributions, to pay Plan expenses and restore forfeited account balances of rehires who are eligible for a restoration of the forfeitures expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,189 and \$9,857, respectively.

2. Summary Of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

b. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

d. Plan Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has conclude that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken that would require recognition of a liability or asset or disclosures in the financial statements. The Plan is subject to routine audits by taxing jurisdictions: however, there are currently no audits for any tax period in progress.

e. Payment of Benefits

Benefit payments to participants are recorded upon distribution.

f. Administrative Expenses

Certain expenses of maintaining the Plan are directly paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

g. Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

4. Investments

The Plan administrator has elected the method of compliance permitted under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the trustee of the Plan).

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - inputs to the valuation methodology include the following:

- 1) Quoted prices for similar assets or liabilities in active markets.
- 2) Quoted prices for identical or similar assets or liabilities in inactive markets.
- 3) Inputs other than quoted prices that are observable for the asset or liability.
- 4) Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs.

6. Related Party Transactions and Party In Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and employee organizations whose member are covered by the Plan, a person who owns 50% of more of such an employer or employee association or relatives of such person.

Certain Plan investments as of December 31, 2024 and 2023 were shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions as of December 31, 2024 and 2023.

Other fee expenses paid by the Plan amounted to \$5,245 and \$2,400 for the years ended December 31, 2024 and 2023, respectively. Although not required, the Company, as Plan sponsor, may pay the related cost of administering the Plan. Expenses paid by the Company on behalf of the Plan are not reflected in the financial statements of the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. SECURE Act 2.0

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

9. Subsequent Events

The Plan's management has evaluated events and transactions for subsequent events that would impact the financial statements of the year ended December 31, 2024 through August 4, 2025, the date the financial statements were available to be issued.

On March 24, 2025 the Plan Sponsor Board of Directors approved to pay a discretionary employer matching contribution of \$353,275 for the Plan year ended December 31, 2024.
