Independent Auditors' Report

Opinion

1. Description of the Plan

The following description of the First American Financial Corporation 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan’s *Summary Plan Description* for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan covering employees of First American Financial Corporation (the “Company”) and of adopting subsidiaries. Employees are generally eligible to participate in the Plan on their first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and the Internal Revenue Code (“IRC”).

The Plan is administered by the Company’s Administrative Benefits Plan Committee (“Plan Committee”). The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (“FMTC”). FMTC delegates certain designated recordkeeping services to Fidelity Investments Institutional Operations Company, Inc. The Plan Committee directs FMTC to utilize Fidelity Brokerage Services LLC to provide brokerage services to the Plan.

Effective October 1, 2024, Plan assets of \$2.5 billion were transferred into the First American Financial Corporation 401(k) Savings Plan Master Trust (“Master Trust”). See Note 3 Master Trust and Note 9 Plan Amendment below for information regarding the Master Trust arrangement.

Effective December 31, 2023, the Mother Lode Holdings Company Savings Plan (“ML Plan”) was merged with and into the Plan. In January 2024, the ML Plan investments totaling \$70.3 million and \$1.2 million of notes receivable from participants were transferred into the Plan.

Contributions

Participants may contribute from 1% to 60%, or, for highly compensated participants, from 1% to 18%, of their annual compensation to the Plan up to an annual limit set forth in the IRC. Participants may elect to make pretax contributions, Roth contributions, or a combination of the two and after-tax contributions up to certain limits. Participants are allowed to make rollover contributions and/or after-tax contributions into the Plan from other qualified plans or conduit individual retirement accounts. Roth In-Plan Conversion is available on after-tax amounts.

Discretionary matching contributions made by the Company have historically been based on the pretax profitability of the Company for the most recent fiscal years. For the years ended December 31, 2024 and 2023, the Company made matching contributions totaling \$61.2 million and \$33.7 million, which were credited to participant accounts in the first quarters of 2025 and 2024, respectively. The matching contributions were allocated to participant accounts and invested based on participant elections under the Plan. For every \$1.00 contributed by eligible participants up to 4% of eligible pay during 2024 and 2023, the Company made matching contributions of \$1.25 and \$0.75, respectively.

Investment Options

Participants direct their contributions and any Company contributions into various investment options offered by the Plan, which also includes a qualified default investment alternative selected by the Plan Committee. Investment options available to participants include target date common/collective trust (“CCT”) funds, mutual funds, money market funds and a self-directed brokerage option. Participant contributions into the Company Common Stock Fund are not allowed. Effective October 1, 2024, all investment assets are held by the Master Trust.

Participant Accounts

Upon enrollment in the Plan, a participant may direct contributions in 1% increments to any of the available investment options as described by the Plan. Participants may generally change their investment options at any time.

Employees who become eligible to participate in the Plan are automatically enrolled unless affirmatively electing not to participate within a specified time period, as required by the Plan. For those participants who are automatically enrolled in the Plan, pretax deferrals of 6% are withheld each payroll period and are contributed into a qualified default investment alternative until a valid election is made by the participant.

Vesting

Participant contributions and earnings thereon are immediately vested. New participants are required to complete two years of service in order to become fully vested in all previous and future contributions made by the Company. The Plan allows for the immediate vesting in all Company contributions in the event of a participant's death, disability or upon retirement if on, or after, the normal retirement age as defined by the Plan. Upon termination, any non-vested balance is forfeited by the participant.

Payment of Benefits

The Plan allows for lump-sum withdrawals upon participant retirement, death, disability, termination or attainment of the eligible age as defined by the Plan. Subject to certain restrictions, as described by the Plan, participants may also make withdrawals in the event of a financial hardship.

Notes Receivable from Participants

Participants may borrow a portion of their account balance pursuant to Plan guidelines. Unless otherwise specified by the Plan, amounts borrowed may not exceed the lesser of 50% of the value of the participant's account balance or \$50,000, less the highest outstanding balance of any loan from the Plan during the one-year period preceding the date on which a new loan would be made. Loans are subject to an initiation fee and other expenses as incurred.

Terms of participant loans are determined pursuant to Plan guidelines. Participant loans are collateralized by the balances in participant accounts and bear a rate of interest that is considered reasonable at the time a loan is made, as determined pursuant to Plan guidelines. Loan repayments are required to be made through payroll deductions, or other methods prescribed by Plan guidelines where payroll deductions are not sufficient or available. A participant may repay a loan in full at any time without penalty, however partial prepayment is not permitted. As of December 31, 2024 and 2023, interest rates on participant loans ranged from 4.3% to 9.5% per annum with maturity dates through December 2039.

Forfeitures

Forfeited amounts, which relate to non-vested accounts of terminated participants, are first used to pay costs of plan administration, next to reinstate forfeited accounts to the extent required under the plan, and finally to reduce matching contributions under the plan. Forfeitures used during 2024 and 2023 totaled \$1.3 million and \$1.9 million, respectively, and at December 31, 2024 and 2023, forfeited balances totaled \$0.1 million and \$0.8 million, respectively.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

The fair value of the Plan's interest in the Master Trust is based on the beginning value of the Plan's interest in the trust, plus actual contributions and allocated investment income or loss, less actual distributions and allocated administrative expenses. See Note 3 Master Trust below.

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 Fair Value Measurements for further discussion of the fair value of Plan investments.

Purchases and sales of securities are accounted for on the date the securities are purchased or sold (trade date). Dividend income is recorded on the ex-dividend date. Interest income is recognized on an accrual basis as earned.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in fair value of its investments, which consists of both realized gains (losses) and unrealized appreciation (depreciation) on those investments. Investment related expenses are also included in net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on an accrual basis as earned.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain annual and transaction specific fees are paid out of Plan assets and are reflected in the statements of changes in net assets available for benefits. Certain other administrative expenses are paid by the Company.

Risks and Uncertainties

Investment securities held by the Master Trust are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in circumstances in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

3. Master Trust

Effective October 1, 2024, the Company established the Master Trust pursuant to a trust agreement between the Company and FMTC, as trustee, in order to permit the commingling of trust assets for certain of the Company's employee benefit plans for investment and administrative purposes. Each participating retirement plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by FMTC.

Employee benefit plans participating in the Master Trust as of December 31, 2024 include the following defined contribution plans:

- The First American Financial Corporation 401(k) Savings Plan
- The Republic Title of Texas, Inc. 401(k) Savings Plan

All transfers into, withdrawals out of, or other transactions impacting the Master Trust are conducted in such a way that the proportionate interest in the Master Trust of each plan and the fair market value of that interest can be determined at any time. At December 31, 2024, the Plan's interest in the net assets of the Master Trust was approximately 97%.

The interest of each plan is debited or credited (as the case may be) (i) for the entire amount of every contribution received on behalf of each plan (including participant contributions), every distribution, or other expense attributable solely to each plan, and every other transaction relating only to each plan; and (ii) for its proportionate share of every item of collected or accrued income, gain or loss, and general expense, and of any other transactions attributable to the Master Trust or that investment option as a whole.

4. Fair Value Measurements

The fair value of Master Trust assets or Plan assets are classified using a three-level hierarchy for fair value measurements that distinguishes between market participant assumptions developed based on market data obtained from sources independent of the Plan (observable inputs) and management’s own assumptions about market participant assumptions developed based on the best information available in the circumstances (unobservable inputs). The hierarchy level assigned to each security in the Plan’s investment portfolio is based on management’s assessment of the transparency and reliability of the inputs used in the valuation of such instrument at the measurement date. If the inputs used to measure fair value fall in different levels of the fair value hierarchy, an investment’s hierarchy level is based upon the lowest level of input that is significant to the fair value measurement. The three hierarchy levels are defined as follows:

Level 1: Valuations based on unadjusted quoted market prices in active markets for identical securities.

Level 2: Valuations based on observable inputs (other than Level 1 prices), such as quoted prices for similar assets at the measurement date; quoted prices in markets that are not active; or other inputs that are observable, either directly or indirectly.

Level 3: Valuations based on inputs that are unobservable and significant to the overall fair value measurement, and involve management judgment.

Investments classified within Level 1 of the fair value hierarchy included a money market fund, mutual funds and common stock funds. The money market fund and the mutual funds were valued at their net asset values (“NAV”) based on closing prices as reported by the funds and were deemed to be actively traded. The common stock funds were valued based on closing prices as reported on the active markets on which the individual securities were traded.

Investments within the self-directed brokerage accounts included money market funds, mutual funds, common stocks, U.S. government securities, and corporate debt instruments. The money market funds, mutual funds and common stocks were valued based on closing prices as reported on the active markets on which the individual securities were traded and were classified within Level 1 of the fair value hierarchy. Fixed income investments, consisting of U.S. government securities and corporate debt instruments, were classified within Level 2 of the fair value hierarchy.

CCT funds were valued at the NAV per unit as a practical expedient to estimate fair value, which were based on the fair values of the underlying investments held by the funds, less liabilities. CCT funds are redeemable, have trades that settle daily and have no future commitments or other trading restrictions. Were the Plan to initiate a full redemption of the CCT funds, there could be a temporary delay in withdrawal in order to ensure that liquidations of securities are carried out in an orderly manner.

5. Party-In-Interest Transactions

Parties-in-interest (as defined by ERISA) may perform services or have fiduciary responsibilities to the Plan. The party-in-interest transactions discussed below qualify for an exemption from the party-in-interest prohibitions of ERISA.

The Company incurred certain administrative expenses on behalf of the Plan totaling \$0.9 million for the years ended December 31, 2024 and 2023.

Certain investments of the Master Trust include shares of mutual funds that are managed by Fidelity Management & Research Company (“FMR”). FMR is a related entity to FMTC, the trustee of the Plan. FMR is also a related entity to Fidelity Personal and Workplace Advisors, LLC and Strategic Advisers LLC, both of which are providers of discretionary investment management services to the Plan.

At December 31, 2024, the Master Trust held 1.3 million in the Company Common Stock Fund with a fair value of \$79.1 million. At December 31, 2023, the Plan held 1.4 million shares in the Company Common Stock Fund with a fair value \$91.9 million. During 2024 and 2023, sales of shares in the fund totaled \$12.3 million and \$10.7 million, respectively.

6. Corrective Distributions

The Plan is subject to certain non-discrimination rules under ERISA and Internal Revenue Service (“IRS”) guidelines. For the plan years ended December 31, 2024 and 2023, one adopting subsidiary under the Plan did not satisfy the non-discrimination rules and the Plan took corrective action by returning an immaterial amount of excess contributions and related investment income and losses.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participant accounts would remain vested in accordance with Plan provisions.

8. Federal Income Tax Status

The Plan is required to operate in conformity with the IRC to maintain its qualification. The IRS has determined and informed the Company by letter dated October 28, 2013, that the Plan is designed in accordance with applicable sections of the IRC and is, therefore, exempt from federal income taxes. The Plan has been amended subsequent to receipt of the IRS determination letter; however, the Plan Committee believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, remains qualified and the related trust continues to be tax-exempt.

The Company evaluates any uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. As of December 31, 2024, the Plan is generally no longer subject to income tax examinations for years prior to 2021.

9. Plan Amendment

In 2024, the Plan was amended to transfer the Plan's assets into the First American Financial Corporation 401(k) Savings Plan Master Trust. See Note 3 Master Trust above for further information regarding the Master Trust arrangement.

In 2023, the Plan was amended to merge the assets of the ML Plan (Note 1) into the Plan. The amendment also increased the maximum pretax contribution and Roth contribution rates for highly compensated participants from 15% to 18%, effective January 1, 2024.

10. Subsequent Events

The Company evaluated subsequent events through August 27, 2025, which is the day the financial statements were available to be issued.
