INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Superior Communications, Inc. 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Superior Communications, Inc. 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**1. General**

Effective January 1, 1997, the Board of Directors of Superior Communications, Inc. (the “Employer”), as amended, established the Superior Communications, Inc. 401(k) Plan and Trust, as amended, for the benefit of substantially all employees of the Employer. The Plan is a contributory profit sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**2. Eligibility**

An employee is eligible to participate in the Plan following the completion of six months of service and attainment of age 21, prior to the entry dates of January 1 and July 1. Leased employees are not eligible to participate in the Plan.

**3. Contributions**

Participants may make salary pre-tax deferral or Roth 401(k) contributions up to 90% of eligible compensation, as defined, up to the maximum deferral limit per Section 402(g)(1) of the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Employer may make a discretionary non-elective Employer contribution and/or an annual discretionary matching contribution to participants employed on the last day of the plan year and who have completed 1,000 hours of service during the plan year. The matching contribution is equal to a percentage of eligible deferred compensation, not to exceed certain limits determined annually by the Employer. There were no Employer contributions for the year ended December 31, 2024.

**4. Participant Accounts**

Each participant’s account is credited with the participant’s contributions, rollovers, Employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**5. Investment Options**

Upon enrollment in the Plan, a participant may direct employee and Employer contributions, as desired, in any of a variety of investment options held by Fidelity Management Trust Company (“Fidelity”), the trustee, as selected by the Employer. Participants may change their investment options daily.

**6. Notes Receivable from Participants**

Participants may borrow amounts from \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000 reduced by the highest outstanding loan balance during the prior twelve months). Participants may have up to two loans outstanding at any time. Loans must be repaid over five years and bear interest at 1% over the prime rate. A loan may be repaid over a period of ten years if it is for the purchase of a principal residence.

**7. Vesting**

Participant contributions, rollovers, qualified non-elective contributions, and actual earnings thereon are fully vested at all times. However, vesting of the discretionary Employer matching contribution and the non-elective Employer contribution portions of participant accounts, plus actual earnings thereon, is based upon the participant’s years of service with the Employer as follows:

**8. Benefit Payments**

Upon termination of employment, a participant will receive a lump-sum amount equal to the value of the participant’s vested account balance. When a participant terminates due to permanent disability, death, or reaches retirement age, the participant or their beneficiary is entitled to 100% of the participant’s account balance. Additionally, participants may receive in-service distributions upon attaining age 59½ or for financial hardship if certain criteria are met.

**9. Forfeitures**

Forfeitures of terminated participants’ nonvested accounts may first be used to pay reasonable plan expenses and then may be applied against future Employer contributions. Outstanding forfeitures as of December 31, 2024 and 2023 were approximately \$36,000 and \$17,000, respectively.

**10. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan subject to the provisions of ERISA. Upon plan termination, contributions would cease, participants would become 100% vested in their Employer contributions, and assets would be distributed to the participants based on each individual participant's interest in the Plan as prescribed by the Plan provisions and the IRC.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**2. Plan Administration**

The Employer is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

**3. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**4. Payment of Benefits**

Benefits are recorded when paid.

**5. Administrative Expenses**

Expenses incurred by the trustee in the performance of its duties are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/ (depreciation) in fair value of investments.

**6. Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note D for discussion of fair value measurements.

##### 6. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### 7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### 8. Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

#### NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity (the trustee of the Plan).

#### NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund (stable value) and collective investment trusts:* Net Asset Value (NAV) for the common/collective trusts (CCTs) is determined by the trustee of the CCTs. The fair values of the Plan's interest in the CCTs are based on the underlying unit values reported by the CCTs as of the close of business on each valuation date. The NAV per unit is computed by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding. Investment income earned is reinvested in the fund and included in the determination of unit values. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE E - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

#### **NOTE F - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Plan investments are managed by Fidelity. Fidelity is the trustee and recordkeeper for the Plan and therefore transactions with Fidelity qualify as party-in-interest transactions. Notes receivable from participants of the Plan and the related interest income are also considered party-in-interest transactions.

#### **NOTE G - TAX STATUS**

The Employer adopted a non-standardized pre-approved profit sharing plan ("pre-approved plan") document, which received its most recent favorable opinion letter from the IRS dated June 30, 2020. The letter stated that the pre-approved plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the letter, however, the plan administrator and the Plan's advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE H - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.
